



Aluminum Fence Limited Lifetime Warranty

Thank you for purchasing Thermal Chek Inc. (TCI) aluminum fence using products from Shapes Unlimited Inc. **To activate this Limited Lifetime Warranty, either return a copy of this completed warranty registration to TCI, or register online within 30 days after installation is required.** This warranty is only valid to the original purchaser, and is not transferable to any other party.

This **Limited Lifetime Warranty** only covers specific defects in material and workmanship of the product only. TCI warranty covers defects in material and workmanship, as well as paint cracking, peeling, chipping. The warranty becomes invalid if the product defects are caused by: (a) those caused by marine, salty, or harsh environmental conditions; (b) those caused by acts of God; (c) those arising from improper installation; (d) those arising from unauthorized use or alterations of the product; (e) those caused by negligence, abuse, accident; (f) those arising from the failure to follow basic maintenance; (g) appearance associated with weathering or fading from exposure to sunlight*; (h) caused by oxidation caused by airborne chemicals or air pollution; (i) caused by exposure to application of paint, varnish, chemicals (including lawn care chemicals) or cleaning agents not approved by the TCI.

*after prolonged exposure to outdoor environments, all products will experience some gradual fading over time and is considered normal. Degrees of fading vary depending on geographical location, air pollution, exposure, and other factors.

Under this warranty, TCI is limited to the repair, or replacement of the defective material only, on a prorated basis as per Shapes Unlimited Inc. warranty terms, provided the Purchaser has completed warranty registration within 30 days of receipt or installation of product. Any prorated portion stated shall be the credit amount to Buyer, and the remaining percentage shall be your obligation. Reimbursement for the cost of removal, shipping and or reinstallation is not covered, and TCI will not provide such services. TCI reserves the right to refund the amount paid for the fence products instead of repairing or replacing the defective fence product. TCI will not be held responsible for personal injury resulting from defect in fencing material.

If the material appears to have a defect, the original customer must advise the Dealer whom installed the materials. Activation of this warranty registration does not fully guarantee warranty coverage. The customer must adequately prove that the material installed is a TCI aluminum fence product. If a claim is made against this warranty, TCI will first require installing dealer's name, TCI order #, date installed, pictures, and a written summary of the issue. If a determination cannot be made using the submitted material, TCI may dispatch at its expense and time frame to inspect the product. If it is deemed to be a condition covered under this warranty, TCI will inform the customer in writing, as to the repair or replacement instructions for the affected product.

The above stated warranty constitutes the complete warranty by TCI. It may not be modified, amended or supplemented without written approval of TCI. No other agreement, written or implied is valid. TCI does not authorize any other person or agent to make any other expressed warranties.

This warranty gives you specific legal rights, and you may also have other rights, which vary state to state. Some exclusions, limitations or consequential damages may not apply to your specific jurisdiction. It is the responsibility of the end user to know these rights in their jurisdiction
