### **LEGISLATION 2007**

During this session of the legislature over a dozen bills were submitted on retirement issues. Most didn't survive but several were *retained* 

for further consideration, including one that provides for a permanent COLA (HB 779).

Two bills that did survive are most important to Retirees:

HB653 Amended. Well founded concern for the health of the system prompted a complete replacing of the BILL with language crafted by a sub committee of the House ED&A Committee led by Rep. Ricia McMahon. However, there was no provision for any COLA. It did provide some necessary changes in the Retirement Law most notably the System's accounting methods.

In order to restore the solvency of the system as quickly as possible, all of the interest gained by the System investments needed to be retained within the system. No portion was to be allocated to the Special Account, the source of COLA's and other additional benefits, until the System funding ratio reached 85%. That was predicted to take between 15 to 20 years.

Fear not that we have not seen an end to COLAs, as you will learn further on.

When HB 653 reached the Senate after a landslide endorsement in the House, we proposed a series of changes that would provide a 2.5% COLA. The Senate ED&A Committee chaired by Sen. Peter H. Burling inserted a 2.5% COLA as an amendment to the Bill and this was endorsed unanimously by the Senate after a superb presentation on the Senate floor by Sen. Burling prior to the vote.

Other groups interested in Retirement issues had attempted to amend the bill by adding a "Sunset Clause" that if accepted would have had defeated the effectiveness of the bill. We were able to beat back this attempt and it was never offered. The bill was sent back to the House with the Senate amendments and a Committee of Conference created. After three days of tough deliberations, the House firmly rejected the 2.5% COLA and rejected a compromise offer

of the Senate of 2.25% for a COLA.

In return they offered a "tiered" COLA that would have seen retirees at the lowest end getting a 2.5% COLA and reducing the amount up the ladder to the top, to a 1% COLA. However, Senator Burling would not budge. In the afternoon of the third day, the House unexpectedly agreed to the 2.25% offer of the Senate and the case was closed as we say. The Committee Report was passed by both bodies on Wednesday and now on way to the Governor for signature.

There are many in the Senate, on both sides of the aisle, who were extremely helpful to our cause. No one better than Sen. Peter Burling, who stands out alone, and then his ED&A Committee, composed of Senators Joe Kenny, Molly Kelly, Mike Downing, Martha Fuller Clark and Jaclyn Cilley. They deserve our acknowledgement as do Senate President Sen. Sylvia Larsen and House Speaker Rep. Terrie Norelli.

HB 876 The Retirement System has needed overhaul for some time. HB 876 was designed to create a committee to study the system and designated who committee members would be. Group II members were to be from two firefighter groups, one led by David Lang and the other by Arthur Beaudry; and one from the NH Police Association, which was actually misidentified in the Bill as the "NH Patrolman's Association". That would have put us (retirees) on the outside looking in.

Once again with the cooperation of members of the Senate, the Group II designations were removed and simply indicated as 3 Group II members to be appointed by the Governor. We were able to have an additional member designated as a "retiree" added to the Bill in each Group. There was little or no disagreement at the Committee of Conference and the Senate version with a minor change for the House was accepted.

The Commission must report its findings and recommendations back to the Governor and Legislature leadership by Dec 1 2007. One of the significant designated duties of the Commission it to formulate a permanent method of providing COLA's. I mentioned this earlier with the admonishment "not to fret".

This was very contentious session with several groups at times at odds with each other. We stayed clear of their disagreements and maintained our focus on our planned strategy that proved very successful. Our brother organization, the NH Association of Retired Law Enforcement Officers joined with us and supported all our efforts. We will now concentrate our efforts to obtain one or more of the four Group II seats on the newly established Commission.

I would be remiss if I did not mention the string support from Lt. Joe Dow, (ret.) FD Portsmouth. Joe continues to be loyal, hard working and valuable teammate in our legislative efforts.

# MINUTES OF 5/23/2007 MEETING

A moment of silence for departed Members was observed.

Herb Frink led us in the Pledge of Allegiance.

Kevin O'Brien, Chairman introduced Colonel Booth and Commissioner Barthelmes.

Commissioner Barthelmes said he had only been on the job for 6 weeks. He thanked everyone for the support he received on his confirmation. The Commissioner talked of the challenges for New Hampshire's public safety in dealing with crime increases involving guns, drugs and gangs. He also noted that in 2005 there were 144 drug overdose deaths, a sharp increase from previous years.

The Commissioner also noted highway deaths continue to involve speed, driver inattention and alcohol. He added that he was proud of what State Police is doing and noted that one trooper alone made 135 DWI arrests!

The Department of Safety has a challenge with 1200 full time employees spread over the entire state. His goal is to change the culture at the Department of Safety to make it the most effective agency.

Colonel Booth spoke how he appreciated the opportunity to attend our meeting. He brought us up to date on what is going on within State Police and commented that he is fortunate to see a new Commissioner of Safety. He is looking forward to seeing everyone at Alumni Night in July.

Kevin O'Brien introduced the evening's Special Guests: Hope McDonald and her granddaughter Maggie; Sue Solloway and her son Scott; Deb Noyes; and Carol Caron.

Joe Broderick waived the reading of the minutes and treasurers report. Treasurer's report was placed on table for members to view. Bart Flanders Seconded, Passed.

There were 3 positions up for nomination to the Board. Nominations were as follows: Jim Norris; Mike Hureau; Mark Furlone. Jim Norris has asked to step

down. Sheldon Sullivan was nominated in place of Jim Norris. Vote passed.

Jim Norris was presented with a State Police Clock for his 8 years of service on the Board.

Kevin O'Brien thanked Colonel O'Leary and Joe Dow (retired firefighter from Portsmouth FD) who have been hard at work keeping track of the ups and downs, in and out (roller coaster ride) on HB653. A summary of their work is included in the Bulletin.
