General Profile

Professor Lei CHEN (PhD) is Chair in International Arbitration and Chinese Law at Durham Law School, Durham University. He was elected as a member of the European Academy of Sciences and Arts in 2024, a Titular Member of the International Academy of Comparative Law in 2021, and a Fellow of the European Law Institute in 2013.

Prof Chen is a visiting Distinguished Professor of Shanghai Jiaotong University, an Adjunct Professor at the City University of Hong Kong, a Honorary Professor at the University of Galway, Ireland, and a visiting Chair at Shandong University. He was the Visiting Professor at the Singapore Management University, the National University of Singapore and the University of Hong Kong. He has been teaching the EMBA and MPA programmes at CityU HK Business School and the School of Public Policy and Management at Tsinghua University.

Professor Chen's research areas are comparative private and commercial law and international arbitration. He has published extensively in these areas in law journals, edited volumes of multidisciplinary scholarship, China studies journals and monographs. He convenes a study group to publish Article-by-article English commentary on the Chinese Civil Code. Professor Chen has been a member of the Law Panel of Research Assessment Exercise (RAE) 2020 and is currently a member of the Humanities and Social Sciences Panel of the Hong Kong University Grant Committee.

Professor Chen has been appointed as a member of the International Commercial Expert Committee of the PRC Supreme People's Court since September 2024. He is a Fellow of the Chartered Institute of Arbitrators (FCIArb) and a Fellow of the Hong Kong Institute of Arbitrators (FHKI Arb). Professor Chen became a specialist mediator at the Singapore International Mediation Centre in 2019.

Arbitration Experiences

Prof Chen has issued more than 250 arbitral awards as sole arbitrator, party-appointed arbitrator and presiding arbitrator in Chinese and English, both domestic and international, including those governed by the rules of the HKIAC, UNCITRAL, ICC, CIETAC, SIAC, SCIA, GAC and BAC. The cases concern the disputes of sale of goods, banking, real estate and construction, financial, oil and gas (including LNG supply contract), maritime, corporate governance (including Share Purchase Agreements) and insurance. The following are illustrative examples of his recent arbitration experiences:

1. Claims for approx. US\$1.1 billion in relation to an indexed linked financial lending in Shenzhen (SCIA)
2. Claims for approx. US\$104 million in relation to investment fund management dispute in Beijing (BAC)
3. Claims for approx. US\$160 million in relation to joint venture project between a Chinese party and a European party (ICC)
4. Claims for approx. US\$ 8 million in relation to a high-end property management dispute ad hoc (UNCITRAL) seated in Hong Kong
5. Claims for approx. US\$ 4 million IP disputes in an online gaming industry in USA (HKIAC)
6. Claims for specific performance in relation to US\$ 300 million share purchase agreement dispute involving a Chinese SOE (CIETAC)
7. Claims approx. US\$50m in connection with a maritime insurance dispute ad hoc UNCITRAL rules
8. Claims totalling approx. US\$ 18 million in connection with construction of a major dam in China (BAC)

Expert Witness Experiences

As a seasoned expert witness, Professor Chen has provided expert evidence on PRC law in proceedings before the London Commercial Court, the Hong Kong High Court, the Singapore High Court, and the New York State Court, as well as in commercial and investment arbitrations under HKIAC, SIAC, ICC, ICSID, PCA, and LCIA rules. He has also attended cross-examinations in these forums. His recent engagements include the following.

1. Engaged as an expert consultant by the Director of Public Prosecutions (DPP) in a high-profile cryptocurrency fraud case before the High Court of England and Wales.

3. Engaged by a Southeast Asian investor in an ICSID-administered treaty arbitration against an Asian state concerning claims of expropriation and unfair treatment in a mining investment, with over USD 400 million in dispute.
