

# **JJ Film & Photography Terms & Conditions Agreement**

## **Requirements For Renting**

We must have a legible photocopy of the renters driver license, certificate of insurance(or collateral deposit) and a JJ Film & Photography “Terms & Conditions Agreement” completed and signed by the renter in order to rent.

IDENTIFICATION: Valid Driver’s License or US Passport (picture ID).

COLLATERAL DEPOSITS: (a.)Credit Card deposit for the full replacement value of equipment, or (b.) Cash deposit for the full replacement value of equipment, or (c.) Certificate of Insurance (see certificate of insurance requirements).

CHECKS: JJ Film & Photography does not accept checks.

INSURANCE: We require insurance on all orders or credit card to cover full value of equipment.

FEES: All prices are per day or weekly. A weekend is charged as one day. Prices are subject to change. A non refundable fee of \$100 is required for all reserved rentals. Fee will be applied toward rental cost.

LOSS OR THEFT: Renters will be charged at the day rate on equipment that is lost, damaged or stolen until JJ Film & Photography is reimbursed for the replacement cost.

### **Daily Rates:**

- Pick-up BEFORE 3 p.m. and return within 24 hours for 1 day rental charge.
- Pick-up AFTER 3 p.m. and Rental begins the next day. Return must be made before 11 a.m. the next day. (e.g. Pick-up Monday after 3 p.m.,return Wednesday by 11 a.m.)

### **Weekend Rental:**

- Pick-Up Rental after 3 p.m. on Friday and Return Rental the following Monday before 11 a.m. and pay for 1 Day Rental.

### **Weekly Rates:**

- Rental for 7 consecutive days and pay for 1 week.

## **Insurance Requirements**

This letter is to inform all clients that JJ Film & Photography requires either insurance, or a full credit card deposit, on all rental orders. Renters accept full responsibility for any loss, or repairs, due to damage while in the renter’s possession. Insurance coverage is the responsibility of the renter. Proof of adequate insurance coverage for the full replacement value of the equipment will be required prior to the rental.

CERTIFICATE OF INSURANCE REQUIREMENTS:

- (a.) JJ Film & Photography must be named the Loss Payee, as well as additionally insured: (Use the 15037 Broadmoor St, North Hills, CA 91343 address).
- (b.) Coverage must include, explicitly, "Miscellaneous Rented equipment & Rented Equipment," as well as property covered off premises.
- (c.) The insurance certificate must also provide the total amount of coverage and the deductible on the policy.
- (d.) Policies with Unattended Vehicle Disclaimers will NOT be accepted.
- (e.) All certificates and attached forms are subject to the verification and approval process by JJ Film & Photography before the equipment is released. All certificates and attached forms need to be approved 24 hrs before rental pick-up.
- (f.) Renter is responsible to cover any insurance deductibles as well as to guarantee rental payment. **Name on policy must match renter's name.**

Please contact your insurance agent for all of the required coverage by JJ Film & Photography. The verification process takes time, please plan accordingly. This policy is in effect to protect you as well as JJ Film & Photography from any size-able loss.
