Client fully understands that they may injure themselves as a result of enrollment and subsequent participation in this self-defense program and hereby, releases Contractor and its agents from any liability now or in the future for conditions that Client may obtain. These conditions may include, but are not limited to, heart attacks, muscle strains, muscle pulls, muscle tears, broken bones, shin splints, heat prostration, injuries to knees, injuries to back, injuries to foot, or any other illness or soreness that may incur, including death.
