Blair, Travis

Baltimore Police officer – CHARGES FILED

Accused of "enlistin veterans soldiers for sex" and claiming they needed to file VA claims and pay \$1,000 a month or face false fraud arrests2....

Chin, Officer

Baltimore Police officer

Joella claims to have a recording of him saying he gave CPR to her deceased brother (2021).

Directly involved in accusations against Officer Travis Blair – uses Trauma from Joella records to bully and harass for the \$1000 Money Laundering Operation directed by Genevieve LaPorte and Leah Rock.

HOWARD COUNTY MARYLAND

Broccolino, Victor / Brocolilo, Victor / Broccolillo, Victor

Brown cleaner, Victor /Brooklyn Park County Police, Victor/Franklin, Victor

Howard County Police officer2....

Accused of "listening veterans soldiers for sex" and demanding payment or threatening false fraud arrests2....

Allegedly almost raped Joella several times15....

Accused of writing false police reports claiming Joella was wounded in deployment and is dangerous6....

Joella claims Fox 45 News lied and told Victor Broccolillo everything she told them, leading to threats and payoffs17....

Associated with a "false two million toll"25.

Allegedly constantly called Joella to meet him in vacant areas or places where drug addicts had parties and dumped bodies11.

Accused of assaulting, framing, and racial profiling Joella11.

Allegedly claimed Joella had an illegal bank account because he couldn't get her military records11.

Referred to as Victor Brown cleaner by Joella when describing an officer at a post office²⁶.

His excuse for demanding military benefits from soldiers/veterans is referenced as "Victor Franklin's excuse"²⁷.

Mentioned as part of the group of Howard County officers that Frederick police claimed to be helping¹¹.

Collins, Edward / Collins, Edwards

Howard County Police officer²....

Allegedly almost raped Joella several times¹⁵....

Accused of writing false police reports claiming Joella was wounded in deployment and is dangerous⁶....

Allegedly assaulted, framed, and racial profiled Joella¹¹.

Referred to as Edwards Collins¹¹.

Mentioned as part of the group of Howard County officers that Frederick police claimed to be helping¹¹.

Crawford

Mentioned as a Howard County Police officer, along with Victor Broccolilo, Edward Collins, and Rukamp, whom Frederick police claimed to be helping¹¹.

Laporte, Genevieve / Laporte, Jennifer

From NAMI of Maryland²....

On the board of NAMI of Maryland⁴....

Allegedly claimed NAMI needed money and advised against giving it to Leah C. Rock (Little Rock), Howard County Police, or any other police department²....

Allegedly stated NAMI needs to collect soldiers and veterans because they are supposedly seen as dangerous⁴.

Allegedly told Joella at the DMV office that police will say she is dangerous, claim her military benefits, and use her for sex trafficking¹⁰.

Allegedly called Joella claiming that NAMI of Maryland can have their team write up false medical claims as long as documents are signed to give NAMI all the money and promise not to sue for the false claims resulting in job loss, becoming homeless, and being unable to get a job³⁸.

Referred to as Jennifer Laporte³⁶.... Jennifer Laporte from NAMI allegedly believes police and NAMI might see a "win-win situation" involving sex trafficking and government money³⁶.

Also referred to as Genevieve Laporte from Howard County³⁸.

Allegedly involved in the false two million dollar toll issue¹¹.

Rukam / Rukamp

Howard County Police officer6....

Accused of writing false police reports claiming Joella was wounded in deployment and is dangerous6....

Mentioned along with Victor Brocolilo, Edward Collins, and Valentine6....

Mentioned as part of the group of Howard County officers that Frederick police claimed to be helping11.
Referred to as Rukamp11.

Valentine / Valen ne

Howard County Police officer6....

Accused of writing false police reports claiming Joella was wounded in deployment and is dangerous6....

Mentioned along with Victor Brocolilo, Edward Collins, and Rukam6....

Associated with the false \$2 million toll25.

Referred to as Valen ne6....

VETERANS ADMINISTRATION

Adams, Dr.

- Allegedly a VA employee who claimed to have treated Joella without ever meeting her.

Alkihida

Allegedly quit the VA after looking into everything. Dr. Garbow allegedly suggested Joella was the reason for their departure. Dr. Garbow allegedly suggested Joella was the reason for their departure6....

Arnold, D.

Mentioned as one of several individuals, including VA employees, who Leah Lyons allegedly helped in federal fraud of filing false claims before Leah Lyons quickly left the VA11. Also mentioned alongside Leah C. Rock, J. Peer, B. Newberry, Ms. Julian, K. White, C. Gibson, Lt. Jones, and Sgt Bernard in this context11.

Bernard, Sgt

Mentioned as one of several individuals, including VA employees, who Leah Lyons allegedly helped in federal fraud of filing false claims before Leah Lyons quickly left the VA11. Also mentioned alongside Leah C. Rock, J. Peer, D. Arnold, B. Newberry, Ms. Julian, K. White, C. Gibson, and Lt. Jones in this context11.

Ervin, Tamara

Mentioned as one of several individuals from Veterans Affairs on 10 North Greene Street, Baltimore, Maryland, who are allegedly racking in money filing false VA claims on soldiers and veterans³⁸.

G, Ms.

Joella was working with Ms. G at the VA, and Ms. G allegedly told her that they may still be getting paid for veterans who died¹¹.

Garbow, Dr.

Breast Cancer Dr. Garbow⁶....

Allegedly pressured Joella to sign false VA claims filed by Leah C. Rock⁶....

Allegedly suggested Joella was the reason for Dr. Jackson and Alkihida leaving the VA⁶....

Gibson, Clair / Gibson, C.

Mentioned as one of several individuals from Veterans Affairs on 10 North Greene Street, Baltimore, Maryland, who are allegedly racking in money filing false VA claims on soldiers and veterans³⁸.

Mentioned as one of several individuals, including VA employees, who Leah Lyons allegedly helped in federal fraud of filing false claims before Leah Lyons quickly left the VA¹¹. Referred to as C. Gibson¹¹.

Harris, Andrew / Harris

VA employee who allegedly claimed to have treated Joella without meeting her¹....

Also described as another social worker who allegedly tried to move in with and live off of veterans⁸....

Allegedly got angry when Joella refused to let him move in and refused to file a claim he wrote for him to receive money⁸....

Physically described as looking like Homer Simpson, always wearing blue jeans and a white shirt, with a big head and little hair²³.

Allegedly dates a lot of veterans⁴².

Jackson, Dr.

Allegedly quit the VA after looking into everything⁵....

Dr. Garbow allegedly suggested Joella was the reason for their departure⁶....

Jason Peer / J. Peer

Mentioned as one of several individuals from Veterans Affairs on 10 North Greene Street, Baltimore, Maryland, who are allegedly racking in money filing false VA claims on soldiers and veterans³⁸.

Mentioned as one of several individuals, including VA employees, who Leah Lyons allegedly helped in federal fraud of filing false claims before Leah Lyons quickly left the VA¹¹. Referred to as J. Peer¹¹.

Joella

The US Army Veteran who provides the account of alleged wrongdoings and harassment⁴⁷....

The central figure in the narrative, claiming to be targeted by various individuals and institutions including the VA, police departments, NAMI, and others⁴⁷.

Jones, Lt. Bernard

Mentioned as one of several individuals, including VA employees, who Leah Lyons allegedly helped in federal fraud of filing false claims before Leah Lyons quickly left the VA¹¹. Also mentioned alongside Leah C. Rock, J. Peer, D. Arnold, B. Newberry, Ms. Julian, K. White, C. Gibson, and Sgt Jones in this context¹¹. Currently at Glenburnie Out Patient Clinic – replaced with Police Supervisor Brown

Julian / Juliana / Julian, Ms.

VA employee who allegedly claimed to have treated Joella without meeting her¹....

Referred to as Julian (he/she)⁴.

Mentioned as one of several individuals, including VA employees, who Leah Lyons allegedly helped in federal fraud of filing false claims before Leah Lyons quickly left the VA¹¹. Referred to as Ms. Julian¹¹.

Referred to as Juliana as one of several individuals from Veterans Affairs on 10 North Greene Street, Baltimore, Maryland, who are allegedly racking in money filing false VA claims on soldiers and veterans³⁸.

Leah C. Rock / Leah Rock / Little Rock

Supposed to be a VA social worker¹....

Allegedly a drug addict who blames minorities for her being on drugs, even though she claims to have never met them⁴⁸....

Accused of falsely claiming to be a beneficiary and having "assigned herself" as such³....

Accused of illegally spreading rumors in veterans' and soldiers' records¹....

Implicated in the filing of false VA claims in Joella's name³....

Allegedly claimed she could make claims "sound a whole lot better," which made Joella suspicious²⁰....

Dr. Garbow allegedly pressured Joella to sign claims filed by her⁶....

Genevieve Laporte advised against giving her money⁴....

Joella believes VA employees are looking for payment if they can get her to sign false claims filed by Leah C. Rock⁶....

Allegedly kidnapped veterans and helped place them in housing, getting police involved to arrest/medicate them and sign away benefits¹¹.

Allegedly must have been in rehab for drugs and mental issues¹¹.

Described as careless, violating HIPPA and civil rights¹¹.

Allegedly displayed drug addict symptoms at the VA, including yelling and jumping on Joella's car¹¹. VA employees allegedly dragged her off Joella's car, stating she is always like that¹¹.

Allegedly had a false women's home called Safe Haven in Montgomery County¹¹.

Mentioned as one of several individuals, including VA employees, who Leah Lyons allegedly helped in federal fraud of filing false claims before Leah Lyons quickly left the VA¹¹.

Referred to as "Little Rock" by Genevieve Laporte⁴.... Joella refers to her as Little Rock in other contexts as well²⁶.

Leah Lyons - TRANSFERRED

Social worker who allegedly quickly left when she found out she was guilty of federal fraud of filing false claims¹¹.

Accused of helping Leah C. Rock, J. Peer, D. Arnold, B. Newberry, Ms. Julian, K. White, C. Gibson, Lt. Jones, Sgt Bernard, and many more in federal fraud¹¹.

Mrc Michael

Mentioned as one of several individuals from Veterans Affairs on 10 North Greene Street, Baltimore, Maryland, who are allegedly racking in money filing false VA claims on soldiers and veterans³⁸.

Newberry, B.

Mentioned as one of several individuals, including VA employees, who Leah Lyons allegedly helped in federal fraud of filing false claims before Leah Lyons quickly left the VA¹¹. Also mentioned alongside Leah C. Rock, J. Peer, D. Arnold, Ms. Julian, K. White, C. Gibson, Lt. Jones, and Sgt Bernard in this context¹¹.

Weissman, Dr.

VA employee who allegedly claimed to have treated Joella without ever meeting her¹....

White, Kim / White, K.

Mentioned as one of several individuals from Veterans Affairs on 10 North Greene Street, Baltimore, Maryland, who are allegedly racking in money filing false VA claims on soldiers and veterans³⁸.

Zetter

VA employee who allegedly claimed to have treated Joella without ever meeting her¹....

FEDERAL AGENCIES

Anthony King

Former sergeant in the National Guard12....

He was a sergeant before Joella joined13.

Allegedly blames Joella for his divorce, which he claims stemmed from his behavior with other women while he was in the National Guard12....

Bridges, Sgt

Joella gave her phone to Sgt Bridges while she was on military duty when the MP police OFFICER were allegedly "sex talking SGT BRIDGES"10.

Matthew / Mathew Mader

COAST GUARD VETERAN

From Westchester Gardens on Clifton Road in Baltimore, Maryland 2121610....

Allegedly took Joella's belongings from her apartment10....

Allegedly falsified an eviction notice28....

Allegedly left messages demanding extortion money28....

Joella believes they received her information from Howard County Police, Baltimore Police, Virginia Police, Veterans Affairs, and anyone claiming she is supposed to be a danger14....

Allegedly went through her apartment when she was at work and appointments and had buyers for her belongings lined up10.

Joella claims to have messages from Mathew Mader yelling that he doesn't care about house laws or Maryland laws and can do whatever he wants, and that Joella should have paid the extortion money10.

Also referred to as Matthew made her and Charles made her31....

Charles / Charles Mader

From Westchester Gardens on Clifton Road in Baltimore, Maryland 2121610....

Allegedly took Joella's belongings from her apartment10....

Allegedly falsified an eviction notice28....

Allegedly left messages demanding extortion money28....

Joella believes they received her information from Howard County Police, Baltimore Police, Virginia Police, Veterans Affairs, and anyone claiming she is supposed to be a danger14....

Allegedly went through her apartment when she was at work and appointments and had buyers for her belongings lined up¹⁰.

Joella claims to have messages from Mathew Mader yelling that he doesn't care about house laws or Maryland laws and can do whatever he wants, and that Joella should have paid the extortion money¹⁰.

Also referred to as Charles made her and Mathew made her³¹....

COMMUNITY AT LARGE

Houser

Maryland State Police officer¹²....

Allegedly gave Joella a message stating, "They're trying to prove a point" by ruining her unless she provides military records, especially those of other soldiers and veterans⁶....

Sheriff

Allegedly stole Joella's belongings from her apartment after Matthew and Charles falsified an eviction notice¹⁹....

Claimed Joella had never paid rent, despite her having receipts¹⁹....

Referred to as Baltimore Sheriffs¹⁰.

Amanda Jo Lovell

Labeled Joella a drug addict, dealer, prostitute, and part of a family also described as such

.Labeled a drug addict, dealer, prostitute, and part of a family also described as such⁸....

Allegedly involved in writing false police reports about Joella⁸....

Allegedly provides females for the police¹⁰.

Allegedly gave Joella's phone number to the police to get out of jail¹⁰.

Joella's neighbor Kristy Davis is alleged to have provided females for police, and Amanda Jo Lovell did as well¹¹.

A Howard County Police officer allegedly called Joella complaining of herpes and suggesting Joella should have told him Amanda Jo Lovell and her sister Sam Lovell had herpes before he "force[d] sex with addicts"⁹.

Allegedly a drug addict who used to be an accountant, displaying signs of addiction¹¹.

Sam Lovell

Amanda Jo Lovell's sister⁹.

Part of a family described as addicts, murders, dealers, spreading STDs⁹.

A Howard County Police officer allegedly complained to Joella about getting herpes from her and Amanda Jo Lovell⁹.

Davis, Christy / Davis, Kristy

Joella's neighbor¹¹....

Joella claims her neighbor informed her that the police harassed them to lie about Joella²⁷.

Christy Davis allegedly gave Joella an online message stating police are crooked and sex trafficking¹⁰.

Joella had correspondence with the Davis's where they allegedly lied on her, claiming Howard County Police forced them to lie¹¹.

Kristy is described as a drug addict who used to be an accountant¹¹.

Kristy's mother, Toni Davis, allegedly got her a job at the Mount Airy Walmart, where she displayed signs of addiction¹¹.

Kristy allegedly assaulted Joella at the Walmart and claimed the police would believe her¹¹.

The police allegedly blame Joella for drug addicts like Kristy who have criminal histories and are trying to set her up¹¹.

Davis, Toni

Kristy Davis's mother, who allegedly got Kristy a job at the Mount Airy Walmart¹¹.

Lady Maryland Transit Authority

Referred to in conjunction with Wayne from "Our County police in Maryland Transit Authority"¹²....

They allegedly issued a two million dollar false toll to have Joella arrested because she refused to turn in her vehicle and herself¹²....

Joella's neighbor Christy Davis allegedly gave her an online message claiming Houser from State Police said, "Police are trying to prove a point with the lies, threats, harassment, assaults, abduction that I'm supposed be a prostitute"¹⁰.

Tina Williams - Maryland Transit Authority

Allegedly used to work at the tolls¹¹.

Allegedly left Joella a threatening message claiming she was helping the police get her¹¹.

May have been fired for falsifying toll photos and records¹¹.

Wayne / Wayne Mulany / Wayne Mullaney - Maryland Transit Authority

Involved with "Our County police in Maryland Transit Authority"12....

Referred to in conjunction with Lady12....

Allegedly issued a two million dollar false toll in an attempt to have Joella arrested because she refused to turn in her vehicle and herself10....

Referred to as TA Wayne Mulany10... and Wayne Mullaney from Baltimore Transit Authority11....

Allegedly almost shot Joella in the head11.

Mentioned as one of several individuals, including VA employees, who Leah Lyons allegedly helped in federal fraud of filing false claims before Leah Lyons quickly left the VA11. Referred to as K. White11.

Mickey mouse

Another police officer who allegedly claims they have many witnesses but no proof and are under witness protection27.

Miller, Victoria

JOELLA EMAIL ADDRESS - Appears as the sender of emails containing Joella's statements and forwarding messages/videos, indicating she is the person compiling and disseminating Joella's account11....

Sent emails on **Thu, Feb 10, 2022**, and **Thu, Feb 17, 2022**11....

Scott - COWORKER

Joella's co-worker at Stulz Air technology in Frederick26.

Allegedly made racial remarks about black people26.

Allegedly fired "last year" (relative to when the account was written)26.
