CONTACT THE APPROPRIATE COURT (IN PERSON OR IN WRITING) FOR:

- 1) Charges or fines not listed.
- 2) Fines for any offense which occurred in school zone.
- 3) **CONSTRUCTION ZONE VIOLATIONS (W/ workers present)**
****NOTE: If workers present in construction zone the fine doubles.**
- 4) If you receive a citation for **NO LIABILITY INSURANCE** proof must be shown with the effective date prior to the issuance of the citation and show proof to the Court on or before your appearance date, your case will be dismissed.
- 5) Charges for **EXPIRED** Motor Vehicle Inspection, Registration and Driver's License **if Remedied before first court appearance** of date of citation will be dismissed with a \$20.00 dismissal fee plus a copy of the receipt upon proof of renewal.
