If you fail to respond to the charge(s) by your appearance date, the additional charge of FAILURE TO APPEAR will be filed against you and your Driver's License may be suspended. If you have an out-of-state driver's license and fail to comply with the requirements listed, it may mean suspension of your driver's license in your home/license state. You may be required to post an appearance bond. You have the right to a jury trial if you so indicate. A plea of GUILTY or NOLO CONTENDERE means that you do not contest the state's charge(s) against you and that you agree to waive a trial before the court. To insure proper credit, return a copy of the citation(s) and completed reply form.
