If you fail to respond to the charge(s) by your appearance date, the additional charge of **FAILURE TO APPEAR** will be filed against you and your Driver's License may be suspended. If you have an out-of-state driver's license and fail to comply with the requirements listed, it may mean suspension of your driver's license in your home/license state. You may be required to post an appearance bond. You have the right to a jury trial if you so indicate. A plea of **GUILTY** or **NOLO CONTENDERE** means that you do not contest the state's charge(s) against you and that you agree to waive a trial before the court. To insure proper credit, return a copy of the citation(s) and completed reply form.
