As part of monthly quality improvements meetings, four hours of audit and review are generally provided—two hours at each sponsoring hospital—for a total of 48 hours annually. Audit and review are conducted by an SJCEMSC Medical Director or, occasionally, by an EMS Coordinator. All AEMTs and Paramedics are required to attend a minimum of **six** hours annually, based on their personal deadlines for the accumulation of CE hours necessary for state recertification. Page 13 of the SJCEMSC Administrative Guidelines
