Welcome and thank you for your interest in the Cornwall Volunteer Ambulance Corps. We are happy that you are thinking about joining our team.

Upon completion of this application you will be contacted by a member of our membership committee to schedule an interview. If you are joining us as a Jr. Member you must have a parent or guardian present during our interview process. Should you be accepted as a member of COVAC you will be placed in a training program with one of our preceptor's. Once off orientation you will be able to sign up for shifts. Shifts are in a six hour blocks and as an active riding member we require twenty-four hours a month. COVAC operates 24/7, 365 including weekends and holidays. It is your responsibility to meet the requirements of the position you are applying for,

When on shift you are required to remain in the Cornwall Ambulance District at all times. While you are on probation or if you are joining as a Jr. Member under the age of 18 you must remain at the station for the duration of your shift. COVAC does offer several amenities such as a lounge with beds, Wi-Fi, a full kitchen if you want to bring food to cook and showering facilities.

We look forward to having you join our team.

CORNWALL VOLUNTEER AMBULANCE CORPS is a voluntary service organization which provides emergency care to community residents in times of accidents or when other medical services are needed. At the time our services are rendered, the people and relatives to whom the services are rendered are generally in vulnerable physical condition and emotional states.

Our constitution requires that membership be "open to anyone of good moral character" (Article II, Section 1). Accordingly, in order to abide by the requirements of our constitution, an investigating agency may be asked to provide an investigative report containing information on your character, general reputation, personal characteristics or mode of living, including criminal convictions, if any, obtained through personal interviews with neighbors, friends, associates or others with whom you are acquainted.

Under the Federal Fair Credit Reporting Act of 1970, you may request in writing the disclosure of the nature and scope of the report referred to above, if any.
