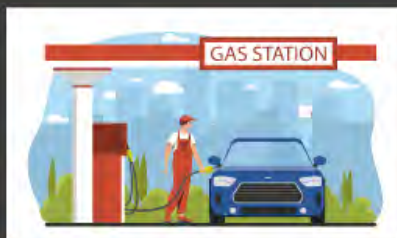

I am writing to you to voice my concerns about the inspection program.

Our industry has been performing vehicle inspections for the past 27 years without an increase in the fee or an overhaul of the inspection regulations, addressing the newer technology and EV vehicles.

However, the cost of living has increased, salaries and overhead have increased and the requirements to the inspection program have increased.

Yet the fees and regulations to the inspection program have remained the same.

A fee increase is necessary to keep up with the increased costs.

I respectfully request that your office recommend to the Governor and DMV Commissioner a fair and adequate inspection fee increase plus an update to the regulations as soon as possible.

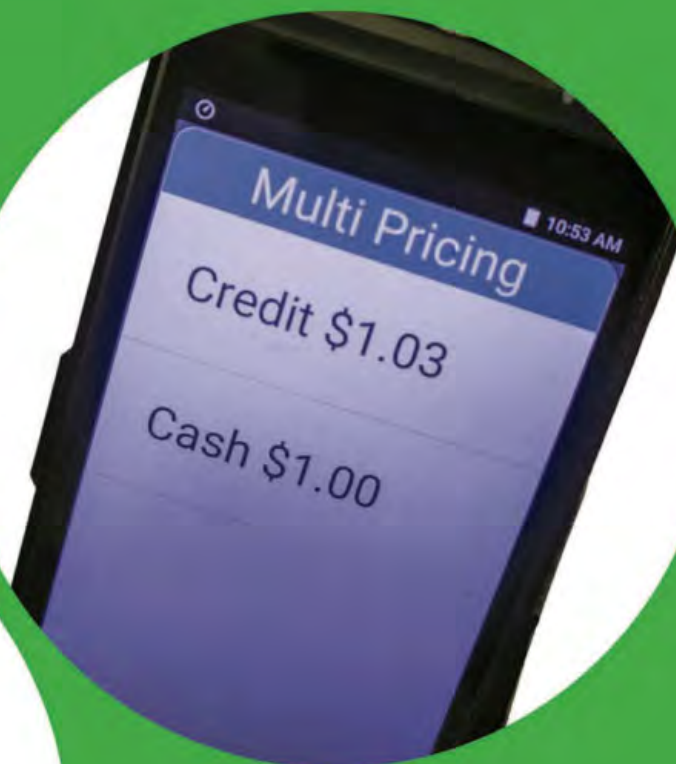

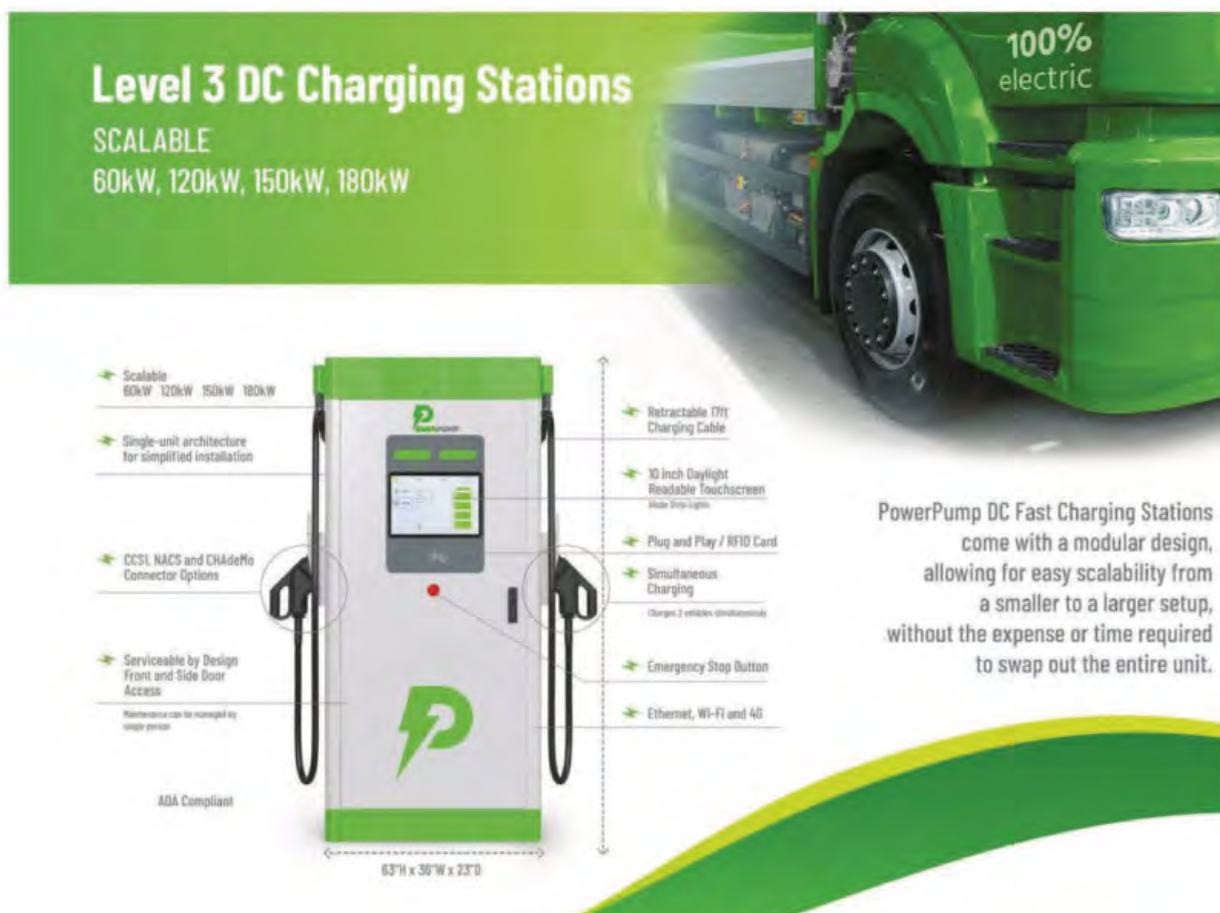

Mandatory Sexual Harassment Policy and Training

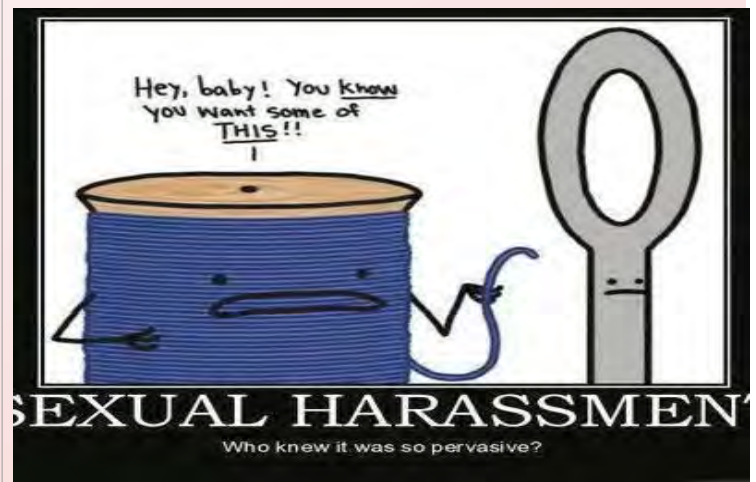

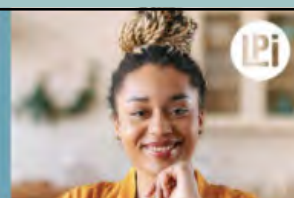
