In the event of an error in the price of any guest room, You have the right to cancel your booking at any time without penalty.

By making a booking to stay at Limefield House on the Website, in person or by telephone You agree to comply with these Conditions. You further agree to procure that any guest staying with you at Limefield House under Your booking will comply with these Conditions:

1. Bookings	<ul> <li>You may book to stay at Limefield House using the following methods: (i) on the Website; (ii) in person at Limefield House Polbeth, Livingston, EH55 8QL; or (iii) by telephone on 01506871237</li> <li>Rooms are strictly subject to availability.</li> <li>We reserve the right to refuse any booking for good reason.</li> <li>You and Your guests may check-in at anytime from 4.30pm on the arrival day unless otherwise</li> </ul>
Check-out	<ul> <li>advised by us to you prior to your arrival.</li> <li>You and Your guests must vacate Your rooms and check-out by no later than 11am on the departure date.</li> </ul>
3.
