

SOLAR ADS AND CLICK BAIT EXPOSED

NO COST SOLAR AD - Nothing in this world is free, heck not even smiles at McDonalds anymore. And with the USA's nation debt climbing a million and a half a minute and inflation really over 25% or more by the new prices we see on what we buy daily. Sadly we are all seeing what so called free stuff gets us. This is label "Partially true" because there is solar leasing available in a few states, see this explained below. We highly don't advise doing this if you have the money, credit or Heloc loan available. How solar is paid for is simple, you pay for the solar PV system or finance it and in your taxes you get back 30% of the entire cost from the federal government if you have a federal tax liability and in South Carolina you get an additional 25% back of the entire cost if you have a SC State tax liability. Your solar PV system generates X amount of power for your home or business daily. Take that money saved from not paying for all those kWh's you now generate for yourself each month and add the 30% - 55% federal and SC state \$1 for \$1 tax credits you get back if entitled and those 2 things is what pays for the solar system at a certain date in the future. (See real life example below of this breakdown of price and incentives and yearly power that size system produces). There are rebates available in a few areas of the country from a few select power companies but these are not guaranteed and only cover a small portion of the total cost.

GOVERNMENT SPONSORED SOLAR PROGRAM AD - No its actually paid for by all the tax payers in the USA combined, not the government. Between 30% of every solar system that is bought and the tax credit claimed and all the solar incentives the federal government hands out has amounted to \$190, 000, 000, yes that's a B for billion. There are but a few local programs around the country that do actually do free solar and I mean a few. The ones I have checked into pay like double the regular cost of solar and the system would take 30 years to recoup what was paid by the organization. Again nothing in this world is free or comes without a catch.

NEVER PAY YOUR ELECTRIC BILL AGAIN AD - Ohh how I wish this was true every time I sold a solar system. Our 14 person sales team was able to figure out at a company sponsored pow-wow event that we have sold over 5000 solar systems throughout all of our solar careers with numerous companies. Maybe about 20 of those 5000 solar systems sold were installed and took the ne solar client off of the grid. Most of America by law has to be hooked up to the grid. Even with solar most clients only generate 40-70% of their yearly energy usage. Also a big portion of your monthly electric bill is made up of delivery charges. This is the cost for the power company to maintain the lines and deliver power to

your house, and then you pay X amount per kWh based on peak and off peak usage hours of the day. Most power companies have a minimum monthly fee. The amount of battery storage needed to go off grid and especially just to power a regular size HVAC / AC compressor is really big and costly. Smaller size battery back up systems charged daily by a few of your solar panels is a great and affordable choice
