Diakonia World Federation Assembly in Tanzania

Deaconesses and Home Missioners in the United Methodist Church are members of the Diakonia World Federation (DWF), an international and ecumenical community of diaconal friendship. Every four years the DWF holds an assembly, bringing together deacons and deaconesses from all over the world and from many Christian denominations.

This year the Assembly took place July 7-12 in Moshi, Tanzania, the first time on the continent of Africa. Alabama-West Florida Deaconesses Clara Ester and Laurel Akin were 2 of the 250 people and 26 countries who attended.

A highlight of the Assembly was the special consecration service held for 15 new members of the United Methodist Order of Deaconess and Home Missioner, also a first on the continent of Africa.

I used to ask that question too. Why take vacation time and time away from my family to travel so far? Others were going and they would come home and tell me all about it. What's the point?

In 2018 I went to Assembly in Columbus, OH, to meet up with my friend Nancy, who came from another state. It was the most amazing experience!

Inquiring Minds Want to Know



There are many roles UWFaith leaders fill to support the structure of UWF. Each of the five jurisdictions has a set of elected officers just as the local, district, and conferences have. The jurisdictions do not have coordinators, but they are led by a Board of Directors with advisory input from the Program Advisory Group (PAG) and national staff.

The Board of Directors consists of 25 directors, 20 of whom are elected by their jurisdiction and five who are nominated and elected by the National Organization. From the 25, a team of leaders is nominated and elected. They meet at least twice a year and serve a four-year term. Their work includes policy and governance, strategic planning, budgeting, care of retirees, and property. Currently on the Board of Directors are six members of the SEJ: Stephanie Dressler (NC), Renee Hayes (WNC), Zan Jones (A-WF), Melba McCallum (NC), Patsy Thomas (SC) and Katy Wrona (A-WF). Margaret Gipson (MS) and Lori Sluder (Holston) serve as alternates.

Another group that works closely with the national staff is the Program Advisory Group (PAG). This group (65 – 70 members) is selected from a pool of leaders nominated at their conference UWFaith annual meeting and from recommendations from the national board of directors and staff. This group may include the 25 Board of Directors members, a representative from each conference not already represented on the 25-member board, the five UWF jurisdiction presidents, representatives from United Methodist agencies, and five members selected by the Board of Directors for diversity. This group meets at least once a year to study issues and prepare recommendations to the national board regarding mission priorities, mission education, interpretation work, and program guidance on behalf of members of UWFaith.

All of us have a role to play in United Women in Faith. A thoughtful strategy mentioned in a local unit may find its way into a national UWFaith membership campaign. A district's efforts to clean up local parks may be highlighted in a video for UWFaith. We all contribute to the "bigger picture," whether we see results immediately or months into the future. We know our efforts turn love into action for women, children, and youth around the world.

I absolutely love Mission u. How could you not love Mission u? This year marked our third year as an in person event since Covid. And just as in 2020 when our Study was "Finding Peace" this year's study "Practicing Hope" was just as timely. As the topics and studies are done years in advance, it is a reminder that God plays a huge role, He often just prefers to stay anonymous!

Again this year our event was held at the Catholic Conference Center in Hickory, NC. The Center is centrally located in our Conference and offers lodging, dining, conference rooms, chapel and more under one roof. For our older more seasoned veterans, this is a huge bonus – once you check-in, you do not have to venture outside until you leave. Our event this year was Friday, July 18th through Saturday, July 19th. Many of our members are integral to their Sunday worship service and being able to drive home before dark on Saturday is ideal.

Participants were seated Emmaus style at their tables, with their place at the table marked with their name tent. Each table of ten included at least one 1st timer as well as a mix of District representation so they would form new friendships and share from various experiences.

Normally we have an early morning praise time, but this year we opted to offer twilight Vespers with the theme "We are the Light!" Five speakers gave a short 3-5 minute example representing the theme, and as we progressed through the speakers they were told to light their tea light and bring it forward and place it in one of the cubicles. When the last speaker finished, we turned the cross around to reveal a beautiful lit cross through stained glass. It was truly memorable.

Our entire weekend was awesome from beginning to end. Great study, excellent study leaders, perfect musical accompaniment – it was a Mission u to remember. This was my final Mission u as Dean, and I could not have asked for a better ending. I may be presumptuous in thinking our Mission u was the best, but honestly I leave Mission u every year thinking ours was the best! I hope everyone feels theirs is the best!
