## Terms of Agreement

This document serves as a contractual agreement between Jax Xpress Events Rentals LLC and the undersigned customer, \_\_\_\_\_, date: \_\_\_\_\_ Time: \_\_\_\_\_ and Location \_\_\_\_\_.

The contract outlines the obligations of both parties and has been established for the purpose of providing rental services for 360, Magic Mirrors, iPad Photo Booths and Advertising Kiosk at the specified event, on the designated date, time, and location.

### Service Pricing

Our 360 service pricing model is reliant on the duration of the rental period. The total expense is computed by multiplying the rental duration of the 360 Photo Booth, Magic Mirror, or iPad Photo Booth with the corresponding hourly rate. It's important to note that the minimum booking duration for any Photo Booths or advertising Kiosks is three hours. To ensure the availability of your preferred date and services, we require a 50% deposit payment upon contract signing. Furthermore, customers are subject to a \$40.00 fee for every returned check.

### Cancelations and Rescheduling

To cancel or reschedule your event, we require a minimum of 14 days' notice before the scheduled date; failing to do so will result in the full invoiced amount being charged. In the case of unexpected circumstances, we encourage you to contact your representative promptly to explore alternative options.

## Travel

We've got you covered with free travel if you're within a 20-mile radius of Douglasville, GA 301345. But, if you're looking to go beyond that, we'll need to charge \$1.00 for each additional mile. And, while we'd love to park ourselves anywhere, we kindly ask that you arrange parking for our Jax team.

## Setup/Removal Requirements

To accommodate all the booths, a minimum floor space of 10' x 10' with a ceiling clearance of at least 8' is required. Additionally, a reliable power source of 110V, 10 amps, and a 3-prong standard electrical outlet should be available at a distance of at least 15 feet. The customer is responsible for any damage caused to our equipment or attendants due to improper power provisioning. For outdoor events, a dry location on a paved or concrete surface free of dirt is necessary. It's recommended to have a backup plan in place in case unfavorable weather is forecasted. In case of outdoor events, electrical equipment must be kept dry and protected from extreme wind, heat, cold, and direct sunlight. Jax Xpress cannot be held responsible for delays or incomplete setup if not allowed a reasonable amount of time or provided with the appropriate resources needed to complete the setup.

## Children under 10

In some cases Jax Xpress decide to enforce our "children under 10" policy for safety around the Booths. "Children under 10" must be accompanied by an adult over 18.

## Insurance

Jax Xpress Event Rentals is required to obtain and maintain insurance coverage with a policy limit of at least \$1,000,000 for any event produced by the LLC.

## **Equipment**

Jax Xpress Events Rentals, LLC owns all equipment utilized during an event, including but not limited to photo and video booths, printers, sound systems, lighting equipment, cameras, lighting, platforms, backdrops, tables, chairs, linens, props, red carpet, sanction posts, accessories, and more. These items must remain on-site at the setup location. The customer is responsible for any loss due to theft, vandalism, misuse, or damage caused by themselves or their guests. The customer agrees to pay for the repair or replacement cost of any damaged, misplaced, or stolen item. Should an attendant(s) be harassed, threatened, or abused by guests, or if equipment is damaged and cannot be promptly repaired at the event location, Jax Xpress reserves the right to interrupt service without providing a refund.

## **Insurance**

Jax Xpress Rentals Insurance policy will ensure a minimum of one million dollars in liability insurance and will provide the certificate upon request by the venue.

## **Additional Hours**

If a customer requests rental time beyond the predetermined allotment specified in the contract, Jax Xpress will evaluate the additional time needed and assess a fee ranging between \$175.00 to \$300.00 per hour, depending on the package. We aim to accommodate these requests, but it's essential to note that payment for additional hours must be made in advance of their commencement.

## **Attire**

Jax Xpress is willing to accommodate any specific attire requests, particularly if there is a special theme.

## **Release**

By utilizing Jax Xpress Events Rentals services, the customer grants permission for the use of photographs and videos taken during their event. It is understood and agreed upon by the customer that they will hold Jax Xpress Events Rentals harmless from any liability related to their event, both during and after. This indemnification will extend beyond the time of service and into the future. Furthermore, the customer agrees to indemnify Jax Xpress Events Rentals against any liability associated with the use of pictures taken within the Photo Booth by its representatives, employees, or affiliates at the customer's event.

This document represents the entire agreement between both parties and has been duly signed. In case of any disagreement between the parties, the Customer agrees to settle the matter through arbitration.

If Jax Xpress Events Rentals is unable to provide a functional photo booth for at least 90% of the service period, the Customer will be refunded a prorated amount based on the services received. In the event of a printer malfunction resulting in the inability to print photos during the entire event, Jax Xpress Events Rentals will issue a full refund of the printer rental fee.
