

PRIVACY POLICY

This Privacy Policy governs the data collection, protection, and usage practices for visitors of the digital properties under Ascendant Digital LLC, specifically including **Superior Notary Service™ (SNS)** (<https://superior-notary.com>) and **Ascendant Digital Notary Solutions™ (ADNS)** (<https://adnsco.com>).

What information do we collect?

- We collect information from you when you register on our site, place an order, subscribe to our newsletter, respond to a survey or fill out a form.
- When ordering or registering on our site, as appropriate, you may be asked to enter your: name, e-mail address, mailing address, phone number or credit card information.
- You may, however, visit our site anonymously.
- Google, as a third-party vendor, uses cookies to serve ads on our site.
- Google's use of the DART cookie enables it to serve ads to our users based on their visit to our sites and other sites on the Internet.
- Users may opt out of the use of the DART cookie by visiting the Google ad and content network privacy policy.

What do we use your information for?

Any of the information we collect from you may be used in one of the following ways:

How do we protect your information?

- We offer the use of a secure server.
- All supplied sensitive/credit information is transmitted via Secure Socket Layer (SSL) technology and then encrypted into our Payment gateway providers database only to be accessible by those authorized with special access rights to such systems, and are required to keep the information confidential.
- After a transaction, your private information (credit cards, social security numbers, financials, etc.) will not be stored on our servers.

Do we use cookies?

- **Yes:** Cookies are small files that a site or its service provider transfers to your computer's hard drive through your Web browser (if you allow) that enables the sites or service providers systems to recognize your browser and capture and remember certain information.
- We use cookies to help us remember and process the items in your shopping cart, understand and save your preferences for future visits, keep track of advertisements and compile aggregate data about site traffic and site interaction so that we can offer better site experiences and tools in the future.
- We may contract with third-party service providers to assist us in better understanding our site visitors.
- These service providers are not permitted to use the information collected on our behalf except to help us conduct and improve our business.
- If you prefer, you can choose to have your computer warn you each time a cookie is being sent, or you can choose to turn off all cookies via your browser settings.
- Like most websites, if you turn your cookies off, some of our services may not function properly.
- However, you can still place orders over the telephone.

Do we disclose any information to outside parties?

- We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information.
- This does not include trusted third parties who assist us in operating our website, conducting our business, or servicing you, so long as those parties agree to keep this information confidential.
- We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or others rights, property, or safety.
- However, non-personally identifiable visitor information may be provided to other parties for marketing, advertising, or other uses.

SMS Privacy Policy
