For the purpose of setting forth the terms and conditions of purchase by the Buyer of a pure-breed Puppy. Please check Puppy Breed.

For the seller agrees to sell and the buyer agrees to purchase a

1. Seller warrants that the above described puppy is a purebred Puppy/Dog (from registered litter and paperwork to complete registration will be provided to the Buyer (*only German Shepherds are register-able), when puppy is picked up.
2. Seller warrants that the above-described puppy is in good health at the time Buyer assumes ownership. Buyer agrees to have puppy examined by a licensed Veterinarian no later than five (5) days of receipt of puppy. If, as a result of the examination, the Veterinarian determines that the puppy is not in good health the Buyer may elect to keep the puppy or return the puppy to the Seller for a refund. If the buyer elects to return the puppy, Buyer shall, within 10 days of assuming ownership of the puppy, send to Seller by Certified Mail, a written Veterinarian's Certificate stating that the puppy was in ill health when examined. Upon receipt by Seller of said Certificate, Buyer shall be obligated to return the puppy to Sellers at Buyers expense. Upon receipt of the puppy, the Seller shall be obligated to refund all monies received from Buyer toward the purchase price of the puppy, and further performance under this contract shall be null and void. All action taken to return the puppy shall be done with the best interest of the puppy in mind.
3. Seller warrants that the puppy sold here-under is progeny of Dam(s) and Sire(s) that was radio-graphed (x-rays) and certified clear of hip and elbow dysplasia.
4. Ownership of the puppy will be transferred to the Buyer for the sale price (listed next to breed, to be paid as follows: Full Execution of the Agreement with full sale price to be

paid on or before the puppy leaves the Sellers premises. Payment acceptable will be cash. Unfortunately we cannot accept any personal checks. All deposits are *non-refundable* at the signing of this contract, or receipt of money paid.

1. Deposit/Reservation Fee: A puppy can be reserved with a *non-refundable* deposit of \$350.00; which will be deducted from the total sale price. Buyers may reserve a male or female with the above-described *non-refundable* deposit/reservation fee. In the event buyer decides they do not want the puppy the deposit is non-refundable.
5. The Seller has determined that the puppy is of 'pet quality'. In such case, Seller shall provide Buyer with Full Registration with breeding rights for German Shepherd puppies only.
6. Buyer agrees that the puppy will reside at the home of the Buyer, have access to a fenced yard, or be taken on walks daily, not be chained or tethered, and will be provided with proper housing, a good quality diet, annual veterinarian care and exercise.
7. The Seller at anytime before transference of puppy to it's new owner, reserves the right to deny the sale of said puppy to it's new owner with the deposit being refunded and the contract made null and void for any reason, if it is deemed by the seller to not be in the best interest of the puppy.
8. Buyer also understands that the puppy was born on **Bloodhounds born on 4/26/2022, German Shepherds born on 05/05/2022**, the puppies will be due for their 1st round of vaccinations no later than 6 weeks from date of birth. We the sellers will be providing the puppies with their first vaccinations, de-worming, and microchips. All puppies will be due for their 2nd Round of Vaccinations no later than 12 weeks of age.
9. Seller requires all Buyers to provide the Veterinarian Information of whom will be executing the veterinarian care:

10. Once Seller receives your signed Agreement with your Veterinarian information, Seller will send you an invoice for the reservation/deposit fee of \$350.00, and return a fully executed Agreement upon receipt of cleared funds.
11. Deposits will only be refunded in the event of illness, loss of puppies, death of puppies, or any other horrific event; where we the Seller can not provide a healthy puppy per this agreement.

This Agreement is made and signed by both parties to insure the well being and protection of this puppy. If the Buyer breaches any part of this Agreement, the Seller is released from any obligations under this Agreement.

6 Weeks Old	Fourth Worming, Vaccinations, & Micro-Chipping
7 to 8 Weeks Old	*Puppies can begin transitioning to their homes.

*****Please note if puppies have to be kept passed their 7 weeks of age, Buyer will be charged a boarding fee of \$5 per day and \$30 for each round of vaccination the puppy needs while in our care. For example, if buyer requires an extra month for us to hold the puppy, (Buyer will be charged an additional \$60) for 2 rounds of vaccinations at 8 weeks and 10 weeks plus \$150 for boarding.*****
