JOB TITLE: School Bus Operator
JOB TYPE: Part-Time – Permanent
LOCATION: Winnsboro, South Carolina
COMPENSATION: **Hiring range is \$16.00 to \$22.00 per hour** with previous verifiable school bus driving experience. Guaranteed six (6) hour per day during school days.

GENERAL DESCRIPTION: Operates school bus/activity bus to safely transport school students to and from school and co-curricular trips destinations in a timely manner, following all applicable laws, policies and regulations. Must be able to work as early as 6:30 AM, during the middle of the day and as late as 6:30 PM for a 180 Day school year. May be requested or required to work any combination of early mornings, days, evenings, nights, weekends, holidays, out-of town, and split-shifts.

MINIMUM REQUIREMENTS:

- Must possess a valid Commercial Driver's License (CDL) equivalent to a Class B with passenger "P" endorsement, school bus "S" endorsement, with no air brake restriction.
- Must possess a valid US Department of Transportation (DOT) medical certificate.
- Must possess or can obtain within one (1) month of employment a valid South Carolina School Bus Driver Certificate.
- 10-year motor vehicle record (MVR) must be insurable by company insurance carrier.
- Submit to and pass pre-employment drug and alcohol testing.
- Submit to and clear employment, safety, 10-year motor vehicle record (MVR), criminal background (FBI & SLED), and sexual offender background checks (SLED).
- Must be at least 18 years of age.
- Must possess a high school diploma or equivalent.
- Must have the ability to read, write and speak English in a clear, concise manner.
- Have at least twelve (12) months of driving experience.
- Have no more than four (4) current points against his or her motor driving record (MVR)
- Have had no more than four (4) points against his or her motor driving record (MVR) in the previous twelve months.
- Have not had his or her driver's license suspended for a moving violation within the previous twelve (12) months.
- Must **NOT** have had their driving license suspended or revoked within the previous three (3) years
- Must **NOT** have had one (1) or more suspensions (with reinstatement).
- Must **NOT** have had three (3) or more at fault accidents with the last three (3) years.
- Must **NOT** have had three (3) or more moving violations within the last three (3) years (The conviction date and not the date of violation will determine the time parameters).
- Must **NOT** have had any combination of three (3) or more moving violations and/or at fault accidents.
