There was no public hearing for the three special one day on-sale liquor licenses as the following dates have been cancelled: Tyndall Rotary, January 14, 2022; Tyndall Fire Department, February 5, 2022; and Tyndall Fire Department, February 19, 2022.

There were no council reports.

Properties:

Dougherty property, the city employees have taken out items of value and pictures were taken. The house will be moved to the south by Schenkel Demolition, closer to the garage. This is to ensure no other structures nearby are burned. The house and the garage will be burned by the Tyndall Fire Department. Schenkel will clean up and take away what is left. Rothschadl asked before the buildings are burned to ensure that all items of value are out of the house/garage.

Skorpik asked about the Brown property. Taxes have been paid for two years; the city can do nothing until 5 years of taxes have not been paid. The Fire Chief has not been given keys to access the property. Skorpik again discussed that George Yaeger would mow the property. Rothschadl stated due to liability, no volunteers should be involved in the mowing of the property. City employees have cleaned up the property to be able to mow the property.

Moved by K. Ranek, second by Soukup, to approve an Agreement for Furnishing Law Enforcement Services between Bon Homme County and the City of Tyndall for 2022 for the sum of \$2000.00. Sheriff will cover 720 hours for the year. Total of 30 days for vacation and sick leave for the two officers (10 days per officer for vacation leave and 5 days per officer for sick leave). All voting aye. Motion carried.

Council approved to talk to Vince Efta about the building at Lot 8, Exc S1', Block 23, Currier's First Addition, if it is for sale. If the building is available for purchase, the council will discuss again at the February council meeting. The Bargain Shoppe space is owned by the City of Tyndall, which is connected to Efta's building. Jones stated it could work to store the items from the Ptak lot to Efta's building.

Bob Foley provided an update on the Pocket Park, which was discussed at the December meeting. Foley discussed possible grants and donations to fund the Pocket Park. District III can help with a formal design, if it is needed. However the city would need to put in the request for the help. Chester discussed the city being responsible for the utility bills and maintaining the property. Rothschadl explained the property cannot be given to Tyndall Housing and Redevelopment; the property would need to stay the city's name since the city is tax exempt.

Elsberry presented an article about electric-car charging stations to South Dakota (SD). Funds were provided to SD from a settlement for funding for the electric vehicle charging stations program. Council agreed to have the city finance officer look into the SD program for electric car stations.

Moved by K. Ranek, second by Chester to declare surplus on the 1987 Stihl model 009 chainsaw. All voting aye. Motion carried.

Cuka presented the question, which had been asked of the finance office, how Ambulance calls out of Tyndall should be handled. Tyndall Ambulance is not compensated for the extra unloaded miles. Council made no decision.

A list of mandatory adjustments on ambulance bills was presented to the council. Moved by K. Ranek, second by Stepka to make the mandatory adjustments of \$29,690.00 on ambulance claims. All voting aye. Motion carried.

Catherine Cuka stated the current mileage being billed is at \$12.00 per mile and informed the council that an insurance company is reimbursing at \$13.00 per mile. Moved by K. Ranek, second by Chester to Increase the ambulance billing for mileage from \$12.00 per mile to \$13.00 per mile.

A list of three utility bills was presented to the council in the amount of \$801.07 to write off as bad debt. The council agreed to send all three utility bills to small claims court.

Council agreed to continue the discussion on delinquent utility bills in February's meeting.

Moved by Soukup, second by Chester to designate the Tyndall Tribune and Register as the city's official newspaper. All voting aye. Motion carried.

Moved by Stepka, second by K. Ranek to designate Security State Bank, now known as Security Bank Midwest, as the depository for all city funds. All voting aye. Motion carried.

Moved by Stepka, second by K. Ranek to enter into executive session at 7:38pm to discuss 2022 wages. All voting aye. Motion carried.

Mayor Elsberry declared the council out of executive session at 8:02pm.

Ranek, second by Soukup to approve a \$0.50 increase for Richard Jones (\$20.39) Zach Heesch (\$18.39); Bob Brattmiller (\$22.94); Jeff Honner (\$18.54); LeWayne Lukkes (\$23.69); Kelly Young (\$19.33); Cathy Cuka (\$22.95); Connie Sip (\$13.50); Joan Johnson (\$13.00); Don Cihak, \$11.50/hr; Parttime relief police, \$16.00/hr.; Parttime snow removal, \$13.00/hr. Increase of \$5.00 per call for Ambulance EMT's at \$40.00 per call. All voting aye. Motion carried.
