

### Introduction.

Associations are working harder than ever to define their value proposition, and their need to advocate, influence and respond to circumstances has never been more urgent and necessary.

In the increasingly turbulent 2020s, Boards of Trustees, their Chief Executives, and their staff teams face increasing expectations and demands from a widening spectrum of interested parties, ranging from staff, clients, and members, through sponsors, policymakers, and industry, to shareholders, partners, and suppliers. It is thus increasingly important that professional management be underpinned by an articulation of professional governance.

### What to expect.

The PCAAE's Certificate in Association Governance (CAG) course covers a range of specific topics to meet the particular needs of aspiring, newly appointed, and existing Trustees, providing guidance on best practice in association governance; and proving ideal preparation for anyone considering a Board role, a suitable induction for anyone embarking on a Boardroom career, and a timely refresher for seasoned Trustees. The course is also appropriate for CEOs and professional staff members who are tasked with supporting governing bodies.

Delivered through a combination of live Zoom sessions ,face-to-face meetings, provision of written materials, podcasts, case studies, performance assessment, and peer support, CAG offers 14 units of accessible, interactive, and engaging content, provided in a highly motivated learning environment. Participants will have the opportunity to check their progress with regular assessments and scenarios throughout the course, earning a digital credential for each completed module.

Following a final project-based assessment, participants will receive a PCAAE Certificate in Association Governance to highlight their achievement in completing the course as well as a CAG digital credential to add to email signatures, media profiles, and websites to demonstrate their expertise as a certified governance specialist.



### **Details.**

- 3½-month program for association leaders (i.e., Board members, CEO and professional staff) who want to enhance their knowledge and understanding of modern membership governance.
- Blended learning delivered remotely and face-to-face, combining online sessions, self-guided projects, group work, provision of written materials, podcasts, case studies, performance assessment, and a final project and presentation.
- Total time commitment of approx. 30 hours:
  - 10 3/4 hours: f2f trainer-led learning
  - 31/4 hours: online assessment
  - 6 hours: self-guided project research and write-up
  - 4 hours: f2f trainer-led project discussion
  - 41/4 hours: off-week learning, reading, etc.
  - 11/2 hours: CAG podcasts
  - 1/2 hour: knowledge benchmarking
- Comprises 13 mandatory units across 4 modules and a final project and presentation
