12.723 PUBLIC REQUESTS, CONCERNS & DISCUSSIONS

12.724 APOLOGIES

12.725 MINUTES

Parish Councillor Mitchell asked if the Parish Council were all in agreement with the Minutes from the last Meeting which was held on the 20th June 2019. The Parish Council agreed and accordingly Councillor Mitchell signed and dated each page of the Minutes.

12.727 NEW PLAY AREA

Parish Councillor Nicklin informed the Parish Council that the older kids were still jumping onto the roof. The Parish Council agreed that anti-Climb paint & stickers should be purchased. In addition, Parish Councillor Nicklin will look into getting the fencing made higher. He will also speak to the Hall Committee regarding the fence & gate.

12.728 GENERAL MATTERS

- Selby District Council are prosecuting more people for fly tipping and as a result are imposing heavier fines – hopefully will deter others.
- Grey Fold – residents are extremely concerned over speeding. The Parish Council have spoken to Barbara Scargill of Selby District Council who has in turn spoken to the Home Group. Accordingly, letters have been sent to all residents on the estate asking them and any visitors to be aware of children and other residents and to drive with extreme caution at all times.
- Residents of Sutton Village are concerned over the size & speed of vehicles passing through the Village. District County Councillor Ellie Jordan will look into the planning conditions and accordingly get back to residents. She also said that the signage & speed limits are the responsibility of NYCC Highways.
- The next walkabout will take place on the 22nd August. There were several matters to discuss on the walkabout including overgrown nettles on the path at 49b Byram Park road; overgrown gardens at the bedsits also on Byram Park Road; Crawford Close the gardens are overgrown; parking on footpaths and the ginnel on Sutton Lane/Sandringham Road (this has been ongoing for several years).
