12.738 GENERAL MATTERS

Public footpath between Sutton Lane and Ferrybridge badly overgrown. PCIIr Mitchell to write to CCIr Pearson.

Car Parking Village Hall - balls going over from MUGA area and hitting cars. PCIIr Nicklin will be attending Hall Committee meeting Monday and say the Parish Council are willing to pay for sign/s saying 'Cars Parked at Owners Risk', covering all risk assessments that have already been put in place.

CIL at last CEF meeting Andy Pound suggested Byram, Brotherton and Fairburn all use their CIL/106 monies to kick start programme with Water Board to upgrade sewage system as all 3 villages continually experiencing problems. All agreed joint meeting would be advantageous and AP had agreed to chair this.

Coach Road - Parish Council had agreed at a previous meeting to fund one pinch gate on the Coach Road subject to price. This will be approximately £600., will not be fitted until later in the year, agreed this should go ahead.
