The attention of all the Principals of Government Degree Colleges in the State is invited to the Government Orders read above and hereby inviting applications from eligible Assistant Professors, Librarians and Physical Directors for preponement of their dates of eligibility for Career Advancement Scheme awards to move from AGP ₹8,000 / Academic Level 12 to AGP ₹9,000 / Academic Level 13A and from AGP ₹9,000 / Academic Level 13A to AGP ₹10,000 / Academic Level 14 under UGC Revised Pay Scales, 2006 and 2016, as permitted in G.O.Ms.No.21, Higher Education (CE) Department, dated 03.06.2026, by reckoning (i.e., in continuation to the outcome of the reckoning of Junior Lecturer service and subsequent preponement of CAS from AGP Rs.6000/- to AGP Rs. 7000/- and AGP Rs. 7000/- to AGP Rs.8000/- in UGC RPS 2006 / AL-10 to AL-11 and AL-11 to AL- 12 in UGC RPS 2016 vide reference 10th cited.)
