ORDER:

In the reference 1st read above, Government have fixed uniform rates of remuneration to be paid to the officers/officials deployed on election duty to the General Elections to the Telangana Legislative Assembly, 2018.

- 2. In the reference 2nd read above, the ECI, New Delhi have issued instructions on payment of remuneration and TA/DA to personnel deployed for election related duties duly fixing the rates to be paid.
- 3. It has been brought to the notice by certain Collectors & District Election Officers in the State regarding variation in payment of TA/DA and remuneration to the personnel drafted for election duty in terms of reference 1st & 2nd read above. In order to maintain the uniformity in payment of TA/DA to the polling personnel and keeping in view of the G.O.Rt.No.53, Finance (HRM.IV) Department, dt.22.6.2023, the rates for payment of TA/DA and remuneration to the polling personnel drafted election duty are hereby modified.
- 4. After careful examination, Government hereby fix the following uniform rates of remuneration to be paid to the officers/officials deployed on election duty.

Sl.No.	Designation of Officers/Officials	Rate of remuneration (in Rupees)
1.	Presiding Officers / APOs / Counting Supervisor	Rs.600/- per day or part thereof
2.	Polling Officers / Counting Agent	Rs.400/- per day or part thereof
3.	Class-IV	Rs.300/- per day or part thereof

5. The above-mentioned rates are equally applicable to police personnel actually deployed on polling booths / counting centers.

- 6. The above rates are also payable to the staff for attending training classes, collecting polling materials etc., and also for attending duty on the polling day / counting day.
- 7. All the Collectors & District Election Officers in the State and the Commissioner, GHMC & DEO, Hyderabad shall take necessary action scrupulously.
