Sub: Collegiate Education – Consequential notification for Award of promotion under Career Advancement Scheme to the eligible Assistant Professors & Associate Professors / Librarians / Physical Directors in Government Degree Colleges in Telangana State – on preponment of CAS under G.O.Ms. No 21 - Orders- Issued.

Consequently upon implementation of the Government Orders in the 1st references read above, permitting the reckoning of 50% of Junior Lecturer Service and 50% of Lecturer Service rendered in the State Pay Scales for the purpose of Career Advancement Scheme (CAS), the dates of eligibility for award of CAS were accordingly preponed vide the 3rd and 4th references read above, subject to fulfilment of the conditions stipulated in G.O.Ms.No.15, Higher Education (UE)

Candidates who are benefitted reckoning 50 % Junior Lecturer Service and 50% of Lecturer Service in State Pay Scales in terms of G.O.Ms.No.21, dated: 03.06.2026 and consequent pre-ponement of CAS at all academic levels, applications are hereby invited from the eligible Lecturers/Assistant Professors, Associate Professors and equivalent cadres, including Librarians and Physical Directors, working in Government Degree Colleges in the State, for consideration of promotion under the Career Advancement Scheme (CAS) in UGC Revised Pay Scales, 2016, for movement from:

Academic Level-11 to Academic Level-12
Academic Level-12 to Academic Level-13A
Academic Level-13A to Academic Level-14

The eligible candidates shall submit their applications in the prescribed format enclosed to this notification, in duplicate, to the Principal of the concerned Government Degree College.

The Principal shall scrutinize and verify the applications and consolidate all eligible applications under his/her administrative control. The applications, along with the original Service Register and all relevant supporting documents, shall be forwarded to the Office of the Commissioner of Collegiate Education, Telangana, Hyderabad, after due verification of the required academic performance, service particulars and other eligibility conditions prescribed for promotion under the Career Advancement Scheme in terms of G.O.Ms.No.15, Higher Education (UE) Department, dated 29.06.2019, and subsequent Government Orders issued in the matter.

The Principals shall ensure that the Service Registers and supporting documents are verified with reference to the eligibility of the candidates, particularly in cases where the date of eligibility for CAS has been preponed consequent upon reckoning of 50% of Junior Lecturer Service and/or 50% of Lecturer Service rendered in the State Pay Scales, as permitted under G.O.Ms.No.21, Higher Education Department, dated 03.06.2026.
