ORDER:

Government in the reference 1st read above, have directed the Commissioner & Director of Collegiate education (CCE), A.P, Hyderabad, that the faculty in Government Degree Colleges (GDCs) be engaged on Contract basis depending upon necessity and that such faculty shall be engaged on Contract basis by the College Planning Development council concerned based on the recommendations of the Three Men Committee and they would be paid an honorarium @ Rs.5000/- per month and for Degree Colleges located in Tribal Areas and Rural Areas an additional Honorarium of Rs.1000/- per month would be paid.

- 2. Government in the reference 2nd read above, have accorded permission to enhance the remuneration to Rs.9500/- per month in Rural Areas and Rs.8500/- per month in Urban Areas to the faculty members working in Government Degree Colleges on contractual basis in the State from the Academic year, 2008-09.
- 3. Government in the reference 3rd read above, have enhanced the consolidated remuneration of the Contract Faculty working in the GDCs to Rs.20,700/- per month w.e.f.01.06.2011, without payment of D.A. or any other allowances, in terms of the Orders issued in G.O.Ms.No.3, finance (SMPC-II) Deptt., dt:12.01.2011
- 4. Government in the reference 4th read above, have reviewed the prescribed remuneration for Contract / Outsourced services and revised the same for certain specific categories listed out in the G.O. and also mentioned that in respect of the categories other than those specified in the G.O., which are having a fixed consolidated remuneration, the remuneration shall be fixed not exceeding 50% enhancement of the existing remuneration or the minimum of the time scale attached to the similar category of comparable post in the RPS 2015, which ever is less.

- 5. Government in the reference 5th read above, have accorded permission to the CCE, TS, Hyd., to engage 926 Contract Lecturers in GDCs in the State of Telangana for the Academic Year, 2016-17.
- 6. In the reference 7th read above, the Commissioner of Collegiate Education, Telangana State, Hyderabad, has furnished the additional financial implication of the enhancement of 50% of the existing remuneration i.e. Rs.20,700+10,350(50% of Rs.20,700) = 31,050/- in terms of G.O.Ms.No.14, Finance (HRM.1) Deptt., dt.19.02.2016 as Rs.9,58,41,000/- (Rupees Nine Crores, Fifty Eight Lakhs and Forty One thousand only) per annum and requested the Government to issue suitable orders in the matter.
- 7. Government after examination of the matter, hereby enhance the remuneration of the Contract Faculty working in the Government Degree Colleges in the State, in terms of G.O.MS.No.14, Finance (HRM-I) Deptt., dt:19.02.2016 from Rs.20,700/- (Rupees Twenty Thousand and Seven Hundred only) per month to Rs.31,050/- (Rupees Thirty One Thousand and Fifty only) per month and accordingly the payment of remuneration for the month of January, 2017 (to be paid on 01.02.2017) shall be made, subject to meeting the expenditure from the existing budget provision in the B.E.2016-17.
- 8. The Commissioner of Collegiate Education, Telangana State, Hyderabad shall take necessary action accordingly.
- 9. This Order issues with the concurrence of the Finance (EBS-IV) Deptt., vide their U.O.No.15778/324/EBS.IC/SE/2016, dt,10.01.2017.
