

**PROCEEDINGS OF THE COMMISSIONER OF COLLEGIATE EDUCATION,
TELANGANA: HYDERABAD**

Sub: Collegiate Education - Multi Zone-I - Career Advancement Scheme (CAS) - Preponement of dates of eligibility for award of Career Advancement Scheme (CAS) promotions to eligible Assistant Professors/Librarians/Physical Directors working in Government Degree Colleges under Multi Zone-I from AGP 6000 / Academic Level 10 to AGP 7000 / Academic Level 11 and from Academic Level 11 to Academic Level 12 under UGC Revised Pay Scales, 2006 & 2016 by reckoning 50% of Junior Lecturer service beyond five years and 50% of State Scale service as Degree College Lecturer - Orders - Issued.

The Government, vide G.O.Ms.No.21, Higher Education (CE) Department, dated 03.06.2026, accorded permission to extend the benefit of G.O.Ms.No.10, Higher Education (CE.I.1) Department, dated 19.02.2004, read with G.O.Ms.No.24, Higher Education (CE.I-1) Department, dated 08.01.2007 and G.O.Ms.No.4, Higher Education (CE.I-1) Department, dated 07.01.2008, for reckoning 50% of the service rendered as Junior Lecturer beyond five years and 50% of the State Scale service rendered as Degree College Lecturer for the purpose of award of Career Advancement Scheme (CAS) under the UGC Revised Pay Scales, 2006 and 2016.

In pursuance of the above Government Orders, a notification was issued vide reference 8th read above inviting proposals from the Principals in respect of eligible Assistant Professors, Librarians and Physical Directors for

preponement of their dates of eligibility for Career Advancement Scheme (CAS) promotions from Academic Level 10 to Academic Level 11 and from Academic Level 11 to Academic Level 12 under the UGC Revised Pay Scales, 2006 and 2016 by reckoning 50% of the service rendered as Junior Lecturer beyond five years upon promotion as Lecturer and 50% of the State Scale service rendered as Degree College Lecturer. The Principals of the erstwhile ID Colleges were requested to submit the Evaluation Committee reports along with the lists of candidates and their Preponement dates of CAS to the Commissioner of Collegiate Education, Hyderabad after scrutiny/examination of each application by the Screening Cum Evaluation Committee constituted at College level.

Basing of the recommendations of the respective Screening-cum-Evaluation Committees, the Commissioner of Collegiate Education is pleased to accord approval for preponement of the dates of eligibility for award of Career Advancement Scheme (CAS) promotions to the eligible Assistant Professors/Librarians/Physical Directors working in Government Degree Colleges under Multi Zone-I from Academic Level 10 to Academic Level 11 and from Academic Level 11 to Academic Level 12 under the UGC Revised Pay Scales, 2006 and 2016 by reckoning:

- a) 50% of the Junior Lecturer service rendered beyond five years upon promotion as Lecturer; and
- b) 50% of the State Scale service rendered as Degree College Lecturer.

The preponement of the dates of eligibility sanctioned in these proceedings shall not be construed as a fresh promotion. It shall only result in revision of the dates of placement under the Career Advancement Scheme (CAS) in accordance with G.O.Ms.No.21, Higher Education (CE) Department, dated 03.06.2026 and the applicable UGC Regulations.

The names of the eligible individuals together with the revised dates of eligibility are appended in the Annexure to these proceedings.

The Principals of the Government Degree Colleges concerned are further requested to regulate the pay of the Assistant Professors/Librarians/Physical Directors whose names are included in the Annexure appended to these proceedings by granting the Career Advancement Scheme (CAS) benefits from the revised dates of eligibility. **While regulating the pay, the Automatic Advancement Scheme (AAS) grades, if any, sanctioned in the lower cadre/State Scale posts shall be withdrawn in accordance with G.O.Ms.No.4, Higher Education (CE.I-1) Department, dated 07.01.2008 and Government Memo No.6612/CE.I-1/2008-3, dated 04.08.2008**

The Principals concerned shall communicate these proceedings together with the Annexure to the individuals concerned under proper acknowledgement.

If any discrepancy, omission, incorrect claim or ineligible service is noticed at any stage, these proceedings shall be liable for revision without prejudice to any other action that may be taken under the relevant rules. Any

excess payment made consequent upon these orders shall be recovered from the individual concerned in accordance with the rules as and when it comes to notice of this office.

The Principals of the Government Degree Colleges concerned are requested to make necessary entries in the Service Registers of the individuals under proper attestation regarding the option exercised for claiming the benefit of 50% weightage of Junior Lecturer service beyond five years and 50% of the service rendered under State Scales in the cadre of Degree Lecturer for award of Career Advancement Scheme (CAS).

The receipt of these proceedings shall be acknowledged immediately.
