Sub: TSCES – Government Degree Colleges - Filling up of the vacant post of Principals in Government Degree Colleges in the State for the Panel Year 2025-2026 – Regarding.

Ref: G.O.Ms.No.06, Higher Education (CE-I) Department, Govt., of Telangana, dated 06.02.2023.

All the Principals of Government Degree Colleges in the State are informed that proposals are invited in respect of eligible and qualified Lecturers/Assistant Professors/Associate Professors working in the respective Government Degree Colleges in the state for consideration for promotion to the post of Principal against the vacancies arising during the period from 01.09.2025 to 31.08.2026 for the Panel Year 2025-2026.

The proposals shall be submitted strictly in accordance with the provisions contained in G.O.Ms.No.06, Higher Education (CE-I) Department, dated 06.02.2023, and other relevant service rules, subject to the outcome of W.P. No.31808 of 2025.

Further, it is informed that the Hon'ble High Court, vide its orders dated 23.10.2025 in W.P. No.31808 of 2025 filed by Dr. D. Adeppa, Associate Professor in Economics and others, has directed that any promotions made to the post of Principal pursuant to the final integrated seniority list dated 30.08.2025 shall be subject to the final outcome of the said Writ Petition.

Eligibility Conditions

The candidates proposed for promotion shall satisfy the following conditions:

1. Must possess a Master's Degree with at least 55% marks or an equivalent grade.
2. Must possess a Ph.D. Degree in the relevant subject.
3. Must have completed 15 years of teaching experience as Lecturer (Existing)/Assistant Professor/Associate Professor in Government Degree Colleges as on 31.08.2026.
4. Must fulfil other eligibility conditions prescribed under the UGC Regulations issued from time to time.
5. Must have passed the Accounts Test for Executive Officers and furnish proof thereof (Hall Ticket/Gazette Notification).

The Principals are requested to furnish the following documents in respect of all eligible candidates:

1. Annual Confidential Reports (ACRs) for the last five years, i.e., from 2021-2022 to 2025-2026.
2. Original Service Register duly updated in all respects.
3. Copies of relevant certificates and documents in support of educational qualifications, service particulars, Accounts Test qualification, reservation status and other eligibility criteria.

The Principals shall ensure that all entries relating to qualifications, regularization of services, leave particulars (including EOL, Medical Leave, Leave Not Due, Dies-Non, etc.), disciplinary proceedings, punishments and court cases, if any, are properly recorded in the Service Registers.

The Annual Confidential Reports (ACRs) in respect of Lecturers/Assistant Professors/Associate Professors shall be recorded and signed by the Principals concerned under whom the incumbents worked during the respective assessment years. In respect of Principals holding Full Additional Charge (FAC), the ACRs for the relevant years shall be recorded and signed by the concerned Joint Director-I/II and Ex-Officio Regional Joint Director, as the case may be.

The proposals, duly verified and supported with all requisite records and attested documentary evidence, shall reach this office within **30 days** from the date of receipt of these proceedings without fail.
