The transfer will go into effect only after the new owner receives the Imagine Pools<sup>™</sup> Swimming Pool Handbook and updated Imagine Pools<sup>™</sup> Warranty Card. The transfer must occur within 1 month of the change in ownership of the Imagine Pools<sup>™</sup> swimming pool.
