Terms & Conditions of Registration & Participation

Please Complete the above Cana-Mex Rally Run 2021 application form with personal details, vehicle description, and the information required on the registration page. You may supply information regarding your co-driver at any time prior to the start of the Rally. Persons registered as Driver or Navigator are free to trade roles at any time provided both meet all the necessary requirements including a valid driver's license and insurance.

All persons traveling in a vehicle participating in the Cana-Mex Rally Run 2021 will be required to sign this agreement upon registration.

By Completing the application, signing these Terms and Conditions and participating in the Cana-Mex Rally Run 2021, you acknowledge and agree to all terms and conditions contained herein and agree to tender payment of the registration fee.

Upon registration participant shall immediately tender payment of the reservation fee or risk losing participant's place in the Rally.

In the event of cancellation by VRROOM LLC, or Cana-Mex LLC for any reason other than those outlined as Force Majeure in this contract, all registration fees received from participants shall be refunded in full within 45 days of notice of cancellation.

In the event of cancellation by the participating team (driver, navigator, and car) the registration fees received will be refunded at the percentages set forth below, within 45 days of notice of request for cancellation on the following schedule:

Cancellation more than 180 days from event start date = 100% refund Cancellation more than 90 days from event start date = 50% refund Cancellation less than 30 days from event start date = 0% refund

Vehicle Makes and Age Requirements

The Rally is open to all makes and models of European manufactured vehicles, 35 years or older. Paid Registrations are limited to just twenty five (25) vehicles. All participants/drivers or passengers/co-drivers (collectively Participants) in a Rally vehicle must be 21 or over.

Safe and Courteous Driving Requirement

Safe and courteous driving is required by all participants during the Rally. All participants are required to drive safely and with proper courtesy with respect to all other participants and members of the public. In the event that your ability to drive or otherwise participate in the Rally, safely and properly, is in any way compromised by illness, lack of adequate rest, intoxication, or because of any other condition that may put you, other Rally participants, the general driving public, pedestrians, or any other persons or property at risk in any way whatsoever, you are prohibited from participating in the Rally.

Compliance with Terms

Participant agrees to comply with all the Rally's terms and conditions of entry. Participant acknowledges that although the VRROOM and CanaMex Staff will use reasonable efforts to ensure that all participants abide by the terms and conditions regarding safety and compliance with laws and regulations, the Staff cannot guarantee that the participants will abide by these terms and conditions.

Badging

VRROOM/CanaMex Staff will provide all registered Participants with badges identifying the wearer as a participant in the Rally. The badge will identify the participant and outline the rules of the Rally and is to be worn during participation in the Rally and Rally events.

Gambling/Wagering prohibited

Gambling or betting of any kind in relation to the Rally is prohibited. No Racing Permitted

Racing is prohibited.

The Cana-Mex Rally Run (the "Rally") is not a race and racing or competing with any participant or any third party is expressly prohibited by these terms and conditions.

Compliance with all laws and regulations is required.

All participants in the Rally shall comply with all applicable laws and regulations of the City, County, State and Country in which they are present at all times during the Rally, including but not limited to speed regulations, laws of the road, laws relating to the safety of your vehicle and operation of your vehicle, laws relating to registration of and insurance on your vehicle, laws relating to your license to operate a vehicle and laws relating to the possession or use of alcohol, drugs or other prohibited substances. The VRROOM Staff reserves the right to prohibit you from participating further in the Rally for any violation of the foregoing or of any terms and conditions contained herein.

Insurance Requirement

Each Participant shall obtain and maintain insurance specifically covering his or her vehicle and participation in the Rally and shall provide proof of such insurance in a form satisfactory to Cana-Mex Rally Run staff should they request such documentation. Appropriate insurance includes, without limitation, third party liability, liability coverage for each Participant and passengers, medical insurance, damage to property and life insurance, and insurance covering Participant vehicle's participation in the Rally.

License Requirement and Registration

Each Participant shall possess a valid vehicle registration for the vehicle to be driven in the Rally, such registration to be in the Participant's name.

Each driver of a vehicle participating in the Cana-Mex Rally Run must hold a current, valid and unrestricted driver's license from a state within the USA, Canada or hold a valid international driver's license and shall present the same upon registration.

DATES/ROUTES

Due to COVID-19, the 2021 Cana-Mex Rally route has been condensed, and we have removed International border crossings.

The 2021 Cana-Mex Rally Run will take place September 26th - October 2nd. Beginning in Big Sky Montana, and ending in Tombstone Arizona.

The route may be subject to change. Any changes to the route, and the latest route information will be available on the Cana-Mex website.

LIABILITY DISCLAIMER, RELEASE AND INDEMNIFICATION

VROOM, LLC and Cana-Mex Rally Run LLC and their members, employees, consultants, agents, staff, assigns, and attorneys, specifically disclaim responsibility for and shall not be liable to any Participant or any third party

for the acts or omissions of a Participant arising from their participation in the Rally. This DISCLAIMER OF LIABILITY includes but is not limited to liability arising out of Participants violation of State, Local or Federal Law, liability for intentional torts or negligence or liability arising out of contractual agreement. In consideration of his/her participation in the Rally, Participant expressly agrees to release VROOM, CanaMex and their members, employees, consultants, agents, staff, assigns, and attorneys, from any and all liability for personal injury, death, property damage, economic loss, breach of contract, lost wages, contribution indemnity, indemnity, punitive damages, negligence, or any other legally recognizable claim arising out of Participant's participation in the Rally (including all legal costs associated with such claims).

As a condition of participating in the Rally, Participant agrees to indemnify VRROOM, LLC, Cana-Mex Rally Run, LLC and their Staff against any and all liability, claims, lawsuits or causes of action of any kind, including claims for attorney fees, whether in contract, tort or arising out of federal, state or local statute, resulting from Participant's participation in the Rally, whether brought by Participant or any third party as a result of Participant's actions, omissions or participation in the Rally.

FORCE MAJEURE

VRROOM, CanaMex and their Staff are not responsible if they cannot fulfill their obligations under this agreement due to fire, earthquake, epidemic diseases, cyclone, flood, aridity, strike, lightning, revolution, terrorist activities and similar troubles, and in other cases generally accepted as Force Majeure under the statutes and case law of the State of Minnesota

LOGOS and Emblems

Participant agrees to have the "Cana-Mex Rally Run" logo and any other logos designated by VRROOM Staff, including but not limited to official Rally sponsors, attached to Participant's vehicle and kept visible during the entire Rally. VRROOM and CanaMex shall not be responsible for claims of damage to vehicle finishes as a result of the application or removal of such logos.

Unauthorized Sponsorship Prohibited

Unauthorized Logos, Emblems or indications of sponsorship, other that those approved by VRROOM and CanaMex are prohibited unless otherwise approved by VRROOM in writing.

No Refund of Fees within 30 days of event

In the event that a Participant is unable or unwilling to continue on or complete the course of the Rally for any reason, including but not limited to injury or illness, mechanical failure, damage to Participant's vehicle Participant shall not be entitled to any refund of fess paid under this agreement.

Cancelation or Expulsion

The Cana-Mex Rally Run staff reserves the right to expel any Participant from the Rally for failure to adhere to the Rally rules. No refund of fees shall be granted to any expelled Participant. VRROOM and CanaMex reserve the right to cancel the Rally for any reason based on the sole discretion of VRROOM and CanaMex Staff.

Intellectual Property/ Permission and Consent to use Likeness

VRROOM LLC and CanaMex LLC shall retain all intellectual property rights in all images, Logos, emblems and text associated with the CanaMex Rally Run. VRROOM LLC and CanaMex LLC shall retain all intellectual property rights in all images, films, photographs, recordings and text produced prior to, during and after the CanaMex Rally Run Event. All Participants consent to be photographed and to be included in the filming of footage documenting the Rally. Participants waive all privacy rights in the use of their likeness and grant the Cana-Mex Rally Run staff full and complete permission to utilize Participant's likeness captured during their participation in the Rally, in any manner and on any media without geographical limitation, in perpetuity.

Participant consents to the use of his or her name, image, likeness, voice and biographical material in connection with any and all footage, photograph, text or related promotional material and for any and all publicity and promotional purposes.

Participant expressly releases VRROOM, CanaMex and their Staff from and against any and all claims which Participant has or may have for invasion of privacy, defamation or any other cause of action arising out of the production, distribution, broadcast or exhibition of photographs, footage, recordings or promotional materials containing biographical information, images, film or recordings of Participant.

Participants may make photographs, film footage or recording of the Rally and Rally events for their personal use but not for any commercial purposes or for public distribution. Participant shall refrain from conducting any media appearance without the express consent of VRROOM and CanaMex staff. Participant expressly grants VRROOM and CanaMex a perpetual and unrestricted license to use all images, films, photographs and recording made by participant during the Rally.

Changes to Terms and Conditions


