- 6. Color: Note whether color is the same as existing on house, or attach color chip for other colors/stains.
- 7. Grading plan if changes in grade or other conditions affecting drainage are anticipated. (Generally, approval will be denied if the adjoining properties are adversely affected by changes in drainage).
- 8. Landscape plan if application is for landscaping or if relevant to project.
- 9. Signed written agreement of affected lot owner if improvement falls on property line.
