Motion by Toni that was seconded by Debbie to elect Lauren as secretary. Roll call vote is as follows: Shawn-YES, Kelly-YES, Toni-YES, Lauren-YES, Charlie-YES, and Debbie-YES. 6 yes, 0 no with 1 absent, motion passed.

Motion to pay the bills as presented by Shawn. Motion seconded by Toni and all in favor. Motion to pay the bills passed. As of November 28th we had \$66,529.71 in the checking. As of December 31st, we had \$63,787.45.

Discussion on King and King CPAS and our audit. Our building insurance went down from \$2,786.00 to \$2,458.00. We have a bid for a cleaner that will vacuum and mop for \$50 for 2 hours and add dusting for \$75.00.

New events are adult bingo and preschool story time. Ruth is working on building an igloo out of milk jugs for a fun reading space. We have new library cards to go with Apollo. Ruth produced a motto that states, Knowledge is growth. She also presented a vision.

Talks on the budget and the income vs expense. Discussion on the cleaning and what we can and cannot afford. Meeting running long, motion by Charlie to extend the meeting past 9 pm seconded by Toni all in favor. Motion passed. It was suggested to start a trial basis for the two-hour cleaning price of \$50 for a two-month period. Motion by Toni Seconded by Kelly to approve the budget for 2023. All in favor of passing the budget so motion passed.

Tabling the ideas for a new printer and the new chair upholstery. Shawn, Lauren, and Ruth plan to attend the rotary club to get help with things we need but may not be able to budget for. Apollo is a go just waiting for cards to come in. Hoping to be all set by Feb. 4^{th} .
