We invite you to participate in our 46<sup>th</sup> Annual Germantown Pretzel Festival held on Saturday September 26<sup>th</sup> (9 am to 9 pm) and Sunday September 27<sup>th</sup> (Noon to 6 pm) there will be NO RAIN DATES OR REFUNDS. The festival is located in Veterans Memorial Park, corner of North Walnut Street and West Warren Street. (TWO BLOCKS WEST OF HISTORICAL DOWNTOWN GERMANTOWN.)

**Due to increased costs and emergency electrical upgrades and repairs, we had to raise vendor fees. It has been many years since we had to raise the vendor fees even with inflation.**

DEPTH 10 FT MAXIMUM

Due to the fact that we are filling the park, the Maximum depth for each booth, in the grass, will be 10 FT. Please make sure your booth or tent meets these requirements. If you want a display in front of booth it must start 4 FT from sidewalk & behind the white line.

Applications must be postmarked by July 1st, 2026, to avoid late fee of 25%. No refunds after July 15, 2026.

**Please make checks or money orders payable to Germantown Pretzel Festival. Cash will not be accepted at any time.**

**No electronic payments will be accepted (Facebook Pay, Venmo, PayPal,...)**

A fee of \$30.00 will be assessed for any returned checks.

#### FESTIVAL RULES:

INCLUDE TRAILER TONGUE AND AWNING IN YOUR LINEAL FOOTAGE

REQUIREMENT! NO WHEELED VEHICLES CAN BE SET IN THE GRASS.

BOOTHS ON PAVEMENT CAN NOT BE MORE THAN 10 FT DEEP.

MUST STAY WITHIN FOOTAGE PAID FOR.

If you want to serve out of both ends of your booth or need room for grill and cooking equipment you must include this in your footage also. Nothing in front or behind trailer, must be on one end and included in your footage fee.

ONLY LIMITED ON SITE VENDOR PARKING AVAILABLE!!!!

No more than three (3) booths will be allowed to sell same food item. Preference will be given to the earliest applicants. **In order to be guaranteed to be allowed to sell certain food items your application is due before the close of the current year festival.** As a result of this policy, you may be required to remove unapproved items. **THERE ARE NO RESTRICTIONS ON PRETZELS.**

Park will be available for setup at 10 am – Dusk ON FRIDAY, September 25, 2026 . NO SATURDAY MORNING CHECK-IN. YOU MUST COME ON FRIDAY & GET BOOTH NUMBERS. All vehicles need to be unloaded and out of area by 8 am Saturday. You can close your booth at any time during festival hours but you CANNOT bring your vehicle into festival area or move booth out during festival hours without permission from Chairperson.

You are responsible for cleanup of your booth area before leaving each night. Bring your own broom or rake. There will be a dumpster by the pool for your trash. NO GREASE IS TO BE PUT IN THE DUMPSTER – GRAY WATER CONTAINERS ARE ON SITE. Festival committee will provide water service. You must provide your own water hose for final hook-up.

Booths will be placed or located according to electric requirements or booth committee best judgement. BOOTH # AND LOCATION WILL NOT BE AVAILABLE UNTIL YOU COME TO SETUP. YOU MUST CHECK IN AT DEPOT OFF WEST WARREN STREET.

Food vendors require health permit, which is the responsibility of each INDIVIDUAL VENDOR. Contact: Combined Health District of Montgomery County, Dayton, Ohio, at least 10 days before event at: 937-225-5943 or 937-225-4460

All Vendors must provide a valid certificate of **Liability Insurance**. **Food Vendors must name the Germantown Pretzel Festival and the City of Germantown as additional insured.** An insurance certificate is required prior to setting up.

A single cord supply minimum of 150 FT long will be required by you to make your final electrical hook-up, with proper ends. A proper 110 or 220 (4 prong plug for commercial trailers). Onsite electrician will make all electrical connections into service box, no direct hook-ups allowed. You are responsible for keeping cords, plugs and electrical connections off the ground per local electrical code. Electrical fees on first page do not apply to 110 Power.

The festival committee will not be responsible for injury, loss of property or legal action that may arise or occur to the public from any condition whatsoever while said premises are being occupied under this agreement.

THE GERMANTOWN FESTIVAL, INC. RESERVES THE RIGHT TO REQUEST THE REMOVAL OF ANY ITEM OR BOOTH NOT CONSIDERED APPROPRIATE OR WITHIN THE THEME OF THE FESTIVAL AND NO REFUND WILL BE ISSUED. FOR THE CONSIDERATION OF ALL VENDORS

PLEASE NO PETS; HOWEVER, SERVICE ANIMALS ARE PERMITTED.
