Thank you for your interest in joining the Artisans of Australia community. Applications are reviewed regularly, and we will be in touch as soon as possible to discuss your application. We are a 0% commission site, where each artist hires their space in the shop (to cover the outgoings / staffing / marketing / public liability / cleaning etc) and then receives the profits from their sales.

CRITERIA

The criteria for successful applications are as follows:

- We support artisans at all stages of their career; however, the expectation is that submitted works will be of the highest quality and finish, with an attention to detail;
- All mediums and styles will be considered;
- Work must be original and not breach any copyright laws; and
- While we encourage recycling and upcycling of materials in artworks, the finished piece must meet the previous criteria in terms of quality and finish – we reserve the right to refuse items as they are brought in.

LICENSE FEES

The shop space at Artisans of Australia can be licensed monthly for (*please circle as appropriate*) –

\$15 per 1/4M² - ie. a row of cards, one (1) medium painting or one (1) shelf of jewellery
(see examples A – E on page 3)

\$50 for 1M² - suitable for hanging art such as multiple/larger paintings or sculptural pieces
such as ceramics (see examples, F – J on page 3)

Space is limited and we appreciate your support in ensuring that your work is regularly rotated, as well as being aware of the amount of space allocated to you.

You are welcome to bring in new pieces anytime, however please note they will not be displayed until the following Tuesday to allow us time to catalogue, photograph, label and confirm stock quantities prior to placing in the gallery shop. Existing pieces will be removed as necessary to accommodate the new pieces in your allocated space; you will be contacted when these are ready for collection.

CANCELLATION OF LICENSE

Licenses run monthly from the 1st of the month, and are payable in advance.

To cancel your agreement please provide at least one (1) months notice – e.g. If you wish to stop licensing the space on the 31st July, notice should be given by the end of June.

If notice is given later than one (1) month prior, then regardless of when the pieces are removed the subsequent month's fee will become due – e.g. If you notify us on the 15th June that you wish to remove your pieces, you will still need to pay for 1st – 31st July.

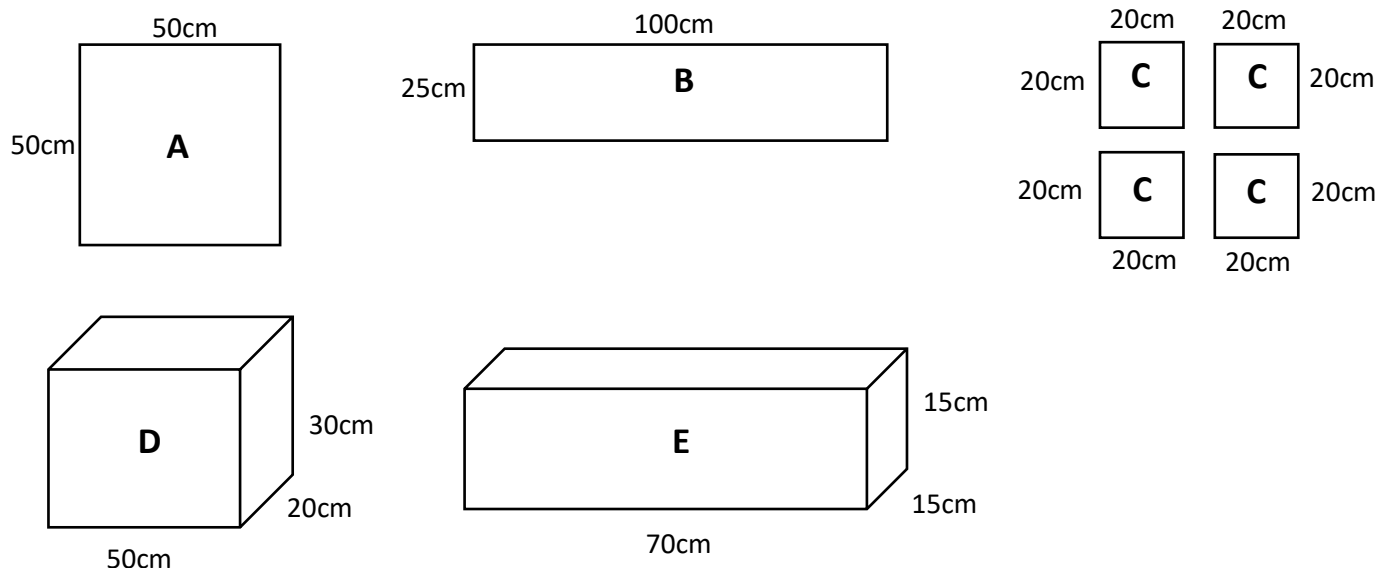
