A regular meeting of the Junior Livestock Advisory Committee was called to order by Jennifer Mason at 6:05pm. A quorum (50% + 1) was present.

Hannah Billows moved to approve the minutes from the November meeting. The motion was seconded and passed, voice vote.

**I. Old Business**

**A. Updates from Fair Board:**

1. The Fair Board approved JLAC's recommendation to have an optional pre-weigh for hogs, sheep and goats. Cattle pre-weigh will still be mandatory as scheduled. As a result, there will not be a rate-of-gain requirement for hogs, sheep and goats, but there will still be an optional rate of gain contest for those who choose to participate in pre-weigh with hogs, sheep and goats. Look for an update from the February JLAC meeting regarding ownership documentation required for hogs, sheep and goats.
2. The Fair Board did not approve JLAC's recommendation for a Supreme Champion Drive. The Board cited a need for additional information before making a decision. It was moved by Angela Mayfield to appoint a special committee consisting of Shannon Hindman, Mackenzie Hindman and Cody Gold to outline details for a potential Supreme Drive for the 2023 Amador County Fair." The motion was seconded and passed voice vote.

- B.** It was moved by Hannah Billows that "we do not have a walk-on dairy goat show this year". The motion was seconded and passed, voice vote.

- C. Proposition 12 - Market hog affidavit Update: As of 1/25 The Superior Court for Sacramento County in California announced that the state must halt enforcement of Proposition 12 for six months. This still puts our fair in the potential realm of being affected by Proposition 12. This will not affect custom processing of hogs but would affect resale processing of hogs. JLAC will provide a consistent Proposition 12 affidavit for hog exhibitors to have signed by the breeder from whom they purchase market hogs. - D. Goat Resale: Angela to follow up with processors regarding processing of resale goats.
- E. Steer Minimum Weight: DeAnna Bell moved to “**increase market steer fair minimum weight to 1,050 lbs starting at the 2023 Amador County Fair**”. The motion was seconded and debate followed. The motion passed voice vote.

## II. New Business

- A. Nomination and Confirmation of Goat Representative for 21-22. **Angela Mayfield moved to nominate Dawn Muschetto as the JLAC Goat Representative.** The motion was seconded and passed, voice vote.
