COMMERCIAL VENDOR APPLICATION INFORMATION The Amador County Fair will be held <u>July 25 through July 28, 2024</u>.

Thank you for your interest in being a commercial vendor at the Amador County Fair. The Fairs annual attendance is 26,000 – 28,000.

Outdoor booth fees are \$590 - \$670 per 12 'x 12' location. **Indoor booth fees** are \$540 - \$590 per 10' x 10' location for the duration of the fair. Larger sizes may be available upon request.

Indoor and Outdoor Commercial booth fees include 8 - 1-day gate passes and 1 - 4-day parking. Additional vendor admission passes are available at the reduced rate of \$5.50 per person per day and vendor parking passes are available for \$16.50 (4- day) for the duration of the fair.

RV parking spaces are limited, so please contact us to reserve a space. The campsites are \$265 per site for the duration of the fair, which includes one vehicle pass. **No guarantee of any hookups**.

****NEW**** We are offering **"Craft" Vendors indoor booths.** To be eligible, all items must be handmade (no commercial products eligible). The booth is 10'X 10' for \$375 each for the 4 days of the Fair and includes four 1-day gate admissions and one - 4 day parking. Limited spaces available.

Note: The indoor building is locked each night and unlocked in the am with supervision.

Tents, tables, and chairs are the responsibility of the applicant. All tents must be inherently fire resistive or treated and labeled accordingly. Equipment is not provided.

ALL VENDORS MUST PROVIDE INSURANCE – A minimum of \$1,000,000 general liability per occurrence, naming the Amador County Fair as additional insured. If a Vendor can not provide their own, insurance for this event, it may be purchased through California Fairs Services Authority (CFSA) which the Fair office will assist with this application.
