WINDOW EXHIBITOR APPLICATION INFORMATION

The Amador County Fair will be held July 30 through August 2, 2026

As window spaces become available, Fair Management will review the new applications to fill vacancies. Upon review, new applicants will be notified of their acceptance or position on our waiting list.

Windows in Pokerville Hall are 7' 9½ " x 6' 9¼ " x 2' 1" in dimension. The remaining windows are displayed by the front entrance to the Mercantile Building and are 10' 1" x 8' x 3' 3½ " in dimension.

The fee is \$165.00 per window.

There are door(s) that give accessibility for decorating. ****WINDOWS MAY BE STARTED ON WEDNESDAY, JULY 1, 2026** (8:30 am to 4 pm) & *must* be **COMPLETED BY WEDNESDAY, JULY 15, 2026**. (There will be certain days (to be announced) the building will not be available for access to the windows during the setup/teardown. Please call or check for weekend accessibility. **DAYS NOT AVAILABLE ARE SATURDAY, JULY 4, SUNDAY, JULY 5, 2026 – FAIRGROUNDS CLOSED.**

Please have your window dismantled & debris cleaned up by Friday, August 8, 2025. The Fairgrounds will be closed Wednesday, August 5, 2026.

****PLEASE SHARE ALL THIS INFORMATION WITH YOUR WINDOW ARTISTS!**

Judging is split into two categories: Commercial & Non-Commercial windows. The criterion for commercial windows is based on the following: Exhibit Theme, Promotional Value as related to product and/or business, Attractiveness, & Decoration and Arrangement. For Non-Commercial displays, the criteria is based upon: Exhibit Theme, Attractiveness, & Decoration and Arrangement. The fair *strongly encourages* participants to incorporate the fair theme into the windows. Be sure to use family-friendly displays as this is your business or organization's showcase for the visitors of the Fair.

Electrical plugs can be found in the windows. Overhead lighting is also provided. Double-check these before starting your decorating. **The Fair no longer has any locks to loan out to secure the window doors. You must provide your own locks to secure your window.**

The State of California, the 26th D.A.A. - Amador County Fair, their agents, directors, officers, servants, and employees are not responsible for any injuries or any damage/theft from or to the windows and the displays.

ALL MATERIALS USED IN WINDOWS MUST BE FIRE RETARDANT per the State Fire Marshal.

If you would like to be a part of the 2026 Amador County Fair, please fill out the enclosed application form, indicate which classification is needed and return it as soon as possible. **DO NOT SEND ANY MONEY with this application.** You will be notified if a window is available.
