## COMMERCIAL EXHIBITOR APPLICATION INFORMATION

The Amador County Fair will be held July 28th - July 31, 2022.

Proposed Fair hours: Thursday: 11 am to 10 pm; Friday: 11 am to 11 pm; Saturday and Sunday: 10 am to 11 p.m. Subject to change.

## BOOTHS MUST BE STAFFED DURING THE FOLLOWING HOURS:

Indoor Booths: Thurs, & Friday - 11 am to 10 pm, Sat & Sun. - 10 am to 10 pm.

Outdoor Booths: Thurs, & Friday: 11 am to 10 pm; Sat. & Sun. - 10 am to 10 pm.

It is the policy of the Board of Directors of the Amador County Fair to allow prior participants the first opportunity to commercial space rental. Contracts to last years' participants are mailed out in February and are due back by  $\underline{\text{April } 1^{\text{st}}}$ . As commercial spaces become available, Fair Management will review the new applications to fill vacancies. Upon review, new applicants will be notified of their acceptance or position on our waiting list.

Outdoor booth fees are \$586 - \$661 per 12 'x 12' location; and Indoor fees are \$536 - \$586 per 10'  $\times$  10' location for the duration of the fair. Included in the booth fee are 8 - 1 day gate passes and 1 - 4 day parking. Additional Commercial Exhibitor passes are available at the reduced rate of \$5 per person per day. Additional Commercial Exhibitor parking lot passes are available for \$15 (4- day) for the duration of the fair. RV parking spaces are available for the first 10 exhibitors at the rate of \$240 per site for the duration of the fair, (which includes one vehicle pass).

No guarantee of any hookups.

<u>ALL VENDORS MUST PROVIDE INSURANCE – A minimum of \$1,000,000 general liability per occurrence, naming the Amador County Fair as additional insured.</u> If a vendor can not provide their own, insurance for this event may be purchased through California Fairs & Services Authority (CFSA) which the Fair office will assist with this.

Electricity, within limitations, is available for each booth. If you have excessive electrical needs, please contact the Fair Office prior to submission of this Application.

If you would like to be a part of the Amador County Fair, please fill out the enclosed application and return it as soon as possible. **DO NOT SEND MONEY NOW – If you are contacted to fill a space, then the guarantee will be requested &** *must* be received prior to a contract being sent. Cancellation **Policy:** 60 days prior to fair – all but \$50; 30 days prior to fair – no refund, unless contract is filled & \$100 would be the retainer.
