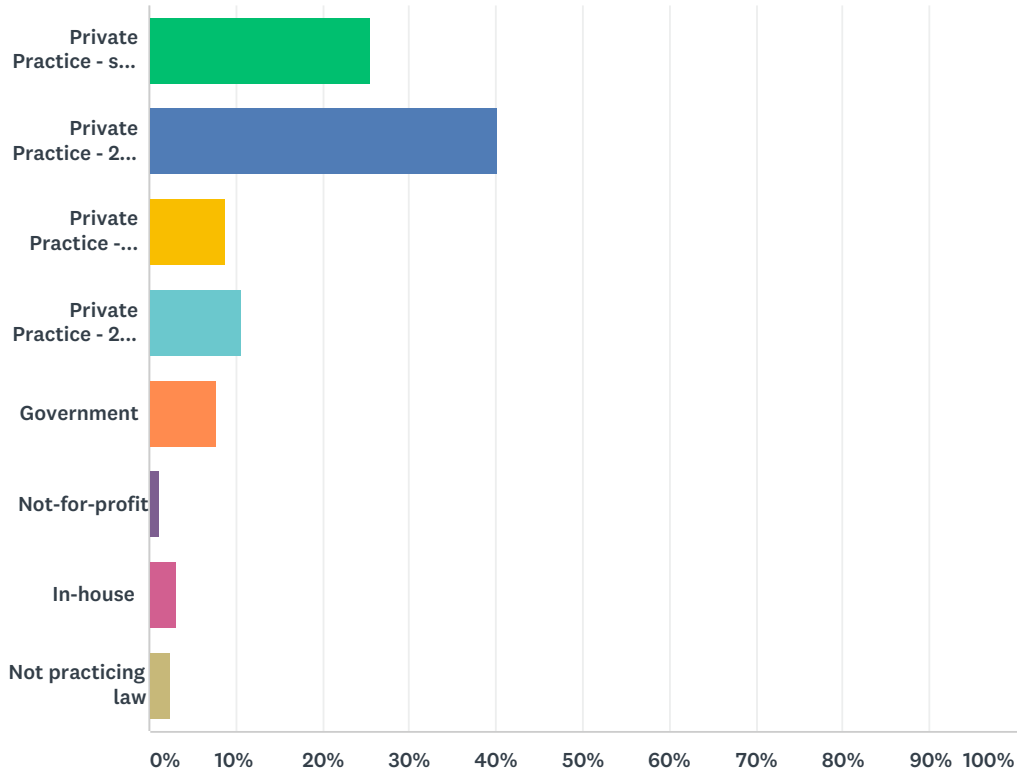


## Q1 In what type of practice do you currently work?

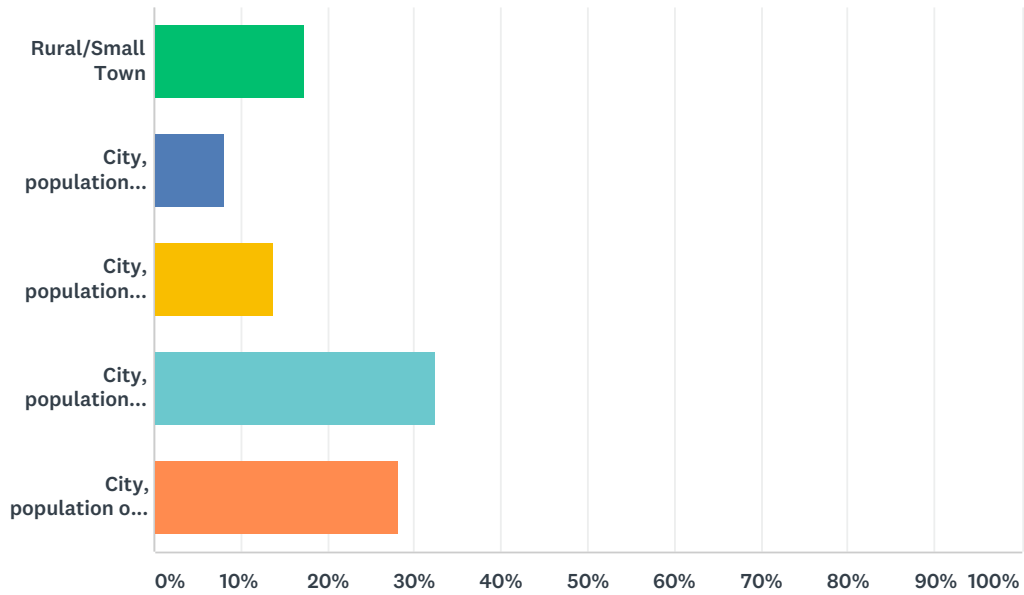

## Q2 Where do you currently work?

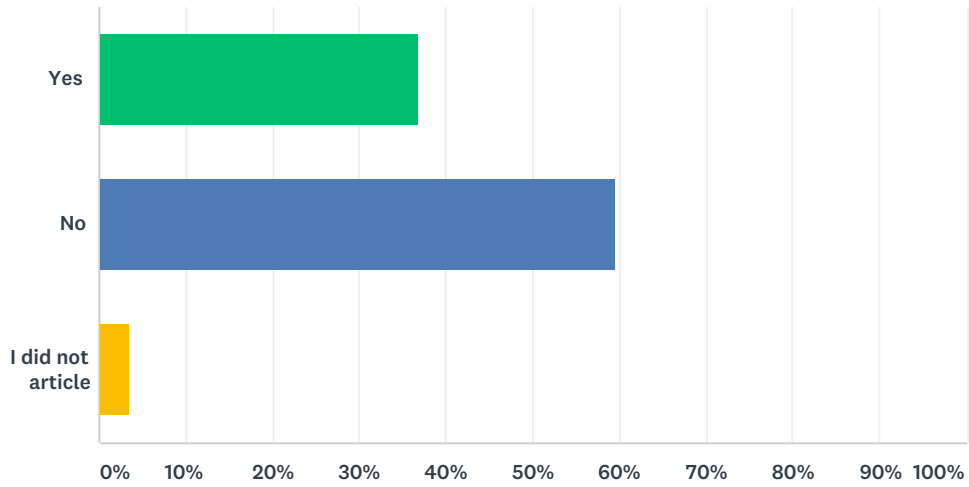

### Q3 Was your first job as an associate at the same firm where you articulated?

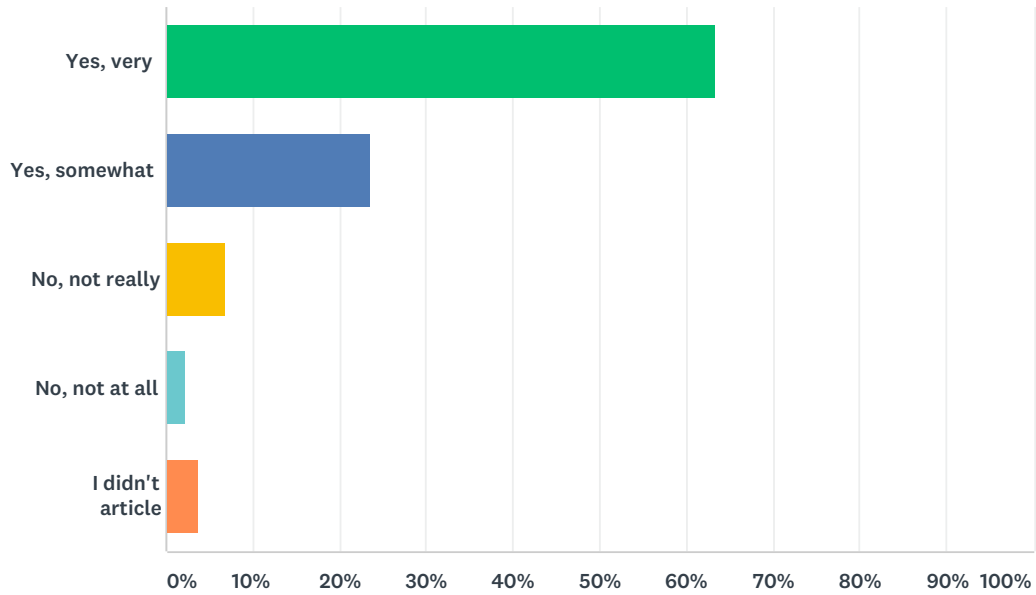

### Q4 If you articulated, was your articling experience useful in helping you to prepare for the practice of law?

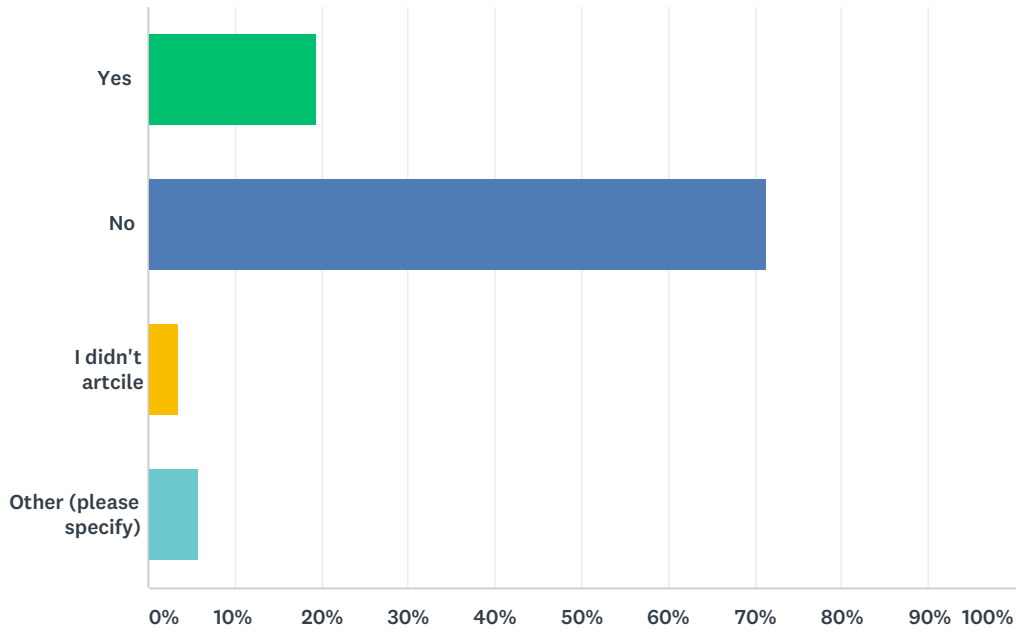

### Q5 During your articling term, did you experience harassment, bullying, or working extreme hours?

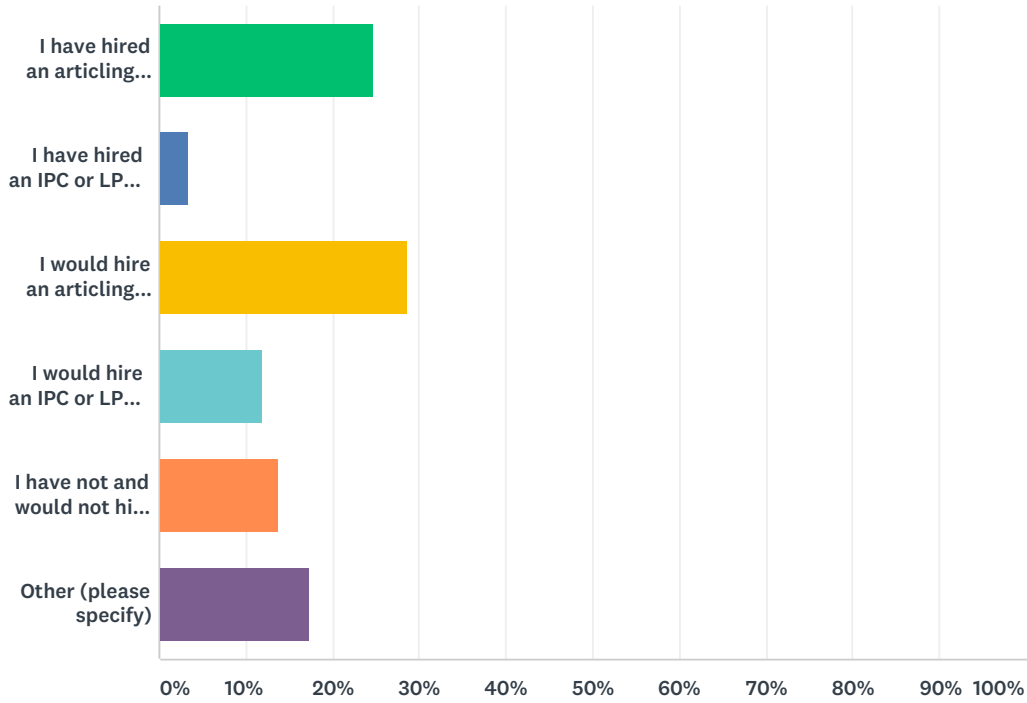

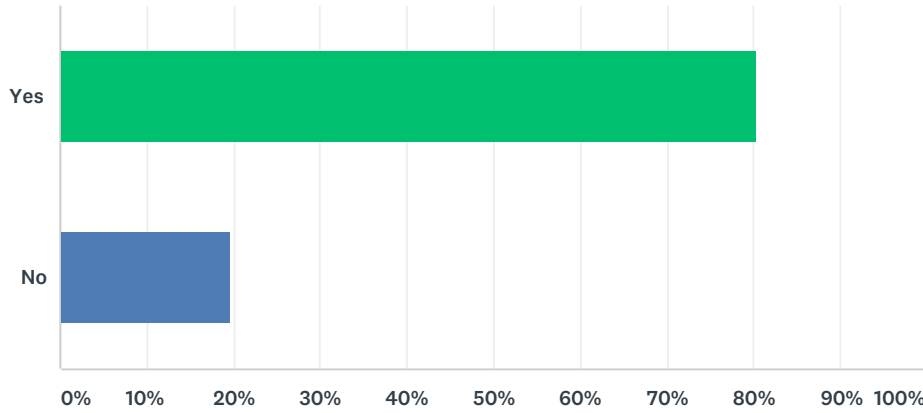

**Q7 Would you be more likely to hire an articling, IPC or LPP student, or hire additional students, if there was funding available to assist with the students' salary?**

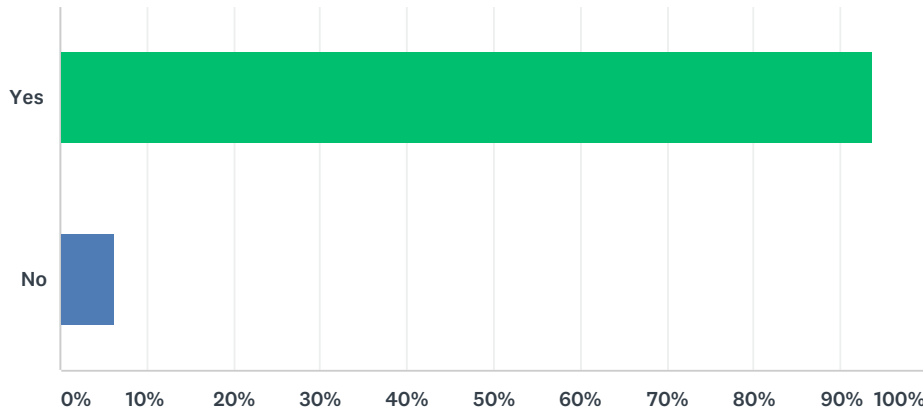

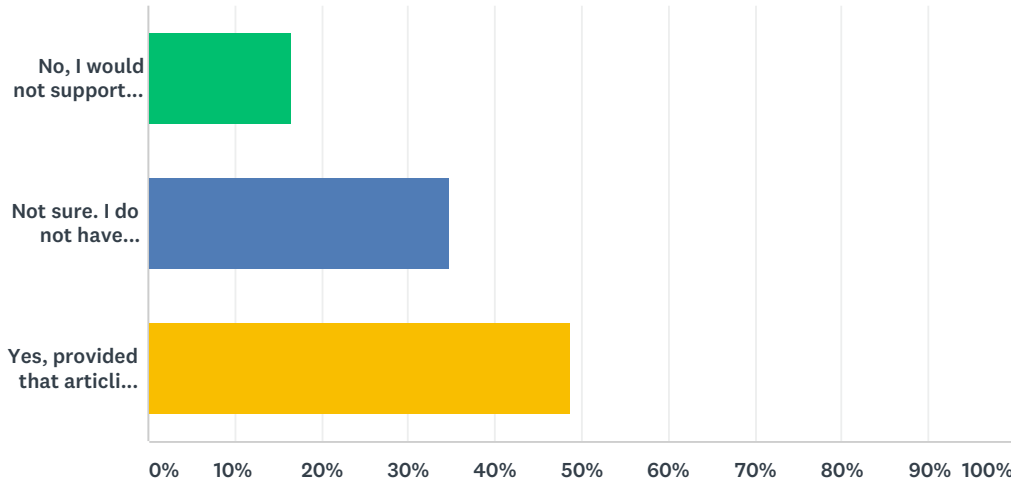

### Q9 Would you consider a licensing system in which it is mandatory for all candidates to participate in the four month LPP training program so as to ensure a minimal level of consistent practical training?

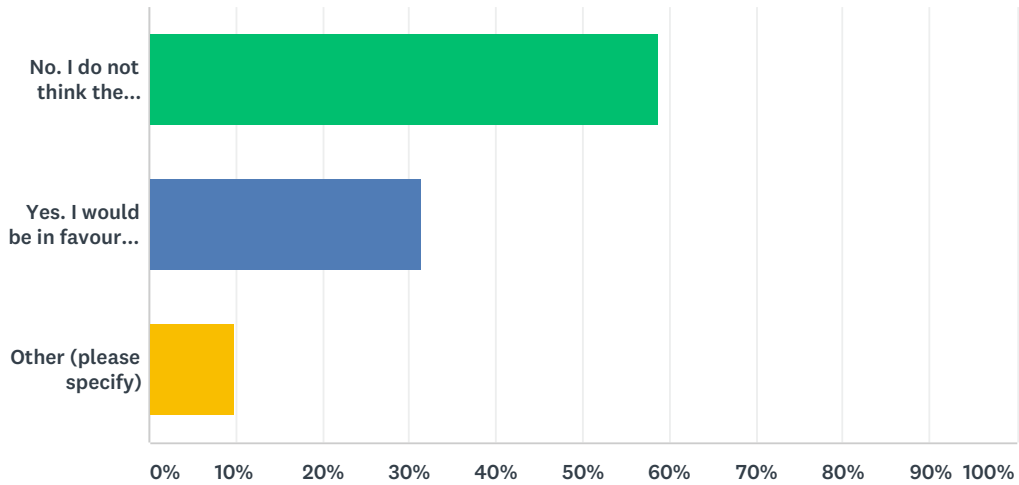

## Q10 Would you be in favour of reducing the articling term from 10 months to 6 months?

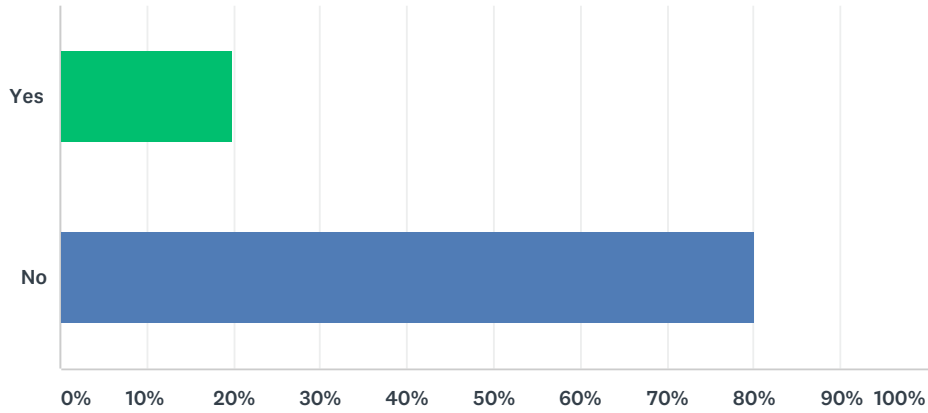

Q11 Would you be in favour of a licensing regime that granted two different types of licence: one to those who intend to provide advice to the public, and one for those who do not (ie. government employees)

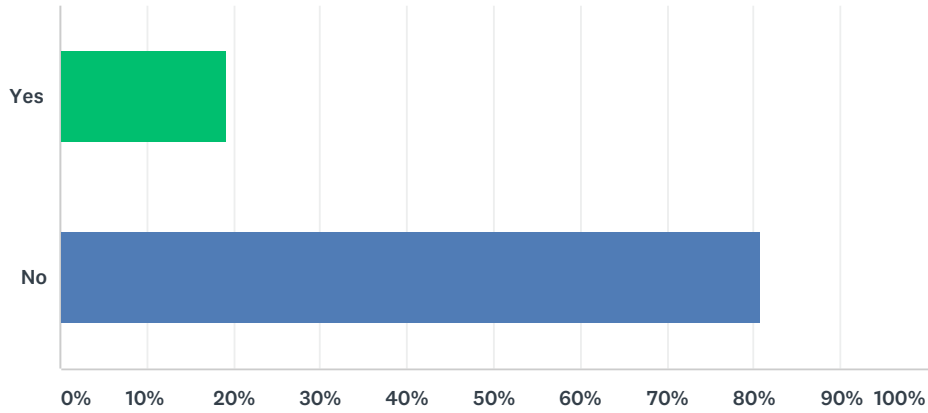
