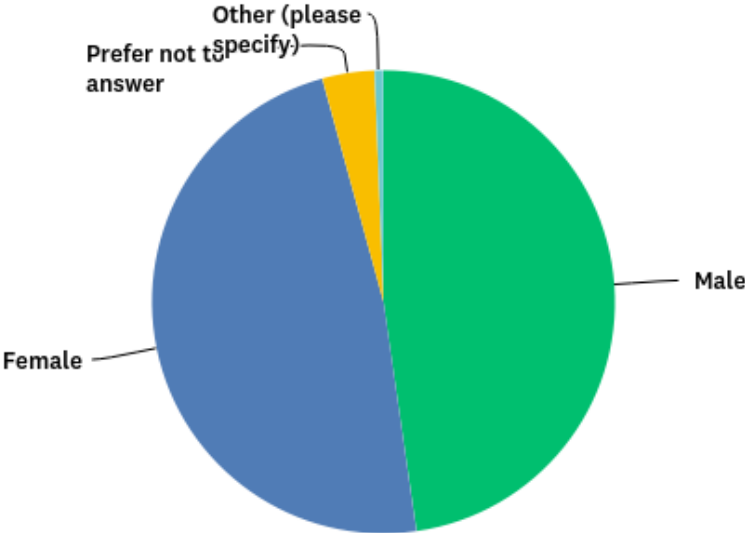

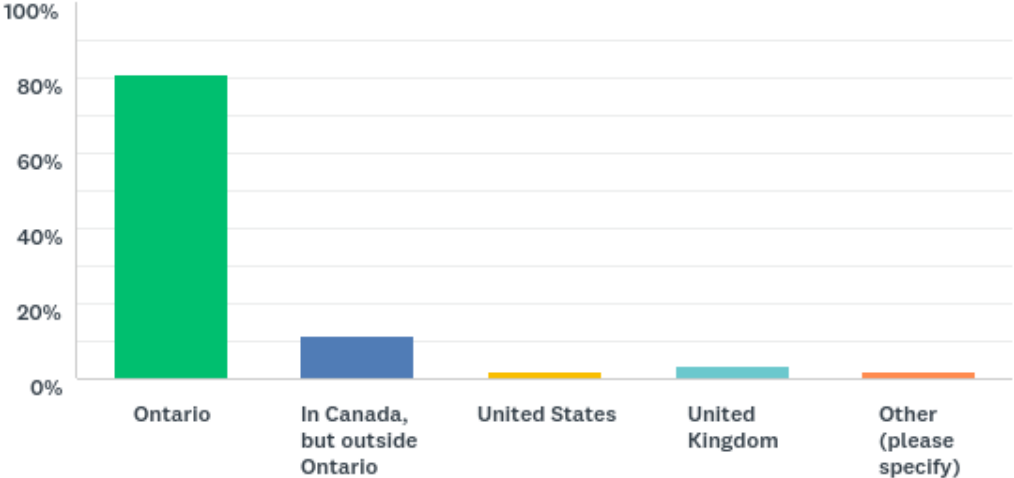

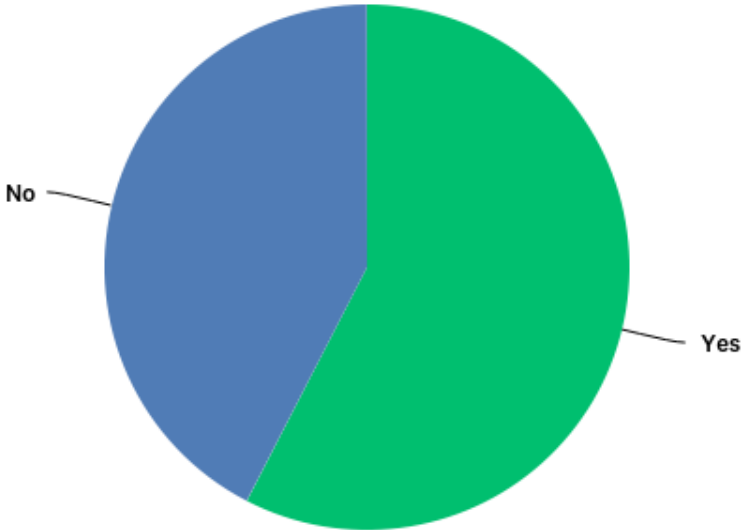


Where did you attend law school?



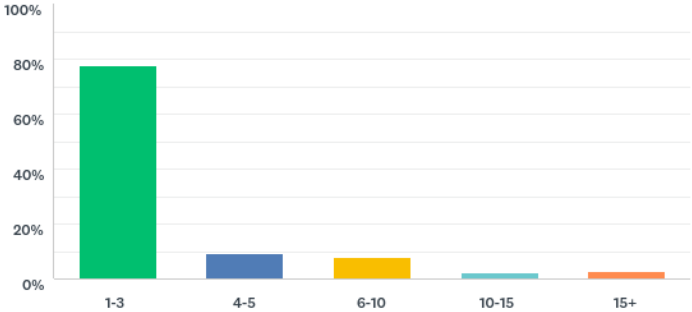

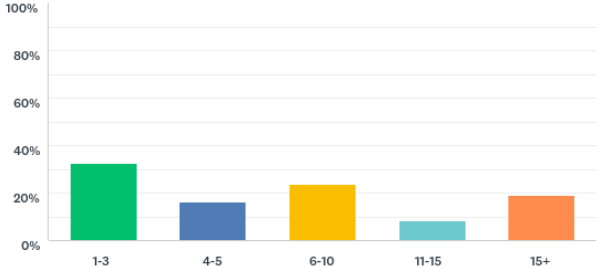
Approximately how many lawyers is your practice comprised of?

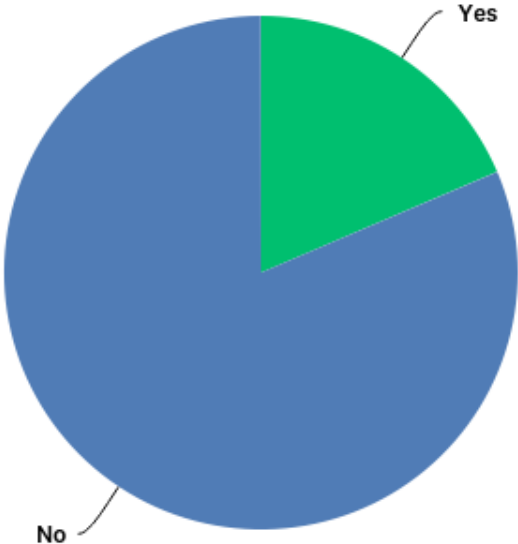

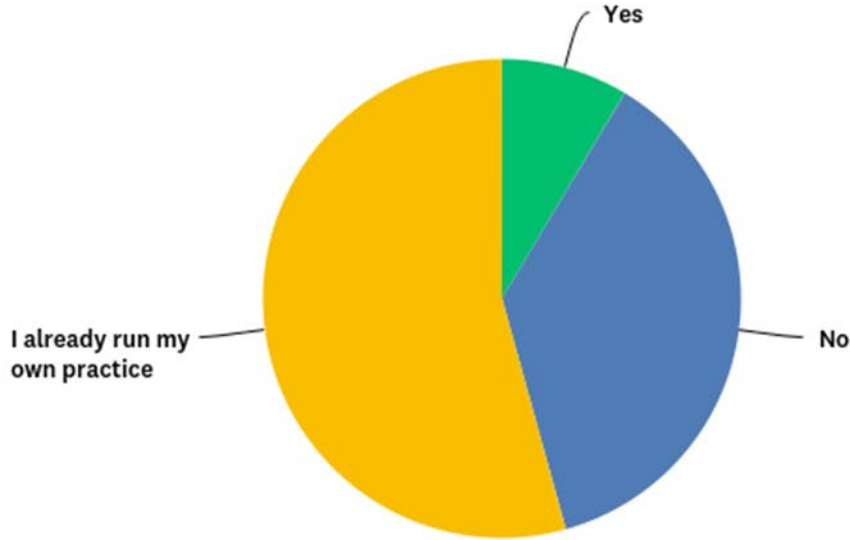
Do you plan to retire within the next 5 years?

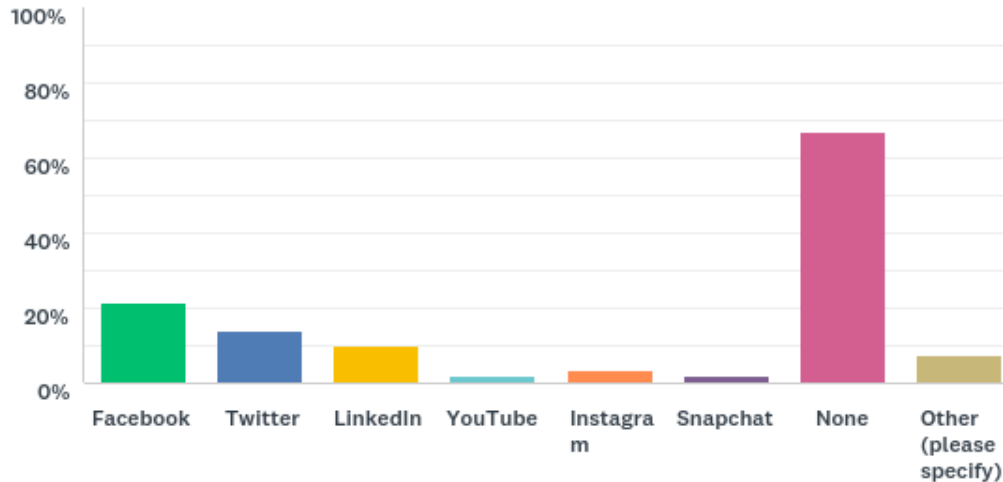


If you don't already run your own practice, do you plan on opening your own practice within the next 5 years?

In a typical week, which of the following social networking sites are you aware of that your association uses? (Please select all that apply)



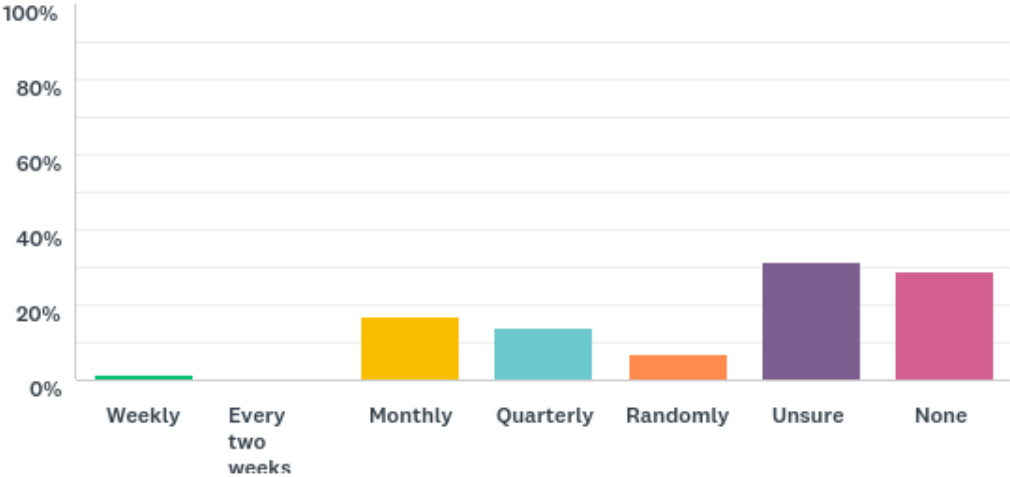

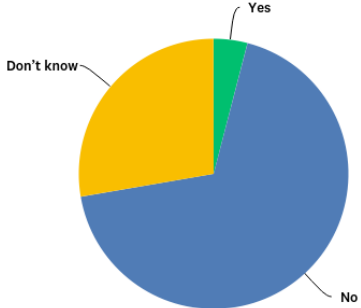

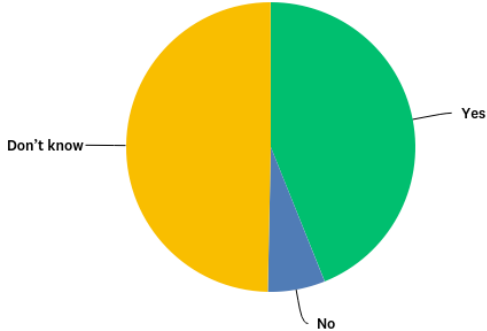

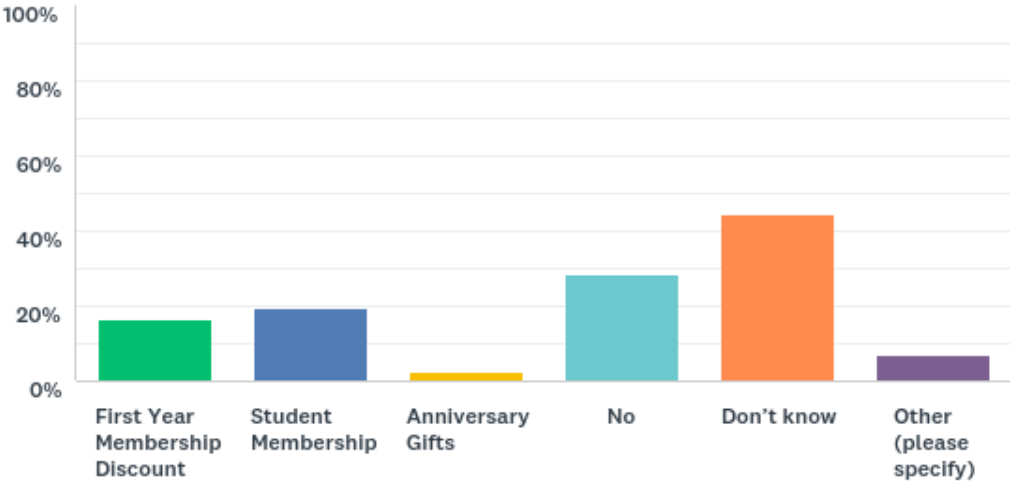

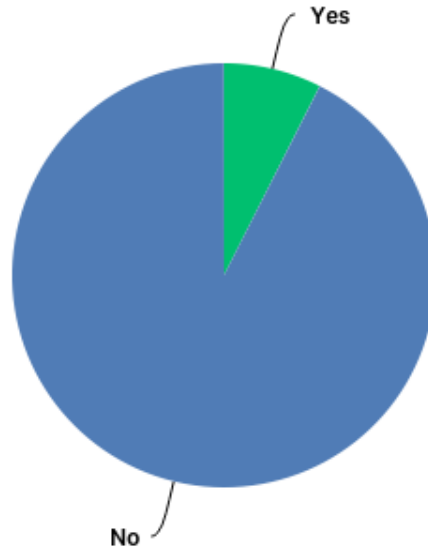
Does your association provide tangible incentives to join and/or for member renewals?

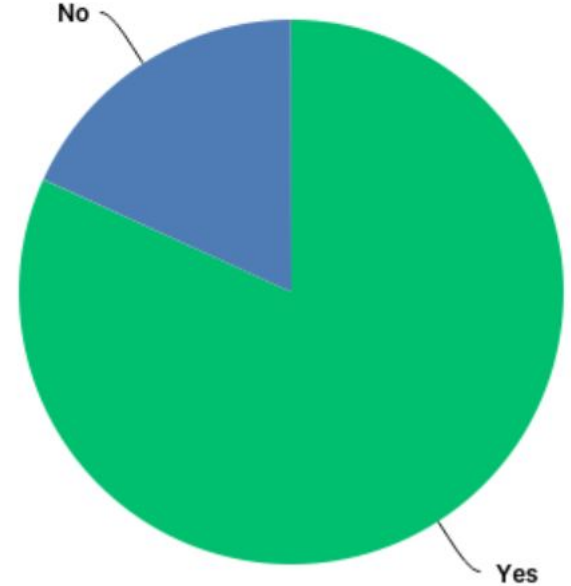
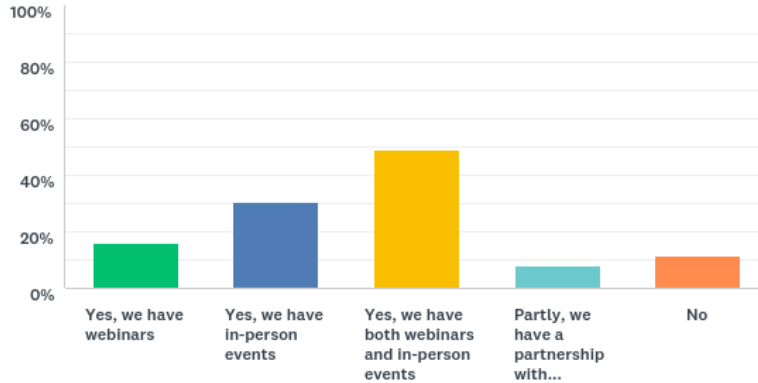

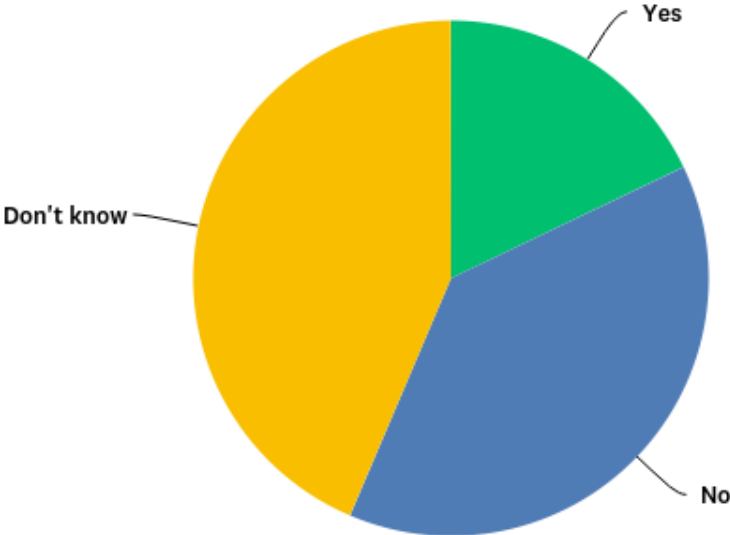
Does your association offer CPD programming? (Please select all that apply)

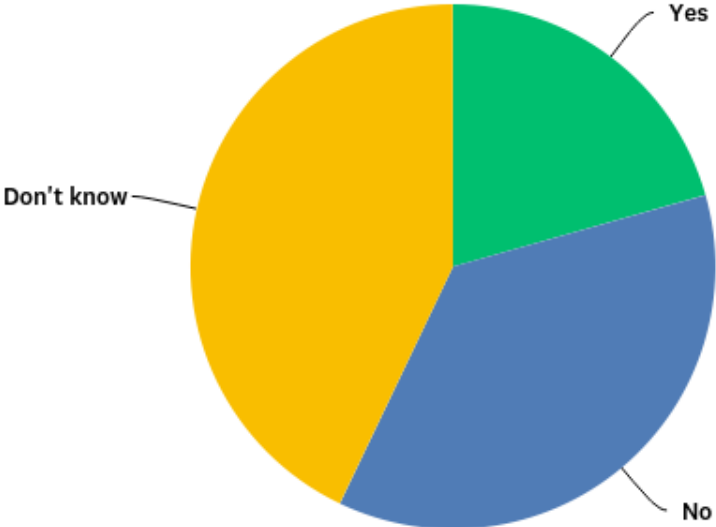

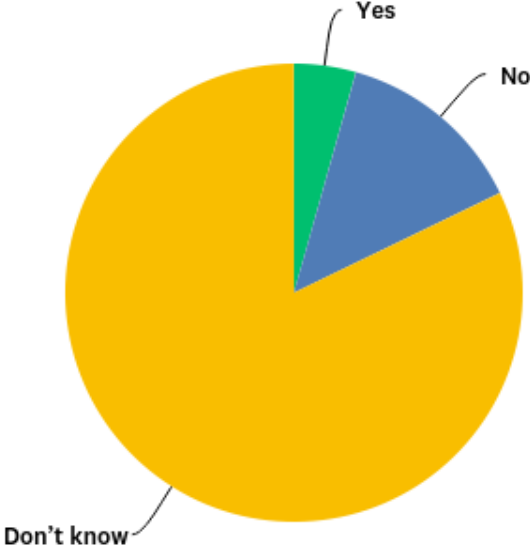

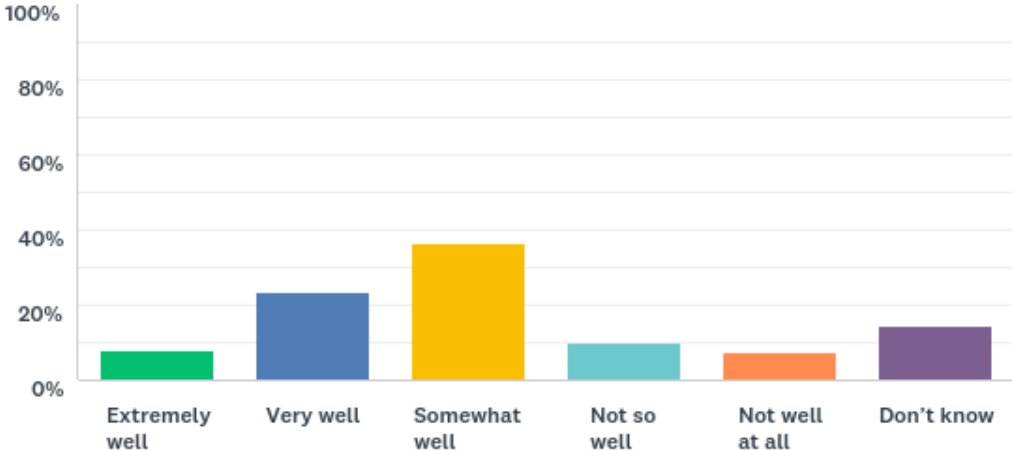

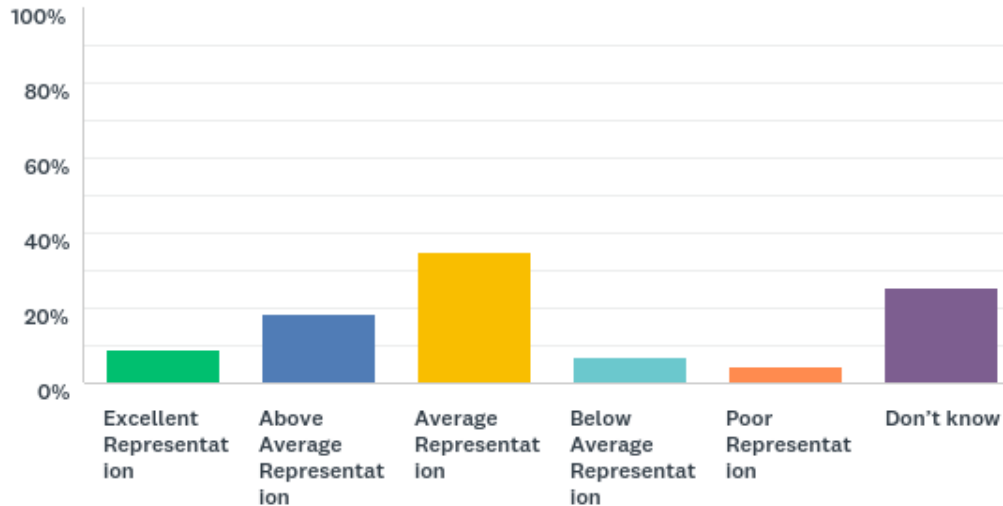


How well do you feel that your association understands your needs?



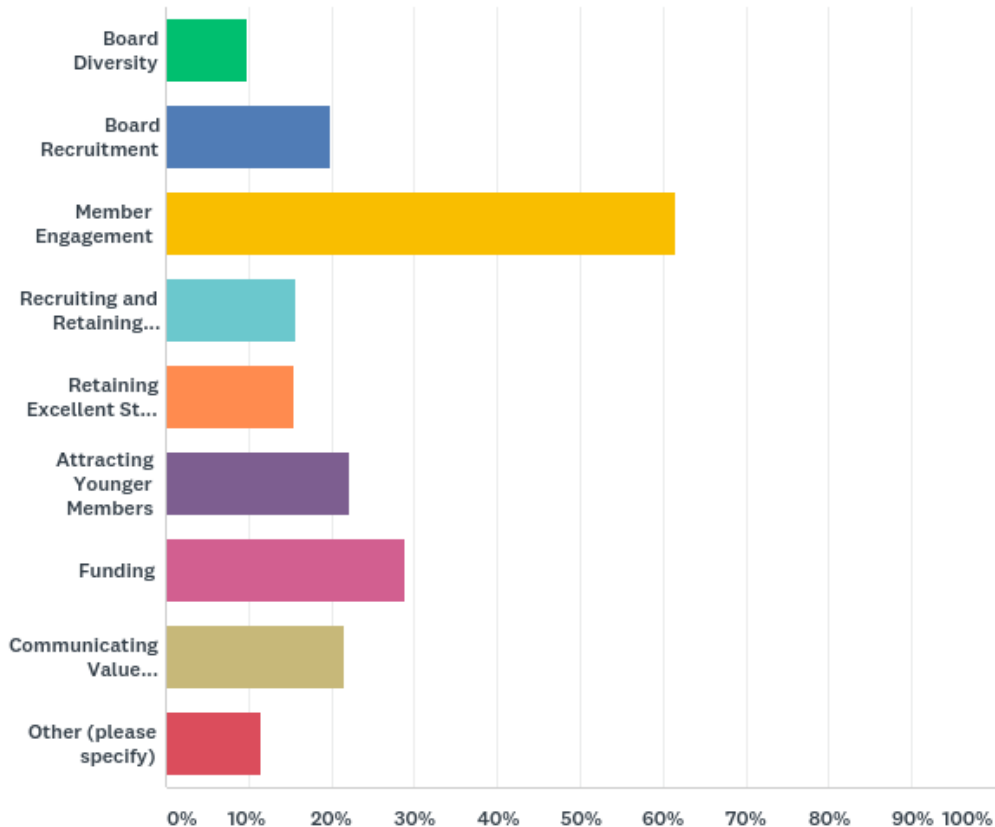

Do you think your Association's board is representative of the lawyers in the Association's geographic region/jurisdiction? (By age, gender, ethnicity, etc.)





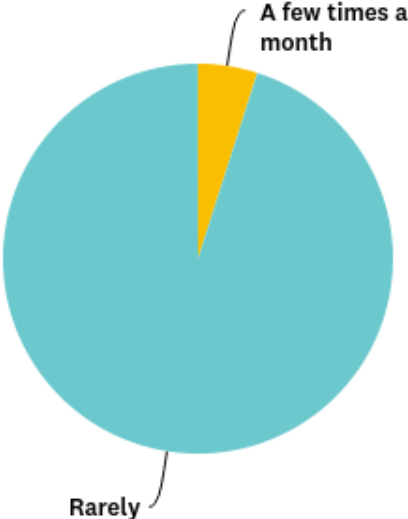
What would you say will be your organization's biggest challenge in this coming year?

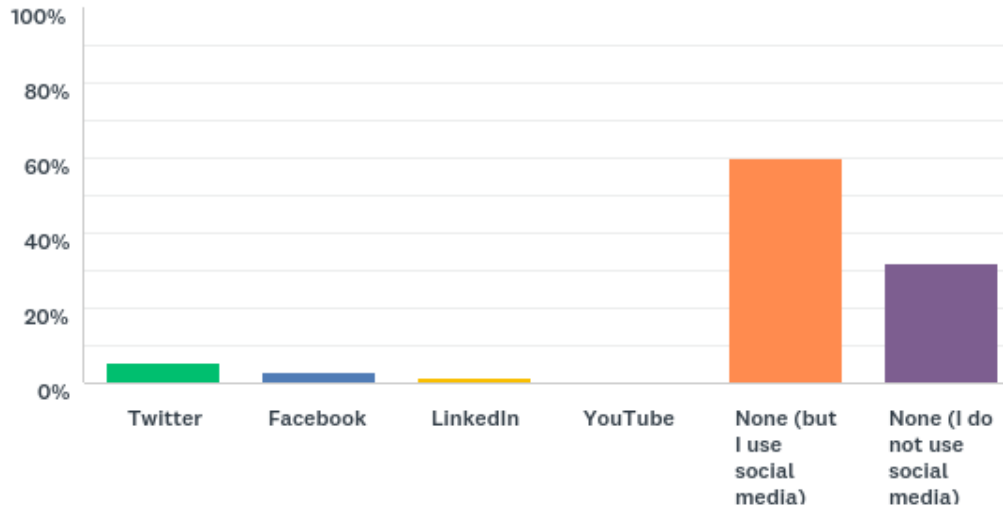

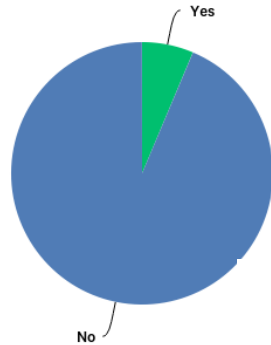

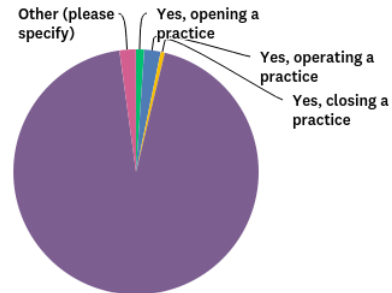

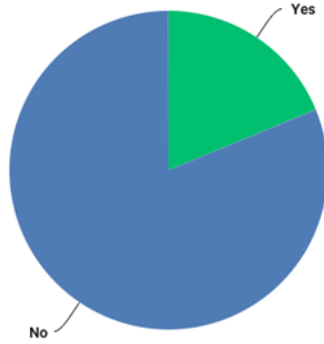
