






### What is your year of call? 989 responses


Pre-pandemic, how many days on average would you attend court in a week?









#### How do you see your library? Select all that apply.




# In those days in court, how many of those days did you require library resources? 962 responses






Have you attended the courthouse for the sole reason of library resource use?




Can you buy all of the legal resource materials required to do your job for \$182, which was the 2020 annual library cost included in your Law Society of Ontario fees?

Have you taken advantage of the off-site library resources (reading emails, visiting website for information/updates etc.)?







There continues to be an assumption that our library by nature needs to contain shelves upon shelves of paper books. The reality is, no one ever reads these books. We could easily fit the entire paper book component of our library onto a single hard drive. What is needed is access to online

resources, and computers. I have had this conversation with law library handlers many times and have pointed out that having a library full of paper books that no one ever reads, and having three old, partially obsolete computers, one of which does not even handle email, is not a good solution to the problem of a large and practice diverse Law Association's membership's day to day connectivity to resources, when you are living in the year 2021 (although it might have been in the year 1971). Having a law library system where the only understanding of a computer, is similar to Archie Bunker's understanding of the inner workings of the engine in his old Cadillac LaSalle, is not going to work. The law library computers are not magical things that must never be touched. They are for the most part old, broken down pieces of museum quality electronic equipment and the reason why they don't work right is not because you have to say the right incantation, it is because they are too old, their programming is obsolete and they need to be replaced with more modern equipment. As our court system is gradually beginning to realize that paper files, fax machines and hand delivered letter mail are all actually things that, outside of the legal profession, one only finds in museums, perhaps our law libraries could also clue into this reality, which has been in existence for at least 10 years now. Stop clinging to the distant past. Libraries contain computers, which computers have access to online legal resource databases. There is no need for shelves upon shelves of paper books. No one reads them. No one even knows how to search them anymore.

As a small and growing law firm I rely on the Norfolk Association library for its expansive collection of books to help me and my newly called to the bar associates to research the main areas of family law, criminal law, real estate, personal injury law and wills law. The cost of the books alone, including with the need for updated materials every year would be to costly to purchase. We are already covering CPDs for all the lawyers to ensure competency development but the published books provide foundation and niche information that is needed. We are 2 hours away from Toronto and would not benefit from any other libraries or their set hours. Our local library allowed 24 hour access. I used it every time I went to court and have gone just for research purposes. It provided an area where I could focus on research and when other local lawyers were present I was able to bounce ideas off from them. The librarian's emails keeping the association up to date on upcoming events, COVID protocols, surveys, and discussions with the local bar. I have had aid from the librarian in my research and have even recommended titles that my firm and others would have interest in. I have purchased some of my own materials but this can not replace the books I regularly take from the library. Family law touches on so many various areas of law alone and to be restricted to what I can afford would hurt my practice and limit my knowledge base. The local law library is a heavily used resource in our area and many of the local lawyers, predominantly the solo or small practice use it and would struggle without it.

I am a firm believer in access to justice, so much so, my practice is comprised only of non cash based clients. I can only continue to do this provided my operating costs do not increase. Purchasing all the necessary books, subscribing to on-line services such as The Lawyer's Daily, Heinonline, Quicklaw, Westlaw, etc., is not possible unless I change my client base - that is not something I want to do. My work gives me a great feeling of satisfaction and accomplishment because I know that I am helping those in most need. Judith from Hastings and Prince Edward Law Association is an absolute gem in assisting me find articles (weekly) and text when needed. She is like a bull dog in her persistence in finding exactly what I am looking for. If I were to lose her services and/or the Library, my practice would suffer as well as those in need of my services. Aside from using the library as a source for articles and books, it is a most desired place to bounce ideas off of other counsel, keep connected with the local legal community, make connections with out of the area counsel, and in general, have some place to go to seek help when the answer is difficult to find/determine. The Law Association also offer CPD at a reasonable price - again, without the Association, my practice will have to change to far fewer financially assisted clients and more cash clients. I love my work and those that I assist; if I were in it only for an income, my client base would be very different and my work would likely be far less satisfying.

My librarian is my go to for research. My small firm cannot afford the resources that are available at the library, nor can my clients afford to pay me to do much of the research. The library is useful when I am in court and need to draft/ print materials for the court. Our librarian assists on a daily basis. Counsel would be lost without her. The library is great for CPD, we put on great programs. The library is a place for counsel to gather, share experiences, debrief with each other after a hard day. We are all missing this and our mental health is suffering. The MAP sounds like a great program, but unless you have an addiction the services are not great. It does not cover our chosen service providers, and it is not easily navigated. Seeing other lawyers face to face all the time, socializing, working together increases competency, mental health and collegiality. All of these are essential. Our association runs many important programs, including a mentoring program for young lawyers, a young lawyers social series, including an annual night with the bench. We recently launched a reverse mentoring program for our young lawyers to mentor senior members on how to navigate all of the new technology. None of this would be possible without our libraries. Paralegals are an increasing presence. Some libraries allow them to use the libraries, our policy is that if they work for a firm they have access. Perhaps adding the library levy to the paralegal's fees would help bridge the gap in funding?

I am a litigator, but I don't have the resources in-office to fulfill all of my needs when it comes to research. And frankly, although some online tools like Canlii are good, and I find these useful, I often find myself turning to texts, old case law books and the like. This is especially true when dealing with a unique or obscure area of the law. I would also note that our courts' law libraries are more than just a repository of this profession's collective knowledge, collected over the past several centuries - my experience is that our law libraries are hubs for the day-to-day activities of the courthouse. They serve as a meeting place, and discussion space, and I do not think that can be replicated in the online world. I know it is now trendy and "cutting edge" to be fully online/digital, but we often forget that humans are analog, material, tactile-seeking, social beings. Much would be lost without our libraries - and I would strongly caution against running headlong "into the future". Libraries have been the hallmark of civilized and progressive Peoples, dating back well before the founding of Alexandria in the 3rd century BC - we should therefore be very cautious about moving away from the institution that has served humankind so well, and so faithfully, these past 2000+ years.

I attend the law library to do very specific research and to have the law librarian there available to assist me or to teach me in finding what I am seeking. Nothing is better than reviewing the materials yourself as you sift through to find what you need but assistance is often required in such research as it is varied in topic and in time. As a real estate lawyer, I am often digging back in time to determine the law existing at a particular historical point in time (for example, when a conveyance of land was made) but I am just as often looking at current materials. The research techniques and tips differ a great deal depending upon the nature of the research and the law librarian is essential and gives great tips and suggestions. The law library is a great source of continuing professional education as well and a place where meaningful discussions between colleagues can take place. At times it is a place for a "mental health break" - a place to quietly read or review materials before going to court or during a break in proceedings, or to review documents before they are filed with the court, or to share experiences with colleagues, or to learn of upcoming events and continuing education opportunities, etc.

The Library is the centre of our law association. It is used regularly by the vast majority of our membership. I use it regularly for legal research, I use the services of our librarian regularly for those days when I am not in the courthouse, and it is a central gathering place for discussions about the law. It also the place where the lawyers in our association meet to socialize and support each other. It is one of the reasons our association is so congenial. The services available at our local library are invaluable to me and my practice. We are a small firm of two lawyers and we practice in a general practice with multiple areas of law. To purchase all of the legal texts associated with all of our areas of practice

would bankrupt our firm, there is no way we could afford these publications on our own. Our clients rely on us having the knowledge to assist them at a price-point that is reasonable for the area where we reside. Our clients cannot afford large firm prices and we cannot afford the libraries that large firms have in-house. Access to justice and legal services in smaller centres relies on there being a robust library available and a librarian to assist in our research needs.

Although the predominant number of files in my office relate to real estate because of the years of assisting clients with their real estate matters I am finding that the estate component is becoming more time consuming than the real estate. To provide the appropriate resolution of the disposition of estate monies I find that without the law library I would be in difficulty. The law library provides the most recent up to date information of the court decisions and legislatures in that area of law. That would mean that I would not be comfortable advising the clients that I have acted for over the years and in my opinion their best interest would not be able to be provided by me. Being aware of their background and their family history I believe that I am best able to advise them as to the allocation of their estate and who should be in charge after their passing. But it would also mean that a significant part of my practice would be lost and in my opinion the best interests of my clients would not be attained. The library is essential to my continuing my practice in the area of wills and estates.

The local librarian has set aside books and CPD materials for my use, and has also helped me locate useful precedents for preparing share and/or asset Agreements. My retiring partner used the library for resources on how to sell his practice/retire. I was unable to utilize the library as often during the pandemic as I have personally tried to limit my visits to any location that was not my home or office - I was also not working full-time in 2020 due to the birth of my second daughter. I miss the ToolBox (I think it was called) that gave me access to more online sources through the library that had been available during my articles and when I was first called to the bar in 2012. I will order text books for my own personal use but many law texts cost close to \$200 or more and if I find them not to be useful for my specific practice it feels like a waste of money. I like the ability to request books from my local law library so that I can complete research for clients, and update my personal knowledge on topics that are ancillary to my practice but affect advice I provide to my clients.

The written resources available are organized in a user-friendly manner which enables a quick review of the most current law, all in one place. The materials can be photocopied there as well and the librarian is very knowledgeable in terms of what is available. She will also obtain copies of cases/texts that aren't locally available. There are also textbooks on almost every area of law which are very useful as a starting point for research as they provide summaries of the law and its sources which aren't easily accessible online. There are also various precedents available as well as all of the cpd binders which provide a current summary of the law. Once at the library, I can usually find and peruse a relevant resource easily and quickly - every visit there is fruitful and it would be greatly missed as a research resource. More importantly, we need a centralized hub with a "secretary" who communicates with all of us and allows us to communicate with announcements, requests etc. among ourselves and also a place to share/mentor/discuss issues, files, judges, etc. while at the courthouse.

The Hamilton Law Association Library provides so many resources that have positively contributed to my practice. I have and continue to rely on library resources and services including books, periodicals, online databases, research assistance and educational/CPD programs. The staff is extremely knowledgeable, patient and always happy to help lawyers no matter how trivial the question. The HLA Library is an invaluable resource for articling students and over the years, I have often heard from our students that the library staff has played such an important role in their articling experience. Throughout the pandemic, the HLA Library was in constant communication with its members through e-mail and provided updates and information about changes to court/filing procedures and practice directions. I cannot imagine what it must have been like for lawyers that did not have the benefit of an Association like the HLA Library helping them navigate the ever changing practice directions especially since, in my opinion, the Law Society did not take on that role.

Our library is vital in a rural area where there are no large firms, and no other way to pool resources to get the necessary resources. Pre pandemic it was always busy. It was also the primary location for negotations during court and to prepare Minutes. In Grey and Bruce counties the courthouses have no cafeteria, and no nearby food source, so counsel generally took lunch together in the library and would discuss cases, either that day's or upcoming. Since the pandemic, I have heard from many counsel that the loss of that social support has impacted their mental health. The library not only allows us to access legal resources, it allows us to discuss what we have learned with colleagues. Many times junior counsel have been in the midst of heated negotiations only to have senior, uninvolved, counsel weigh in or pass them a case that affects their

position. It also allows us to attend CPD programs together, not only for a lower cost than individual registrations, but also with the benefits of colleagues to discuss matters with.

As a small rural firm, we could not offer the same level of service nor attain the same level of competence without access to our Association library. Our librarian assists with research requests promptly and exceptionally well, and we are able to conduct our own research due to the resources available at the library which we could never possibly afford to purchase ourselves. A significant majority of our work is to legally aided and low-income families, domestic violence survivors without access to funds until well into court proceedings, and others who cannot afford to pay the fees we would need to charge in order to obtain the sorts of resources available through the library. Our Association library is absolutely fundamental to the ability of our firm and many firms like ours in the Association to provide access to justice to the families we serve. Failure to adequately fund libraries is actively deciding to make justice inaccessible to the majority of the Ontario population.

While I am rarely at the Superior courthouse I use the library relatively often as it has many excellent resources that I can not access elsewhere and that are far to expensive for my practise. I am a sole practitioner and do not have access to some large Bay street firm library as is the case for many people practicing outside of Toronto or Ottawa. I depend on the library for access to Quicklaw, Hein Online and other subscription services. I do research for other lawyers and would not do so without the library supports. Much of the caselaw I use is not available on CanIII and I could not access without the library's online resources. It is also my only connection to many local colleagues who practice in other areas of law than I do. It provides a very important communal component that allows me to competently refer my clients to practitioners in other areas and to work together with them to solve client problems that involve more than one area of law.

The Association Library was perfect for drafting documents on the fly when attending court including drafting orders and consent agreements. The library books and computers available assisted me in researching cases to use in factums and the librarian was a great resource in assisting me in where to look online to find cases to assist me in my endeavors. I found the library to be a hub to network and meet other lawyers and allowed me to find amazing mentors who have helped me to this day. I also found the association put on some great CPD programs which were provided at a low cost. My clients benefited from this resource as we were able to save time and money by drafting at the court and putting the parties' agreement(s) into writing before leaving the courthouse, by saving me time in drafting their factums and researching and by my continued education and learning provided by the association.

1 response

Having the Librarians, Actual books and online resources is invaluable. I practice in a specialized field that no one else does in the region. The librarians continue to assist me- especially with direction on research and finding legal information both in person and online. Having the books available in the library is also helpful since it allows you to research and find information that the online sources don't. Lastly, online services are also invaluable since they are so expensive and otherwise a small firm/sole practitioner cannot really afford it. Further, during COVID the Librarians have been amazing with providing information and guidance. It is the only legal community resource and acts as a true community. The support of the library is critical to a small practice. Our small firm of 3 lawyers uses the services frequently.

1 response

The Toronto Lawyers Association Library provides an essential service that all libraries provide - it is a community hub. It is a space for law students, paralegals and lawyers, not matter where they are in their career to research, share expertise, and forge community. Libraries are indispensable. They provide access to curated materials and knowledge that would otherwise be impossible to access as an individual or a small group of people. Further, having a physical library to attend in the core of Toronto means there is always a quiet place to research, write or ponder - all essential parts of a legal practice. The physical space that the library provides is extremely important in creating a sense of community for lawyers. It means that there is a space for you, irrespective of how much money you have as a legal professional.

The TBLA library is a hub of activity. I can always go there and do research or look for drafting resources. I can pick the brain of our law librarian or any of the other more senior counsel who happen to be there at the time. I can research an issue quickly and efficiently at our library. If our library does not have the resource I'm looking for our law librarian can order it for me from one of the other Law Associations. There is absolutely no way I would be able to afford the required subscriptions etc to be a competent lawyer if I had to pay for them myself. Research would also take me substantially longer if I had to order everything from Toronto. The geographic distance from Thunder Bay to Toronto is HUGE. Without our library in Thunder Bay I do not believe I would be able to maintain my competence.

1 response

The library is an invaluable part of the local bar. The practice of law can be very isolating, especially in a small community where there are a high number of sole practitioners and small partnerships. Law libraries provide more than simple access to legal information. it provides a community where lawyers discuss, chat, share, laugh and argue. It is a healthy and vibrant village. We need libraries for the law related resources they provide, which would often times be prohibitively expensive for small firms to procure. But we also need libraries to build our social network, our legal community and our collegial relationships. I believe that the loss or erosion of this community would directly effect clients by increasing the likelihood of litigation and prolonging court cases generally.

1 response

Our Librarian, on a daily basis, distributes information to keep us up to date, and helps with will searches in addition to her regular duties of keeping library resources up to date, helping to find resources and answers, and organizing CPD programs. During the Covid year, this has been more important than ever. We have been discouraged from attending the Court House for any reason, including the Library. I miss it. I expect to be back, to enjoy flipping pages, and "bumping into others" to exchange ideas, and to ask and be asked questions. It's amazing how positive an influence casual, serendipitous contact and conversation are. It is depressing to notice how easy it is to shut yourself off from personal contact with other lawyers; who else could possibly understand our gripes?

Pre-pandemic I would use the library daily. The Library is essential for research that is required during a hearing. I represent clients mainly through Legal Aid Ontario and access to resources through the library is my main source of research. I use printed material and electronic subscriptions the library offers. The London Criminal Lawyers' Association uses the library to hold CPD programs. In addition, information sessions from community organizations are regularly set up in the library area. The library provides a private place to work while at court, without police or crown access (very little crown access). It is not feasible to return to the office each time some work or preparation needs to be done during a day at court (even though my office is only 2 blocks away)

1 response

I am a paralegal member of the Halton County Law Association and I pay the Library fee. HCL was probably the first law association to accept paralegals as members. At present the LSO does not require paralegals to pay the library fee, yet we are equal members of the LSO. There are in excess of 9000 paralegals. If the LSO charged them half of what they charge lawyer members that would work out to an increase of over \$800,000.00 of NEW money for Libraries. What could you do with an extra \$800,000.00? FYI - I also attend the OCJ in Brampton where paralegals are banned from the Library even though I have paid the fee. I have been told if I attempt to access the Library the police will be called! Isn't being an equal member of the LSO a wonderful thing????

1 response

I think my input is important. I have been a full member of the Hamilton Law Association for 45 years. Each year at the annual meeting, I always second something, so I show up in the minutes. And I joke that is the extent of my involvement with the administration of the association. I love the HLA, every part of it. It is crucial to me being a lawyer. My wife made me move to Simcoe. The first thing I did was join the NLA, my wife was not happy with the cost. I do not care. [Please do not tell her I said that] But for Covid, I would be at the library almost every weekend, and I have the advantage of the HLA. I am angry as hell over the closing of the registry [LT] offices. This would be far worse. Thank you. James W. Orme.

It is central to the fabric of the legal community in the County, and the law libraries across the province are the hubs connecting lawyers from all cities. I practiced litigation for 17 years in Superior Courts in almost every County; libraries provided space to work remotely between Court appearances, crucial research facilities for issues arising during trials and motions, and assistance from library staff and members of the local bar. Gatherings and chance meetings gave rise to friendships, networking opportunities and encouraged civility and collegiality amongst learned colleagues. Although transformation to reflect new technology is important, loss of the physical library space would undermine the collective strength of the bar.

1 response

The Durham Region Law Association ("DRLA") sends daily emails with new information about Court procedure and updates to the legal profession. I get almost all of my announcements and notices to the profession from the DLRA. I'm able to quickly get up to speed and do not have to hunt for this information. I book all of my CPD training through the DRLA. I feel more connected with my local legal community. The DRLA connected me to a mentor who I meet with monthly to talk about law practice. I moved to Ontario from Alberta in 2020 and was called to the Bar in Ontario May 2020. I was previously called to the Bar in Alberta in July 2013. The DRLA has been invaluable for me new to Ontario.

1 response

The resource staff assists me in obtaining / accessing materials from the Great Law Library, and enables us to have group watching of Continuing Education materials and presentations. From time to time such staff provides guidance as to available legal research materials, and assists me in locating same. When at Court the Library, and the Library staff assists by having the computers available for use in the Law Library, and the photocopier is accessible at the Law Library to enable revisions, corrections and printing of the documents when a draft Order or document needs to be prepared on site to advance or finalize a Court Order, or other document.

It is extremely beneficial to have access to the books, particularly annotated statutes. The library is able to update the books as new updates come out. We have a small firm and the cost of obtaining the resources we use from the library each year would far exceed \$5000. The library is extremely beneficial to help us access the resources we require to research and be able to properly advance the clients claims. Additionally, with the library we are often able to find what we need right away, which cuts research time when wading through long court decisions that may not be relevant. The library is fundamental to allow us to do our jobs as lawyers.

1 response

Now that I no longer work for a large firm with its own firm-library, the association library is the only place I can get lots of secondary source material. When I was practicing civil litigation, the libraries were critical - both as a quite place to do last-minute preparation before court, and - which happened more than once - when a judge would have a question I would run to the library on the lunch break and perform some frantic legal research and print out materials for the evening. It is somewhere to collect yourself other than the hallway, especially if travelling to an out of town courthouse. Every major courthouse should have a library.

1 response

Our I law library has been a vital source of support for counsel even during the pandemic. I have received support for CPD which, during normal times is provided at the library, but during the pandemic has been provided by the library for use elsewhere. As well I have received case law required for court submissions and researched by the librarians. Also, I have worked with one of the staff in support of a project pertinent to the OCJ Robes Display complied by Justice Douglas Phillips. Our law library is a support which assists counsel to provide their best service to their clients, the community and the justice system as a whole. We need it!

Our library is a community hub for our lawyers. We use the space regularly between Court matters to engage in settlement discussion, complete settlement documents, discuss cases with our peers, and as a young lawyer I learned more from that type of interaction than most other things I did. Our association is close and collegial, largely due to that space and our librarian, Barb. As a newer call I rely more on online resources than print but without those interactions in the library I would not have the competency I do. Our library also arranges and hosts CPD which as a practicioner in a small firm is invaluable.

1 response

The Library and the Librarian are invaluable resources for myself and the younger lawyers that I supervise. the library provides a place to research legal questions when on breaks from court, especially in Trial situations. The Librarian is a valuable source of information and connection to legal literature both on site and through the Great Library. This is especially true for the younger lawyers I supervise. They benefit from the presence of the library and the librarian which is a great service to their clients and saves the clients money. It provides a quiet space to prepare legal work especially if out of town.

1 response

Having been in two different law associations in two different areas of the province during my years of practice, I think the law library is always the hub of our association. We have meetings, but the law library is where the day to day interaction of counsel happens on a regular basis. This may have temporarily changed due to Covid, but the law libraries are still vital to many lawyers, especially sole practitioners, for resources, and to the bar as a whole for collegiality and competence. Having a space to prepare, to converse, to research, to gather is essential, and it would be a travesty to take that away.

When I cannot find materials or the materials I am able to find are insufficient I often look to the law library for assistance in finding those materials. They are able to scan pages and email them to me. Some times they make suggestions which are very helpful. They are always available and do a great job in locating the information I am looking for (and it is often urgent and they are able to provide me with the information quickly). They also have online resources available which i use often. The number of materials both online and physically in the law library would cost too much to purchase on my own.

1 response

The library is indispensable to my work. I work with law students at two legal clinics and each semester, I take them on a tour of the library. After many years of practice, I have relied heavily on the law library. I now teach law students at the law school - but I still go to the library (in non-Covid times) to do work there. I find it crucial to maintain connections to the local bar, I have hosted community focus groups there, and I have participated in events at the law library. I find it an essential aspect of my work. Online tools do not replace the importance of physical space and connection!

1 response

I could not practice without the assistance of our excellent library staff. When I started practicing in Renfrew County, the Library was an invaluable hub to connect with other members of the Bar. I was made to feel very welcome, invited to participate in social and professional gatherings and quickly felt like I was a member of the community. 20 years later, my feelings have not changed. The library and the staff are invaluable when a quick legal answer is needed, as well as providing access to materials I might not otherwise look at. They work long and hard, and are largely unsung heroes.

We are a small law firm and it is not economical to pay the cost of numerous subscriptions and resources. The Association Library has numerous resource materials which our firm borrows on a regular basis. Hard copies of the materials are more accessible and user friendly. Hard copies of materials last for many years and can be regularly and frequently borrowed. There was a group requirement for CPD hours, and my firm required the services of the Law Library to attend on group CPD programs. The library staff here is extremely helpful as a resource person to assist lawyers in many areas.

1 response

It is an integral part of the practice of law in any courthouse. It offers critical space to prepare, regroup, and access resources, particularly in the field of criminal defence. The crown has resources at the courthouse as their office is there. It is critical to have this same access as defence counsel. I have often used the library as my base during trials. I have the use of the fax machine and printing for when I need urgent access to items from my office, cases printed in the midst of unexpected argument or agreements drafted for matters that were not anticipated prior to trial.

1 response

Our library is THE hub at the Walkerton courthouse for counsel. We have no lawyers lounge. It is obviously a source of legal texts, but just as importantly it is a work space - regularly criminal and family lawyers are in the library before, between, and after court appearances to prepare, to review materials, to discuss cases with senior counsel. Without this HUGE resource, our clients would obviously suffer. Also, we have an absolutely fantastic law librarian, who is in my opinion underpaid for all the work that she does. It is her dedication that keeps our association and library going.

The Association Library provides a place for counsel, and the librarian to work together for the benefit of all parties impacted by the need for Court. Our law librarian provides us with a cost effective way to research so that we can keep costs minimized for clients and therefore help ensure that people get access to justice. The funding to law libraries and librarians, each and every jurisdiction will find it more time consuming and difficult to assist clients as required. They are without any doubt a very important part of the ability of lawyers to provide the services we provide.

1 response

I am a sole practitioner with a specialized practice in education, labour relations and education law. Frequently, I have to research areas which intersect with my specialty, but which are outside of it. I find the Law Library to be a superb resource at these times. In addition, the CCLA runs some of the best and least expensive CPD programming in Ontario. I find the LSO's library budget cuts at odds with their stated commitment to supporting the backbone of Ontario legal services (sole practitioners and small firms) set out in their 2005 Report on Sole Practitioners and Small Firms.

1 response

As a young practitioner in a rural area, I generally can't rely on my more "seasoned" colleagues for assistance with any matter that is novel, new, or otherwise outsides their cultural comfort zone. Having a law library gives me a lifeline to the wider legal community so I can better serve my clients. Law libraries, through the services they provide, allow smaller firms and sole practitioners to compete with the in-house resources and infrastructure larger firms have. Law libraries are essential for facilitating access to justice and fostering equity in the practice of law.

1 response

The law Library and staff are a very important resource. The law is constantly changing and to keep up to date with current legislation, regulations and case law it is useful to have dedicated resource staff. You cannot always keep up with every email or online source. The

information for recent Bills, regulations and case decisions is not always available. It is cost prohibitive to subscribe to every online search engine and each covers its own publications. Now with increasing isolation, it is more important than ever to have a law library available

1 response

The library was invaluable resource for research, resources, preparation for court, connecting members of the bar to important updates in the justice system at large, etc. Every single time I go to court, I spend time in the library. It was a refuge in the court day where you could find support in colleagues and other members of the bar as well as negotiate on matters. In addition, I would regularly attend the library for community legal events and CPDs. I continue to remain in constant contact with library staff to remain connected and updated.

1 response

It provides a link for CPD and offers invaluable research assistance and materials. It also offers computer terminals to draft minutes and perform Divorcemate calculations. Many a case are settled in our law library. Judges expect counsel to be able to access the law library to carry out research or draft minutes while a case has been set down to a latter time. There's often no time to run back to the office. More importantly, I could never have the range of legal research materials available to me if not provided by our Law Association.

1 response

I am a research lawyer. I write factums one after another. They seem to be increasing in importance, as more and more motions are in writing and require factums. Many of my firm's cases go on to the Court of Appeal level. I could not do my job adequately without the library's resources. I am a fairly frequent user of interlibrary loans as well, and communicate often with library staff. I have Westlaw at my fingertips at the office, yet I cannot get the full picture on the law in any given area without texts and resources in the library.

I don't often need to do formal legal research in my solicitor practice, but when I do I of course need reliable, up-to-date resources. The TLA Library means I have access to the resources I need, without having to pay for and store, well, a whole library. Although being in Toronto means I have access to the Great Library, it's been extremely helpful to have access to both collections (and both sets of legal librarians), and during COVID the TLA Library has been open more frequently for when there's no substitute for being on-site.

1 response

The Law Library is so much more than a library and the law librarian so much more than a librarian. The library provides a central resource centre, not just for books or legal research but also for consulting with the librarian or other lawyers, access to research in a pinch while in court, access to computers to draft/print orders or case law on the day of court, and a central location for lawyers to gather, to ask questions and share resources with one another. This is especially so in regions where sole practitioners are many.

1 response

Each lawyer with a Brant Law Association membership can obtain legal research from the librarian at no additional cost. Therefore, this really helps Legal Aid clients who have limited hours of legal services appointed to them, and financially helps the other clients as well. It is most important just before and during a trial when a lawyer is super busy and a new issue arises to which they are not familiar or need proof with caselaw. I direct all lawyers at this firm (5) to utilize the library to save client's time and money.

1 response

It keeps me more up to date with legislative changes and helps me provide a more educated service to my clients. It keeps me knowledgeable and provides access to resources at reasonable cost. Now however I do not wish to attend at any courthouse and only want online resources. FOLA

should consider only dealing with publishers who allow licensing and access(to members only) to online or electronic access. Any publisher who requires a lawyer to access information solely at a law library should no longer be dealt with.

1 response

Our Association Library is integral to my practice. We do not have the resources to maintain a comprehensive collection of written and electronic material, nor do we have much opportunity to connect with our colleagues at the local bar outside of the various events and courses offered by our Library staff. Our librarian is incredible and an invaluable resource to our small Association. Especially in smaller cities, the Association Library is fundamental to the provision of legal services and to access to justice.

1 response

Immediate availability to do individualized case research on points that arise before and during trials/motions. Immediate availability to assist with processing research requests. Direct contact for assistance, by virtue of 3 knowledgable and helpful staff. My Law Library is indispensable to my practice as a sole family law litigator. I don't have time for research and do not have a student or junior, yet need info in a timely manner and often urgently. My law library staff are fabulous in helping me.

1 response

The Association Library is essentially an extension of my office - I research, work, and meet at the library on a regular basis. I use the paper collection and can access other materials (like conference proceedings) that are not available online. My office can send me materials or documents by email to access through the computers and I can print material for court use in a pinch. I meet with colleagues and clients at the library. And sometimes, its just a nice place to work with a change of scenery.

The library is an integral part of our legal community. Pre-pandemic I attended all of my CPD programs at the library. As a sole practitioner this allowed me to interact with my colleagues during this programs. When in court the library is also an important resource as I would regularly use it to finalize and print settlement documents to be filed in court that day. Again, as a sole practitioner I cannot afford access to expensive research materials. The library provides me with this access.

1 response

Our Librarian keeps us up to date on all upcoming meetings and possible CPD programs. Further, she forwards correspondence from the Judiciary to the members of the law association to keep us up to date on new practices and procedures. In addition, the library has texts that I don't have personally, so I can access them whenever I need them. In addition, the library is where I go to get copies of "unreported" cases ( cases that are reported but not published), and difficult to find cases as well.

1 response

I work at a small firm, and most of my clients are assisted by legal aid. The library gives me access to resources I could not otherwise afford, which allows me to provide a higher quality of representation to my client. The library also serves to connect our legal community together for both professional and moral support. This creates a network of colleagues, which leads to access to CPD at reduced cost, and both emotional and professional support, which ultimately benefits our clients.

1 response

The pandemic has unfortunately drastically changed the practice of law... who needs libraries or court houses anymore ???...the decision makers are completely removing human beings from the practice of law....post pandemic practicing law means being chained to your desk 10 hours a

day staring at a computer screen.....I read recently that judges are conducting murder trials in front of their fireplaces wearing sweaters????...I mean REALLY ???.....this is so NOT what I signed up for !!

1 response

I am in court for several hours at a time, several days a week. Pre-pandemic, the law library served as a community hub where I could talk with lawyers, bounce ideas off them, negotiate with counsel, eat, relax, etc. I also used it to review old CPD, look at books on specific topics that I can't access online, or do legal research. I work for a small, social justice firm that does not have the funds for Lexis Nexus - the library allows me to do research necessary for my practice.

1 response

The library is invaluable to young lawyers. I could never afford the books I rely upon for legal research, advocacy training, and practice management. Beyond that, it is a hub for local lawyers to discuss access to justice issues, particularly for the criminal bar, but as I have observed it serves a similar purpose during civil and family trial sittings. It simply needs to be funded. Less books, less community, less organizing is a bad idea in any context, but especially in law.

1 response

1. Research during a case on unexpected points that arise, is essential to assist the client's case. Often the Librarian is an integral and quick part of that process. 2. Colleagues who have often had a similar issue congregate in the Law Library, and provide an additional resource. 3. Texts available in our Library often contain Summaries of issue subject matter, readily accessible to assist particular points, and especially if the need is urgent, in the case.

My local library as been critical in improving my competency, and therefore my ability to effectively advocate for my clients. Whenever I'm stuck on a legal issues, I can write to our local law librarian. She has consistently, and promptly, steered me in the right direction. Not only has she been extremely helpful, but my clients save on legal research fees. Our local library also permits lawyers to borrow texts, which has been invaluable to my professional development.

1 response

In my view, Law Association Libraries are particularly crucial for sole or small firm practitioners, particularly in smaller communities, who do not have access to the colleagues or resources that a large firm would provide. These sole or small firm practitioners are essential for access to justice and even in a post-pandemic world they will be crucial to ensuring that my colleagues have access to the resources that they need to provide legal services in our community.

1 response

The books and resources at the Association Library are invaluable. A number of the books are not available on-line and can no longer be purchased. I also use Quicklaw while at the library. Based on my limited usage of this service (about 30 hours a year), it would not make sense to subscribe to Quicklaw. This is an invaluable service for those of us who are sole practitioners or small law firms or who not litigation lawyers but still require these resources.

1 response

During this pandemic, our Library Association (DRLA) has been FUNDAMENTAL to being able to continue to practice Law. We have a GREAT Librarian and support staff (research) and they have in the past hosted great educational and social events. I've attended at Courthouses outside

of Durham Region that don't have a full time Librarian, and it was very difficult to access and navigate resources when the Court raised an unforeseen issue that s/he wanted to be clarified.

1 response

Our local law and our law librarian, Brianna, are absolutely critical to my ability to provide high quality service to my clients and maintain my competence. They are also vital to my ability and that of my colleagues to maintain connections between the members of the legal community. It is hard for me to imagine that there is any other surface provided by the Law Society of Ontario for my dues that is even close to equally as important to my professional life.

1 response

The librarian helping me with research, especially as a sole practitioner is helpful. A s well, access to software that I can't afford for my practice is available for use at the law libraries. They put on CPD programs, allow for networking with other lawyers so that you can build your network and get help. Lawyers cutting library funding; of all the nerds to cut funding to libraries, lawyers? Really? I'm embarrassed and disappointed. They should be also.

1 response

Local Librarian is able to efficiently locate relevant legal resources for uncommon issues and does so in a timely manner. Also Local Librarian assists lawyers use the technology and applications available on the computers in the library ie Divorcemate. It is unfortunate that we no longer have remote access to Quicklaw as many practicing lawyers do their research outside of 'working' hours and CanLii does not provide the same level of research assistance.

I can not properly operate as an effective lawyer without the necessary tools to do the job right. The Library and all the resources is an essential tool and without makes me a less effective lawyer working without the proper tools. It's like the a Carpenter being forced to work without a hammer or a mechanic without a wrench. Taking away out tools of the trade does not make logical sense although it may appear to make financial sense for LSUCK

1 response

It is the conduit through which lawyers communicate with other lawyers in our association - including searching for Wills, sending and receiving proxies for meetings, and informing the membership of important events in the life of the legal community (receptions, funerals, etc.), social events (mentoring dinners, lunch and learn events, golf tournaments), and continuing professional development opportunities (video replays of programs, for example)

1 response

I encourage unrepresented parties to visit library to obtain proper information and help to meaningfully participate in the proceeding. I also encourage my clients to go to the library to educate themselves to better understand the process. I also attend the library for info of recent changes in my area of law, or if I am in court, the library is fastest way to print documents or communicate with the office re: amending documents.

1 response

Jennie our librarian is a huge source of support if I have some research to do that is tricky or if i need a resource from another library. I think the library really assists in leveling the playing field between sole practitioners or small firms and the large firms. I also think that the library is a really nice place for us lawyers to have some social connection with our colleagues. I use the online services of divorce mate often.

1 response

if print is removed from the county spaces there will be no space for the other reasons lawyers use the library - a place to work, look up materials and print them, draft documents on short notice, meet with colleagues, socialize, earn CPD credit, learn from one another, assist junior lawyers in learning the law, a quiet place to gather your thoughts, have your lunch or a coffee or grab a granola bar because there isn't time for lunch.

1 response

The local library is essential to the practice of law. The librarians are trained to direct us practitioners to sources essential to keeping abreast of the law. In addition, the Law Library is a source of local legal history. Our Librarians knit together our local law association. Its existence promotes a sense of purpose to serve the community, provide legal services, encourages courteous exchanges amongst combatant litigators.

1 response

It is massively helpful to have Divorcemate and other software applications available on library computers and to print them off on library printers. It's absolutely critical. The law librarian is also useful for advising on extra resources on other topics. It's great to access a national newspaper in the lounge. Relating to lawyers in the lounge is the # 1 means to develop collegiality and support with one's peers.

1 response

The library is essential is providing resources as well as a librarian able to assist in research. the CPDs are great, along with the newsletter, webstie, twitter and facebook account to keep everyone updated and informed, the library is essential to all lawyers, espectially smaller firms and

sole practicio	oners and the public, who don't have their own resources or skills. without the library the legal community would be lost.

The library provides an invaluable resource for a sole practitioner in a small town. We are in a small community. Our library is essential to lawyer-to-lawyer engagement in court, for resources/information, for use of computers which assist us in drafting materials/accessing online resources/etc. Whenever I am in a courthouse, I access the library services (I practice primarily in Norfolk, but also in Woodstock, Brantford, Hamilton and Cayuga). It is essential to my practice (pre-Covid).

Our library is more than a library. It is a community. Without it, we would not have the connection to our association. It also is a library and is important for the research and work that I do. Solo and small firm lawyers cannot afford to equip themselves. We need our libraries. If the mandate of the LSO is to protect the public, closing association libraries or cutting their funding will do the opposite.

The library provides essential resources which are exceptionally important, particularly to those of us who are sole practitioners. I do no have the funds to purchase the latest reference texts, or maintain database subscriptions. My only access to these materials is through the library. Without the funding necessary to sustain these services through the library, my practice would be negatively impacted.

I could see the value of looseleafs available in the library as they are obnoxiously expensive and small firms/solos could never afford it. Our Law Association maintains the Barrister Lounge at the Family Courthouse site which means I have access to a computer with printing at a more affordable rate than the photocopier offered to the public that has a rate that is twice as high. The lounge also offers basic library reference books for family law and a place to speak with counsel and socialise while waiting for matters to be called.

Having the library available as a resource provides confidence required material will be available as and when needed. The librarian provides timely and reliable assistance with any search issue. The library atmosphere and resources provides great work environment. Meeting colleagues and discussing issues at the library improves our overall ability to serve clients and provide access to justice.
