# Licensing updates - examinations

- In April, letters were issued to individuals who may be involved in the cheating scenario, advising that they will be subject to investigation through the regulatory process.
- Summer in-person lawyer licensing examinations are available on select dates in five cities:
  - London, Ottawa, Thunder Bay, Toronto and Windsor
  - July 5 to 8 barrister examination
  - July 19 to 22 solicitor examination.
- Summer paralegal examination will be available in Toronto, July 25 to 27.



- Automatic tally of percentages to help ensure accuracy.




### **Innovate Forward**

# **Access to Innovation**



- Five-year pilot project, launched November 2021.
- A2I is accepting applications from legal innovators who wish to offer their products or services directly to Ontario consumers.
- A provider's approval to participate in the A2I project means that they can offer their legal product or services for a limited period of time, subject to operating and reporting requirements that safeguard effective and ethical standards.
- Facilitating access to justice by helping Ontarians understand, navigate and address legal issues through technology.

## Competence Task Force



- Call for Comment June 1 to November 20, 2021
- Ensure competence framework remains effective, proportionate and of assistance to lawyers and paralegals in maintaining their competence, while ensuring the public is protected.
- Next steps: Report and recommendations to be presented at May Convocation.

## Lawyer experiential training program enhancements

- In April, Convocation confirmed a policy of mandatory minimum compensation for articling and other experiential training positions.
- The board sought additional feedback from the profession, following a November 2021 report to Convocation recommending a best practice approach encouraging rather than requiring mandatory minimum compensation.
- Feedback was received from 141 individuals and 24 organizations.
- Target implementation May 2023.

The Law Society of Ontario's Board of Directors (Convocation) invites all those interested to email their views about mandatory minimum compensation for experiential training.




