- All refund requests must be received by no later than October 31, 2018. Please note that the \$40.00 Skate Canada fee and a \$50.00 administration charge will not be refunded. There will be NO refunds after this date.
- Returning skaters are NOT eligible for a refund.
- In the case of a skater withdrawing who has paid their registration fees with post-dated cheques, the following will apply; In order that there is a traceable paper trail, all post-dated cheques will be cashed on the appropriate date. Once all cheques have been cashed and have cleared the banking system (10 working days after deposit), a refund cheque will be issued by SSC.
- Registration funds must be paid in full by NO LATER than January 1, 2019.
