Dyers Moor Farm & Kennels - Declaration form

- 1. Whilst every care and precaution is taken during booking, responsibility can only be accepted at the owner's risk.
- 2. One person should leave and collect the dog(s). If you need to nominate another person to do either we ask that you inform us of the name and phone number of that person. ID in the form of a passport or driver's licence will be accepted. The dog(s) will not be released to them without prior consent from the owner and you will be liable for any extra boarding charges should this occur. This is for the safety and security of your dog(s).
- 3. Owners must have their dogs vaccinated against Distemper, Hepatitis, Leptospirosis, canine Parvovirus & ParaInfluenza. We also require your dogs to be vaccinated against Kennel Cough (Bordetella Bronchiseptica or canine parainfluenza virus).
- 4. All dogs must be fully vaccinated at least 2 weeks before staying with us. We take no responsibility for your dog(s) contracting any viral diseases whilst staying with us. Please bring your vaccination certificates with you when you check in your dog. It is your responsibility to ensure your dog/s vaccinations are up to date so please check this before confirming your booking as we cannot accommodate your dog if their boosters/ vaccinations have expired.
- 5. All dogs must have an effective flea and worm treatment at least 2 months prior to boarding. If either is found within the first few days of arrival, the relevant treatment will be sought from our vet and the cost added to your kennel bill accordingly.
- 6. Please advise us immediately if your female dog is in season or due to come into season. Although every effort will be made to confine dogs, we can accept no responsibility should your dog become pregnant. An additional cleaning charge may apply in case of bleeding/ urination in the kennel.
- 7. We are unable to accept bookings for a dog subject to the terms of the Dangerous Dogs Act 1991 or any other dogs with aggression problems.
- 8. Your dog MUST be wearing a collar with an ID tag and as a legal requirement be microchipped. Collars must be secure so they cannot slip loose. Choker chains are not accepted.
- 9. You will need to supply the necessary dog food and treats for the duration of the stay (unless otherwise agreed).
- 10.All beds, bedding and toys are left entirely at the owners risk. Dyers Moor will not be held responsible for lost or damaged items. We also reserve the right to dispose of any items should they become unreasonably soiled. Dogs which frequently need to have their bedding changed due to soiling or damage may incur an extra fee for the laundry or replacement cost.

- 11. Any relevant medication will be administered as instructed by owners; however, we are unable to accept any liability for incorrect administration or adverse reaction.
- 12.We reserve the right to always act in the best interests of the dog(s), this includes seeking veterinary advice if he/she becomes ill. We will contact you immediately should your dog become ill. If you cannot be contacted within a reasonable amount of time or have chosen not to be contacted we reserve the right to seek appropriate and swift veterinary attention and proceed with treatment regardless of costs, which you agree to cover. We will do everything needed for the dog as regards treatment, comfort and recovery. If euthanasia is absolutely necessary (determined by the vet) for whatever reason excluding behavioural (aggression etc) we will accept and act upon that vet advice. There will be a minimum charge of £45 added onto your remaining balance for each Veterinary visit made, this includes non emergency vet visits.
- 13. Any current or ongoing problems with a pet's health or temperament must be notified to us at the time of booking. We reserve the right to refuse any pet that we consider to be of an unreliable temperament, or sick at the start of boarding and costs will not be refunded.
- 14. Veterinary care consent By making a booking with us you consent to us being able to take your pet to our local vets, where it is required in an emergency or where we are concerned for your pets health. Our vets, should an emergency arise are Penbode Vets, Bradworthy, EX22 7SZ.
- 15.In the event of a dog(s) not being collected 14 days from the agreed collection date, we reserve the right to take any action deemed necessary regarding future ownership.
- 16.If there is evidence of external parasites, (fleas & ticks) then you consent to us administering this treatment via the vets and you accept the additional costs.
- 17.Please clearly mark any items with your dog's name and only bring items you are happy for the dog to be left unattended with.
- 18.I/We understand that Dyers Moor will monitor feeding habits whilst our dog/s are left in their care and consent to them increasing the quantity of food we have provided if they believe our dog shows sign of excessive hunger (breed and temperament dependant) from the amounts of physical and mental stimulation they are provided with. - 19.I/We consent for any toys or bedding provided by ourselves to be left unattended in the kennel with our dog/s: YES / NO
