## OPERATIONAL UPDATE FOR THE CEDAR COUNTY TRANSFER STATION

\*\* This update applies to rural residents only! Proof of residency required. \*\*

A temporary solution has been found for those rural residents that depend on refuse services from the Cedar County Transfer Station.

On Tuesdays and Thursdays, rural Cedar County residents may dispose of household waste between 8:00 a.m. and 12:00 p.m. (noon) on the grounds of the Cedar County Transfer Station. A container will be available during these hours on the northeast side of the property and residents can dispose of household waste. Rural residents that have recyclable items that would typically go to a recycling center can bring these items to the refuse container, however these items will be transferred to the landfill. All refuse MUST be in trash bags; no loose items will be accepted. Again, this service is only for those rural Cedar County residents residing outside of a city's boundary limits.

Please note that only household refuse will be accepted. Larger items, appliances, construction debris, shingles and other such items are not available for this service. This service will continue as needed during the COVID-19 public health emergency.

The Transfer Station will continue to accept waste from contractors with established accounts, commercial haulers and local municipalities.
