COURTHOUSE OPERATIONS UPDATE

After several weeks of limiting public access due to the COVID-19 pandemic, the Cedar County Courthouse will reopen to the public access on June 8, 2020.

The Courthouse will return to its regular access hours of 8:00am – 4:00pm, Monday through Friday, on that date. Prior to traveling to the Courthouse to conduct business, members of the public need to be aware of several operational and policy changes for all individuals entering the building.

- If you have experienced coronavirus symptoms of fever, shortness of breath, cough, chills, muscle pain, headache, sore throat or new loss of taste or smell within the past 10 days, please postpone your visit to the Courthouse.
- If you are mildly ill, or caring for someone who is ill, please postpone your visit to the Courthouse.
- If you have had contact with someone who has tested positive for COVID-19, or travelled outside of the United States within the past 14 days, please postpone your visit to the Courthouse.
- All individuals entering the Courthouse will be subject to a temperature screening with a no contact thermometer. If your temperature reading is 100.0° or higher, access to the Courthouse will be denied.
- Facemasks are not required to enter the Courthouse, but the use of such masks is encouraged for the protection of others.
- Social distancing practices must be maintained while visiting the Courthouse.
- It is requested that only one person per transaction enter the Courthouse. Any additional individuals (including children) are requested to remain outside while Courthouse business is transacted.
- All persons entering the Courthouse will be asked to provide their name and the office with which they will be conducting business.
- If you visit the Courthouse, and subsequently (within 10 days) test positive for COVID-19, you are asked to call Cedar County Public Health at 563-886-2226.
- Some services may not be available due to Federal or State limitations. To verify that a specific service is available, it is advised to call the particular office that you wish to visit prior to traveling to the Courthouse.

Meetings of the Cedar County Board of Supervisors will again be available for public attendance starting with the meeting at 8:30am on June 9th. Social distancing measures will be observed.

Driver's License services will be open 8:30am – 3:30pm, Monday through Thursday by appointment only. No drive tests will be available at this time. All other services at the Treasurer's Offices are available by appointment only. Appointments can be made by calling the Treasurer's office at 563-886-2557.

Please note that Courthouse capacity may be subject to a limited number of individuals to comply with all proclamation orders from Governor of Iowa. If this limitation is enacted, residents will be notified through postings on the Cedar County website (www.cedarcounty.org), the Cedar County COVID-19 newsletter (available at most post offices, gas stations and grocery stores within the County) and on the Cedar County COVID-19 Response website (www.cedarcountycovid19.org).

CEDAR COUNTY VETERANS AFFAIRS

When the Cedar County Courthouse reopens on June 8th, the Cedar County Veterans Affairs Office will open as well, but with some restrictions. Appointments will be required for all services and visitors are requested to wear masks due to the proximity of contact within the office. Those needing service from the Veterans Affairs office are encouraged to call 563-886-2170 for information or to make an appointment.

CEDAR COUNTY SHERIFF

The Cedar County Sheriff is pleased to announce that the lobby of the Law Center has been reopened to the public for certain transactions that have been temporarily suspended due to the COVID-19 emergency. Cedar County residents can transact normal operations via the lobby window. It is recommended that residents visiting the Law Center wear a face mask. Individuals with sentenced mittimus can begin serving their sentences; if these sentences need to be rescheduled, individuals are encouraged to contact their attorney. Please note, inmate visiting is still restricted at this time. For questions, please call 563-886-2121.

CEDAR COUNTY 911

Due to the COVID-19 emergency, contact restrictions were put in place at the 911/Emergency Management Office. During this time, 911 addresses were issued via phone. 911/EMA wishes to remind individuals who received a 911 address over the phone that they need to contact the 911/EMA office to obtain their 911 sign and post. REPORT ABUSE

Child Abuse – If you suspect a child under the age of 18 is being abused or neglected:

1. If you believe that the child is in imminent danger, CALL 911 immediately
2. Call the Abuse Hotline at 1-800-362-2178, available 24 hours a day, 7 days a week.
 - Be ready to provide identifying information and the whereabouts of the child
 - Unless you are a mandatory reporter, you may remain anonymous.

Dependent Abuse – Call the Abuse Hotline at 1-800-362-2178, 24 hours a day, 7 days a week.

EVICTON AND FORECLOSURE PREVENTION

PROGRAM - On May 29, Governor Kim Reynolds launched a new program that will provide short-term relief to income-eligible renters and homeowners who are at risk of eviction or foreclosure due to a documented COVID-19 related loss of income.
