Broadline Equipment LLC believes that trailer leasing should be easy and affordable. All of our trailers start at a flat rate of just \$825/month with NO MILEAGE FEES and NO APPLICATION FEES!

Easy 4 Step Leasing Process:

- Step 1: Fill out, sign, and return this Trailer Rental Application along with a readable copy of your drivers license, social security card, and copies of the summary pages of your last 3 bank statements.
- Step 2: Choose your specific trailer and pay the \$1500 refundable security deposit.
- Step 3: Submit a certificate of insurance showing that the trailer has been added to your insurance policy with Broadline Equipment LLC listed as additionally insured.
- Step 4: Sign the lease agreement, pay first month's rent, and pick up the trailer.

Frequently Asked Questions:

- Do I need to have good credit to get approved for a trailer lease?
 - o NO! We are less interested in your credit report and more interested in verifying that you are who you say you are.
- How long is the lease agreement?
 - o Our usual lease agreement is 6 months. Select trailers have Monthly and 90-Day lease options.
- What if I need to return the trailer before the 6 months is up?
 - o We offer 2 options: you can either pay the Lease-Buy-Out fee which is equal to 2 months rent, or you can pay rent for the remaining months of your lease agreement- whichever is less.
- What is the \$1500 deposit for?
 - o The security deposit is used to repair any damages that occur to the trailer while you are leasing it. If the trailer is returned in the same condition it was in when you took it, with no damages, the deposit will be returned to you.
- How do I pay rent each month when I am on the road?
 - o Rent is auto-deducted from your bank account each month so payments are easy.
- When is rent due?
 - o Your first month's rent will be pro-rated and due before you take the trailer. The following rent payments will be due on the 1st of each month. If an auto-deduct does not work, there will be a fee of \$250 and either payment is required to be sent immediately or the trailer returned to the yard.
- Who maintains and repairs the trailer during the lease agreement?
 - o You will be responsible for all repairs and maintenance during the lease agreement.
- Do you offer lease-to-own options?
 - o Yes! We start everyone out on a 6-month lease agreement. If all payments are made successfully during the initial 6 months, we then sign a lease-to-own agreement. After the term of the lease-to own contract is over, we simply sign the title over to you!
