Please Note:

Because **Kids in Aviation** classes include both ***“in classroom”*** and ***flight line or possibly in a hanger and around an aircraft***, we are requesting the parents or guardian to **complete the following two release of liability forms**. These same forms are also used for our Discovery Flights. The first form is for the parents acknowledgment of the risk involved in both being in and around an aircraft either on the ground or in flight. The second is the parental consent form.

Liability Release Waiver and Hold Harmless Agreement

In consideration for allowing me to participate in a Discovery Flight, flight training (both aerial training and ground training to include **Kids in Aviation** classes), or other flying activities (all or any one of these, the “activities”), I hereby represent and agree as follows:

I understand the inherent risks and dangers associated with flying and the possibility of serious physical or mental trauma or injury, disability or death, as well as property damage, and knowingly, freely and voluntarily agree to assume any dangers or risks associated with such activities and the social and economic losses that can result from participation in these activities. PILOTS AND PASSENGERS HAVE A DUTY TO EXERCISE GOOD JUDGMENT AND ACT IN A RESPONSIBLE MANNER WHILE USING THE AIRCRAFT, AND TO OBEY ALL ORAL AND WRITTEN WARNINGS, BOTH PRIOR TO AND DURING THE USE OF THE AIRCRAFT.

I, for myself and my heirs, assigns, personal representatives and next of kin, hereby agree to release, waive and discharge **KIDS IN AVIATION** including its owners, officers, agents, employees, contractors and volunteers (collectively, "**KIA**") SHALL NOT BE LIABLE FOR MY DEATH OR INJURY TO MY PERSON, OR FOR ANY LOSS FOR DAMAGE TO MY PROPERTY caused in any manner whatsoever, whether attributable to the negligence of **KIA**, or for any other reason, occurring during the time that I am in, entering or alighting from an aircraft piloted by or under the control of or owned by **KIA**, and I do hereby waive any right of action against **KIA** from any and all causes or claims that I may have against them from the beginning of time, from any and all claims, damages, injuries, losses or other liabilities that may be sustained by me, my heirs, executors, administrators, legal representatives, successors and assigns directly or indirectly in connection with, or arising out of, my participation in the activities, whether caused in whole or in part by the negligence of **KIA**, to the fullest extent permitted by law. I further agree not to sue on any such cause or claim. I further agree to indemnify and hold harmless **KIA** from any and all claims, damages, judgments, injuries, losses or other liabilities he or she may incur arising from my participation in the activities, including but not limited to attorneys fees, arising out any lawsuit related to the flight and/or enforcement of or legal challenge to this agreement even if arising in whole or in part from the negligence of **KIA**. It is my intention that this agreement be interpreted and enforced to the maximum extent allowed by Arizona law.

To the best of my knowledge, I am in good physical condition and believe myself fully medically able to participate in flight training activities. I am fully aware of the risks and hazards connected with the participation in general aviation activities, including physical injury or even death, and hereby elect to voluntarily participate in said training, knowing that the associated physical activity may be hazardous to me and my property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OR LOSS, PROPERTY DAMAGE, OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me, or loss or damage to property owned by me, as a result of participation in these activities.

It is my expressed intent that this release and hold harmless agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVE, DISCHARGE, and CONVENTION TO SUE the above named **KIA**. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be constructed in accordance with the laws of Arizona.

In signing this release, I acknowledge and represent that I HAVE READ THE FORGOING Waiver of Liability and Hold Harmless Agreement, UNDERSTAND IT AND SIGN IT VOLUNTARILY as my own free act and deed; no oral representations, statements or inducements, apart from the foregoing written agreements have been made; and I EXECUTE THIS RELEASE FOR FULL, ADEQUATE AND COMPLETE CONSIDERATION FULLY INTENDING TO BE BOUND BY SAME.

I have read this Waiver of Liability and Hold Harmless Agreement, fully understand its terms, understand that I have given up substantial rights by signing it and sign it freely and voluntarily and intend it to be a complete and unconditional release of any and all liability of **KIA** to the fullest extent permitted by law. I further agree that if any part of this agreement is held to be invalid, the rest notwithstanding shall continue in full legal force and effect.

I, for myself and my child/ward, as well as for my/our heirs, assigns, personal representatives and next of kin, hereby agree to release, waive and discharge **KIDS IN AVIATION**, including its owners, officers, agents, employees, contractors and volunteers (collectively, “**KIA**”) from any and all claims, damages, injuries, losses or other liabilities that may be sustained by my child/ward, my/our heirs, executors, administrators, legal representatives, successors and assigns directly or indirectly in connection with, or arising out of, my child/ward’s participation in the activities, whether caused in whole or in part by the negligence of **KIA**, to the fullest extent permitted by law. I, for myself and my child/ward, as well as for my/our heirs, assigns, personal representatives and next of kin, do hereby agree to indemnify and hold harmless **KIA** from any and all claims, damages, injuries, losses or other liabilities it may incur arising from my child/ward’s participation in the activities (including those arising from any legal challenge to this agreement), even if arising in whole or in part from the negligence of **KIA**.
