MANTUA TOWNSHIP TRUSTEES MEETING

Regular Meeting Minutes of July 10, 2025

John Festa called the meeting to order at 6:00 p.m. Roll Call: John Festa, Matthew Benner and Susan Lilley; Trustees, Julia Pemberton, Fiscal Officer and Assistant Michelle Stebbins. If you need copies of the minutes or other records, please contact the Fiscal Officer, Julia Pemberton. Others present. The pledge led by Matthew Benner.

The July 10, 2025, meeting covered several key points. The board approved the minutes from June 5, 20, and 27, 2025, with minor corrections. The 2026 budget was approved, totaling \$1.53 million. The road levy renewal was certified at \$193,437. The board discussed the Civic Center flood damage mitigation bid, with a pre-bid meeting scheduled for July 21 and bids due by August 13. The board also addressed the need for a special meeting to finalize the columbarium project before August 1. Additionally, the board discussed the impact of the road levy on property taxes and the ongoing issues with the Portage County Water Resources project.

Fiscal Officer presents the 2026 budget, totaling \$1.53 million, including salaries and special revenue accounts. Mentions the renewal road levy and the county's certification of the revenue. Discusses the need to certify the property tax revenue and the resolution passed on June 5 for the road levy renewal. Fiscal Officer Report- Expresses need for Resolution to place renewal road levy

on the ballot and the need to contact the Prosecutor's office again regarding language of the renewal and need for the procedure to get started as soon as possible.

Road Levy and OPWC Funding

Matt Benner asks about the process for renewing the road levy, and Julia explains the steps involved. John Festa expresses relief that they didn't have to raise taxes.

Susan Lilley mentions receiving positive feedback about the ditch maintenance on Mantua Center Road.

Civic Center Bid Process

John Festa reads the legal notice for the flood damage mitigation bid for the Civic Center.

The board discusses the bid process, including the pre-bid meeting and the timeline for receiving bids.

John Festa confirms the bid opening date and the criteria for awarding the contract. The Fiscal Officer suggests running two ads in Record Publications & Facebook to promote the bid.

The board discusses the need for insulation in the Civic Center and the impact of the flood damage. The Fiscal Officer expresses concerns about the town hall repairs and the need for a plan.

The board discusses the columbarium project, including the cost and the need for parts.

The Fiscal Officer raises concerns about the financial viability of the project. The board discusses the need for a special meeting to finalize the columbarium project before the August 1 deadline.

The board addresses issues with the Board of Elections regarding accessibility and compliance with ADA standards.

Trail and Roadway Issues

John Festa updates the board on the trail and roadway issues, including the resolution passed to deny permission for the trail. Matt Benner explains the legal and practical challenges of the trail project. The board discusses the impact of the trail on property values and the need for alternative routes.
